

**Notice of SHOW CAUSE HEARING and JUDICIAL FORECLOSURE HEARING
NON-PAYMENT OF PROPERTY TAXES**

On March 1, 2024 real estate with **unpaid 2022 and/or prior years property taxes** was forfeited to the Ingham County Treasurer pursuant to the General Property Tax Act, Public Act 206 of 1893, PA 206, MCL 211.1 to 211.157, as amended.

The Ingham County Treasurer is acting as the Foreclosing Governmental Unit in proceedings to foreclose on these properties for unpaid property taxes.

There are two hearings scheduled to finalize the foreclosure process. This publication is intended to provide additional notice to parties of interest in these parcels as to the nature, time, and location of these hearings.

SHOW CAUSE HEARING is scheduled for 9:00am-5:00pm Friday, February 7, 2025 at Ingham County Courthouse, 2nd Floor Treasurer's Office, 341 S. Jefferson, Mason, Michigan 48854.

A person with an interest in the property forfeited to the Ingham County Treasurer may appear at the show cause hearing and redeem that property or show cause why absolute title to that property should not vest in the Foreclosing Governmental Unit.

JUDICIAL FORECLOSURE HEARING is scheduled for 10:00 am Thursday, February 20, 2025 at the Ingham County 30th Circuit Court, Mason Courthouse, 341 S Jefferson St, 3rd Floor Mason, Michigan 48854.

At this hearing the Foreclosing Governmental Unit shall ask that the court enter a judgment foreclosing the property as requested in the petition for foreclosure. A person or entity claiming an interest in a parcel of property set forth in the petition for foreclosure, who desires to contest that petition, must file written objections with the clerk of the circuit court and serve those objections on the Ingham County Treasurer, the Foreclosing Governmental Unit. The Ingham County Circuit Court docket number is **24-440-CZ**.

If you are a person or entity with an interest in property being foreclosed:

- You have the right to redeem this parcel from the foreclosure process by payment of all forfeited unpaid taxes, interest, penalties, and fees prior to the expiration of the redemption period. You should contact the Ingham County Treasurer for the amount required to redeem.
- You may lose interest in the property as a result of the foreclosure process.
- The title to the property shall vest absolutely in the Foreclosing Governmental Unit unless all unpaid delinquent taxes, interest, penalties, and fees are paid by March 31, 2025 or in a contested case 21 days after the entry of a judgment foreclosing the property under MCL 211.78k
- All existing interests in oil and gas in the foreclosed property shall be extinguished except for: (1) the interests of a lessee or an assignee of an interest of a lessee under an oil or gas lease in effect as to the property or any part of the property if the lease is recorded in the office of the register of deeds in the county in which the property is located before the date of filing the petition for foreclosure under MCL 211.78h; or (2) interests preserved as provided in section 1(3) of 1963 PA 42, MCL 554.291.
- Any party who holds a **legal interest** in the property at the time of foreclosure has the right to **make a claim** for remaining proceeds, if any, which first requires completing and sending the Notice of Intention (State of Michigan form 5743) required by MCL 211.78t(2) to the Ingham County Treasurer **no later than July 1, immediately following foreclosure**. PLEASE TAKE NOTE:

The following list represents parties that appear to have title, liens, or other rights to the parcels being foreclosed by the Foreclosing Governmental Unit.

This notice is required to be given by law, even if the party no longer claims or desires an interest, if it appears they hold any undischarged, apparent, or potential title or lien right to the property.

Listing of a party does not necessarily indicate that they are the owner of a parcel, or that they are liable for the property taxes.

This list is NOT an offering of property for sale. These parcels are NOT being sold, auctioned, or otherwise available by virtue of this notice.

There is no procedure for purchasing these parcels from the Foreclosing Governmental Unit at this point in the foreclosure proceedings. Those parcels that are foreclosed and not redeemed may become available at public auction in 2025. These parcels remain the property of their current owner until redemption rights have expired. **No party should make any attempt to inspect or enter upon these parcels assuming them to be for sale.** This may constitute trespassing and subject the offender to criminal prosecution. The street address of the parcels listed is based on local records and is not guaranteed to be the actual location of the property.

The **amount due** listed indicates the balance which was due on December 2, 2024. The **current amount** required to redeem must be obtained from the Ingham County Treasurer, as additional penalties, fees, and interest have accrued since forfeiture. Calls may be directed to:

WHAT THIS MEANS

The legal language in this publication is required by law.

Property for which 2022 and prior property taxes, interest and fees are not paid may be foreclosed after March 31, 2025.

If this is your situation, you have options, but must act quickly.

- You may pay the 2022 and prior taxes in full on or before Monday, March 31, 2025.
- You may call this office at any time to discuss payment plans and other assistance.
- You may come to the Show Cause Hearing on February 7, 2025. However, we encourage you to call as soon as possible because time is working against you.
- You may ask the judge for an extension or exception on February 20, 2025. The judge may want to know what you did before then to work with us on a solution.

If you are listed in this publication it is because you have a recorded legal interest in a property and law requires that we list you here. If you do not care whether the property is foreclosed you do not need to take any action. You will not be required to make any payments and your credit will not be affected by this process. Please note, paying the taxes on a property does not gain you ownership! If you have a question about this please call.

If you have a payment plan in place through an agreement with the Treasurer's Office and are fulfilling the requirements of that agreement, this list does not affect your standing with the Treasurer's Office. We are required by law to list the property here. If you would like to verify the status of your payment plan please call.

If you are interested in acquiring property listed here, **read carefully the PLEASE TAKE NOTE** section on **page 2**. Only a small number of these properties will be foreclosed after March 31, 2025. Foreclosed properties may only be sold through public auctions which will be held in August and October 2025. Ingham County does not own properties listed in this publication and is not offering them for sale.

If you end up losing a property to foreclosure, you have the right to any excess proceeds that might result from the sale of your property at public auction. In order to protect that right you must file the 5743 Form ("Notice of Intention to Claim Interest in Foreclosure Sale Proceeds") with the Ingham County Treasurer's office no later than July 1, 2025. The form is available on our website, tr.ingham.org, under "Tax Forms & Information". If you have questions about this process please call.

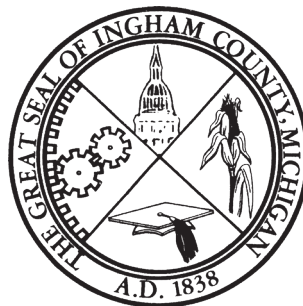
