Hillsboro Council Approves Summer Events

Hillsboro's City Council, with all members present for the Tuesday evening, March 10, meeting, gave permission to various groups to use city streets as the setting for a busy schedule of festivals and concerts planned for the summer

Zach Wygal represented Imagine Hillsboro as he requested permission to use the older city lake east of the beach for the group's sixth annual Cardboard Boat Regatta. He also spoke of plans to this year. Displays will begin near city

move two of the concerts planned for the hall, go north on Main Street and circle Summer Concert Series to downtown on June 13 and July 24; both are to be held on East Wood Street between Sullivan Drugs and the Opera House. Last, Tony Marcolini requested city help with plans to shuttle visitors to the Fourth of July activities at the lake.

Rod Stewart of the Old Settlers Association asked if the city would close Main Street for the group's annual car show and block party on Sunday, Aug. 2. The group expects 150-175 entries

Courthouse Square, and overflow onto East Seward. A band will perform on the Old Settler's stage when the car show is over.

Stewart also asked permission to plan for a smaller show for Saturday, May 16, from noon until 5 p.m. Co-sponsors of that event will be the Opera House Brewing Company; only the portion of Main Street between city hall and Wood Street will be closed that day. No dissenting votes were cast concerning those plans.

Hillsboro Board Prepares For Coffeen Transition

Continuing a discussion about transitioning Coffeen School to a pre-K center and sending all grade school students to Beckemeyer beginning next school year, the Hillsboro School Board talked about staff changes at the Hillsboro elementary school to handle the new students at their meeting on Tuesday, March 10.

The plan is to add one first grade and one fourth grade classroom at Beckemeyer to keep larger class sizes manageable, move from 20 aides at Beckemeyer to 25, and turn the two computer labs at Beckemeyer to special ed classrooms.

'We would also have a fulltime nurse since we will have all of our elementary kids in one building," Superintendent David Powell said, noting that currently the elementary nurse splits time between Beckemeyer and Coffeen. The same would be true of a music teacher, art teacher, and PE teacher, Beckemeyer Principal Zach Frailey added.

After a closed session at the end of the meeting, the board dismissed two teachers effective at the end of the school year, Rachel Garde and Brittany Clavin, and one teachers' aide, Tabatha Hamilton, due to reduction in force.

They also accepted letters of intent to retire from aides Maribeth Rahe and Patty Holshouser, and from cook Marcella Kimbro. They accepted a letter of resignation from teacher Adam Haston, approved volunteer fishing team coach Dennis Loskot, and tabled the re-employment of fall sports coaches.

The board accepted the low asbestos abatement bid of \$75,800 from Triple A of Pana, the lowest of six bids and below the estimated \$80,000 cost to replace floor tile at both Beckemeyer and Coffeen School.

At the recommendation of district maintenance supervisor Fred Butler, the board approved a price not to exceed \$37,443 for new motorized bleachers to replace those on the stage at the high school. Funds will come from the school facilities sales tax.

'The metal ones there now are getting pretty rickety,' board President Greg Bellaver said, "and there are no aisles-you have to walk up the bleachers.'

The board also took Butler's recommendation-based on research done by administrators Zach Frailey and Michelle Reeves-to purchase new playground equipment at Beckemeyer to replace current worn-out equipment. Some of that equipment can no longer be used, Butler said, because replacement parts are unavailable.

The projected lifespan for the new equipment, in answer to a question by board member Bryce Rupert, is 25 years. The cost is \$80,080 including \$25,000 for installation; the second number was especially difficult for board members to swallow. Those funds, too, will come from the school facilities sales tax.

"The last playground equipment," board member and former Beckemeyer Princinal Earl Meier pointed out "was paid for by the parentteacher organization.

County Prepares For Coronavirus

"When it comes to worry and panic, this is not the flu, but people should take the same precautions," said Montgomery County Health Department Administrator Hugh Satterlee in giving an update about the Coronavirus epidemic. "Be sure to wash your hands, don't rub your eves or scratch your nose. Basically, it's all the same things you do to prevent the flu."

Satterlee and ChristMont

EMA Director Greg Nimmo addressed members of the Montgomery County Board at their regular monthly meeting on Tuesday evening, March 10, at the Historic Courthouse in downtown Hillsboro. Board members Kirby Furness, Dave Loucks and Donna Yeske were absent.

Satterlee told the board there were 19 confirmed cases of the Coronavirus in Illinois, and all were in the Chicago area. He added that one case in St. Louis, MO had been confirmed from a passenger on a train from Chicago to St. Louis. He was working on trying to determine if the train made a stop in Carlinville.

Board member Jeremy Jones asked if the temperature outside affected the spread of the virus and if it would decrease when the weather warms up. Satterlee said there is no proof of that at this time. Jones also asked if those who contract the virus would be immune from it in the future, and Satterlee said he did not think so.

Issues Arise In Schram City Project

After meeting in closed session for nearly 20 minutes, members of the Schram City Village Board made a motion to approve summer workforce during their regular monthly meeting on Monday evening, March 9, at the village hall. Christian Hernandez and Griffin King, who have helped during the past two summer seasons, will be returning in

During last month's meet-

ing, board members learned that the village was not selected to the Community Development Block Grant to fund the water main replacement project. However, Village President Albert Oberle said they will re-submit the grant. At this month's meeting, he told the board there may be an additional grants to be applied for as part of the Rebuild Illinois program. If the IEPA loan is awarded, construction for the first phase is slated to begin Au-

gust 2021. The IEPA project manager that is reviewing the case encouraged the village to establish an emergency plan for water storage. Oberle has been working with the city of Hillsboro and wondered if joining rural water on each side of the village could be

A USDA grant in the amount of \$25,000 was awarded to the village to purchase a new truck.





Foresight Energy, the parent company of Deer Run Mine in Hillsboro, filed for bankruptcy on Tuesday, March 10, saying the global economic slowdown triggered by the coronavirus epidemic had pushed it over the edge.

The company said it plans to hand ownership to its creditors as part of a restructuring plan. That plan, which allows the company to stay in business, would cut debt by about \$1 billion by swapping \$1.4 billion of debt for equity, according to the Chapter 11 documents filed in US Bankruptcy Court in St. Louis.

The filing came just a few weeks after the company signaled that it plans to shut down Shay mine in Macoupin County.

IDHS Announces First Day To Complete Online Census

The Illinois Department of Human Services (IDHS) announced the first day to complete the 2020 Census online will be today, Thursday, March 12 on my2020census.gov.

The online questionnaire is the quickest and easiest way to get counted in Illinois and can be accessed from a smart phone, tablet, laptop, computer and terminals at local libraries. The census is nine questions long and will take less than ten minutes to complete.

"It is extremely important that everyone knows the implications of the census and gets counted in Illinois," said IDHS Secretary Grace B. Hou. "Completing the census online will ensure that Illinoisans get both the representation and federal funding for the critical services that they deserve."

An accurate count of the Illinois' population is essential to ensure the state receives the funding needed to properly care for its residents and provide critical services and programs.

In 2015, Illinois received \$19,738,866,367, or approximately \$1,535 per capita, in federal assistance for 16 programs. Failure to count every Illinois resident will have devastating effects on Illinois' ability to meet the needs of its residents. Even a 1 percent undercount would result in the loss of \$19,557,435 per year, for a decade, resulting in a total loss of \$195,574,350 for the state of Illinois.





Senior Achievers Meet K9 Officer, View Banners

Thirty-three Montgomery/ Macoupin County Senior Achievers met Tuesday, Feb. 4, at the Free Methodist Church in Hillsboro for breakfast and to hear from Litchfield Police Department K9 Officer, Sgt. Jack Spaur, and to meet his K-9, Wookie.

Sgt. Spaur is a 13-year law enforcement veteran and a third-generation police officer. Wookie is a three-year-old Dutch Shepherd who was bred in Illinois and graduated from K-9 academy at the tender age of ten months. He also has a family history of law enforcement, as his father is a K-9 serving on the Decatur police force and a sister and two brothers also serve as K-9 officers. Wookie, like most K-9s are bred from European stock, where there is a culture of working sport dogs like we have culture of race cars,

Sgt. Spaur advised that K-9s are trained to alert on only five drugs - marijuana, methamphetamine, cocaine, heroin and crack. They are also trained to track human

They track items the person fleeing may have discarded that are evidence Wookie is a passive alert dog on drugs and he also targets people who are fleeing. The K-9 is trained to apprehend a suspect by biting and holding until given the order, by the handler, to release. Sgt. Spaur shared that the use of a K-9 allows law enforcement to apprehend suspects with much less force and injury than other methods of apprehension.

A K-9 serves as a law enforcement animal for a defined period of time, each jurisdiction having different requirements. For example, K-9s serving in the Decatur Police Department are retired at the age of seven. The last Litchfield K-9 retired at the age of ten. When the dog retires, he usually goes to live with his handler. Legal requirements of the department where the dog served are followed and the dog is either given to or sold to the handler for \$1.

There are three law enforcement agencies in Montgomery County where K9s are serving- Litchfield Police Department, Hillsboro Police Department and the Montgomery County Sheriff's Department.

Randy Leetham assisted Sgt. Spaur in putting Wookie through his paces. After Chief Leetham donned a "bite sleeve" (protective training gear), Sgt. Spaur gave Wookie the command to attack. Wookie latched onto the bite sleeve on Chief Leetham's arm. Even with Sgt. Spaur picking the 70-pound dog up by his tail and pulling backward on him and with Chief Leetham using his free hand to twist Wookie's ear, the dog did not release his hold until Sgt. Spaur gave him the command to do so.

Nineteen Montgomery/ Macoupin County Senior Achievers gathered at Chinatown in Litchfield on Thursday, Jan. 20, for lunch, after which they adjourned to St. Timothy's Methodist Church to view Seasons of the Church Banners, a series of ten liturgical banners created by Achiever Nita Markos, local educator, artist and author.

She shared that several years ago, Tom Hott, a member of St. Timothy's, where Mrs. Markos also worships, asked her to create banners for the church sanctuary. Nita accepted the challenge and began by submitting designs to the church board for approval, which was given.

The designs of the banners are somewhat abstract so that they do not clash with the stained-glass windows in the sanctuary.

The Sunday the banners were dedicated at St. Timothy's, they were rolled to the top. As Mrs. Markos read the story of each banner, Mr. Hott slowly unrolled it until it was revealed in all its beauty.

The basis of the banners are old sheets, which are soft and take paint well. Using the primary colors of crimson, blue and yellow (from which any color may be made), she painted the sheets. Once painted, she began cutting out the individual pieces of the banners.

Using the collage technique, she mounted the pieces of each hanging on the backing cloth with spray-on basting glue. By using the basting glue, she could rearrange the pieces of the banner until they were exactly as she wished them to be.

The next step of the creation was to cover the design with fine tulle (think bridal veil fabric). After this was attached, Nita machine quilted each banner with parallel

Oberle has been working with the city of Hillsboro and wondered if joining rural water on each side of the village could be an option.

A USDA grant in the amount of \$25,000 was awarded to the village to purchase a new truck. Oberle said he will be seeking bids to review during next month's meeting. Trustees Pat Rhodes and Sam Whitlow inquired about purchasing a gasoline truck as opposed to a diesel and Oberle said he will gather bids on both.

The weather has been less than cooperative and many problems have risen as village employees replace the lift stations. The Saathoff and Boyd lift stations are completed and the lift station near the DMV will be completed soon. The village must replace the expired meter bases and Ameren required the control panel structures to be replaced and run underground power lines. According to the village president, the unforeseen circumstances resulted in a cost increase of \$38,535, bringing the total cost to \$550,802.

A motion to approve a \$165,870 payment for the work on the Saathoff and Boyd lift stations was made by Trustee Jerry Woods and seconded by Rhodes. A payment of \$111,730.50 was also approved to continue the work. Oberle said the village has opened special bank account to allocate project funds.

As part of their municipal aggregation bid review, members of the board approved a one-year contract with Homefield Energy at 4.054 kW, but with a grant the village uses, the rate is 4.04. Trustees also approved a three-year contract with Dynegy for street lighting and a one-year contract with

Constellation to power pumping stations and the village hall at .041. Oberle said he's hopeful the new pumps will use less energy, thus saving more money.

Village Attorney Alicia Granito reported that Officer Gary Satterlee has issued citations that were scheduled for court Wednesday, March

Rhodes asked if they've received a quote from John Masten of Masten Mosquito Control, who introduced himself and his business to the board in January. Oberle said they have not, but he will follow up with both Masten and the city of Hillsboro.

The village president said residents should expect their Census 2020 around March 12 to March 20 and encourages everyone to fill it out.

Trustee Sam Whitlow addressed some concerns over traffic speeding and running stop signs and Trustee Kevin Tuetken suggested installing more "Children At Play" signs. Oberle will order more to place throughout the village.

In streets and alleyway news, Tuetken said there is a pot hole on 18th and Klar that needs attention, as well as the roadway that runs beside Dollar General, which needs asphalt. In building and zoning, Oberle said he has received a few applications for a new apartment complex and storage units. Additionally, Jansen Cable Construction, Inc. will be running fiber optic cables for New Wave.

Upon checking the mine site, Trustee Earl Eller said there was an abundance of trash that was dumped on the property and suggested getting signs to let the com-

munity know what is allowed. Next month's meeting will be held Monday, April 13, at 6 p.m. A fall festival meeting will follow.

In asking how long patients are carriers of the virus, Satterlee told Jones and the board that he's heard there is a 14-day window, noting that it could be longer. Jones also asked how long it could live outside the body, and Satterlee said that is unknown, but it could be as long as 70 hours.

"It's something we're just learning more about every day," Satterlee said.

Board member Dennis McCammack asked if there were charges to be tested, and Satterlee said there were not through the state lab, but that testing had to be requested by a medical doctor, and they would likely run other tests first. Satterlee said the state has three labs where testing can be done, but he has heard rumors that some private labs were also looking into testing for the virus.

Nimmo said from an emergency management perspective, his office plays the role of coordinator.

"We do have an emergency plan in place for medical related issues, and we are following it," he said.

Nimmo told the board the governor has declared a state of emergency in reference to the Coronavirus, but encouraged residents not to panic.

"It just opens up available resources at the federal and state level," Nimmo said.

He continues to work with county schools, hospitals and long-term care facilities on making preparations. Nimmo also encouraged residents to get their information about the Coronavirus from reputable sources, like the Illinois Department of Public Health and the Center for Disease Control.

"Facebook is not a reputable source," he told the board. Other Business

During the middle of the meeting, the board would spend an hour and 42 minutes in closed session on two matters. They discussed a request from Foresight Energy asking for a reduction in coal royalty payments to the county, as well as a request to sell or lease the county's recycling equipment to DC Waste and Recycling in Hillsboro.

After closed session, the board tabled all further action in regards to the request from Foresight Energy as the board seeks additional information.

During the public comment portion of the meeting, Bill Schroeder told the board Foresight Energy had declared bankruptcy that day, and asked if the board could consider adding a clause in the contract encouraging the company to pay local vendors first. County Board Chairman Evan Young said the state's attorney said they could not do that.

The board also unanimously passed a motion to present a counter-offer to DC Waste and Recycling to lease the county's equipment.

Consent Agenda

Board member Bill Bergen led the Pledge of Allegiance, followed by the unanimous approval of minutes from the last meeting and mileage and per diem requests.

During the consent agenda, Montgomery County Clerk Holly Lemons gave an update to the board on the Criminal Traffic Assessment Act, which provided credit for time served and fee waivers for low income offenders. She that the first reports were due in February, adding that from July through December, the county lost \$179,841.40 to the program. She said information for all counties was available on the Illinois Supreme Court website.

Adding to that discussion,

Sheriff Rick Robbins encouraged board members to keep an eye on legislation pending in the Illinois House and the Senate to go to a no cash bond program.

"It's primarily driven up north," Robbins said. "But it's a complete failure of the state of Illinois. There is not one conversation about the victims. It's all about poor defendants. The justice system can't pay for itself now, and it's only going to get worse."

Lemons said the state legislature is also looking at a similar waiver for traffic tickets, which is one of the places remaining that the county does see revenue. Board member Chuck Graden asked how someone would qualify for a traffic ticket waiver, and Lemons said they have to fall within a certain amount of the poverty guidelines.

Montgomery County State's Attorney Butch Hitchings added to the discussion that Montgomery County doesn't have the big civil docket like other counties do, which help pay for their court systems.

Lemons said it's driven by the platform of the state's lieutenant governor to reform the criminal justice system. She said she will soon be attending meetings in Springfield to look at how to continue to fund the courts system.

"It's just a completely different way of looking at our criminal justice system," Hitchings said.

Liaison Reports

In CEFS news, board member Tim Fogle said they are looking at new ways to promote their programs, like Meals on Wheels, LiHeap and PIP, to encourage further usage.

In Senior Citizens news, board member Ron Deabenderfer said they have bids out for a new floor at the senior center in Taylor Springs.

In West Central Development Council news, board member Richard Wendel reported that Jeremy Jones had been elected secretary of the organization. He added that the group is helping 80 workers displaced from the Coffeen Power Plant with training and job placement. Jones said the group is also working on promoting its youth work programs.

Coordinating

In addition to the report on the Coronavirus, board members heard from Nathan Nichols of Central Illinos Public Transit. Nichols is the mobility manager for the program, which covers seven counties. He said that last year, they had 566 unduplicated riders in Montgomery County with 20,352 trips.

Nichols added the program offers all types of transportation, serving in-county needs first and filling out-of-county needs (such as doctor's appointments in Springfield) as they are available. They also offer some trips for seniors.

"We appreciate your constant support of this program," Nichols told the board. "Without you, we would not be able to operate like we do."

Following his presentation, the board unanimously approved both the intergovernmental agreement and resolution to continue supporting the program in the county.

In information systems updates, Young said the department had 95 work tickets in January, and that they got the email set up for the 708 Board members.

Montgomery County Clerk and Recorder Sandy Leitheiser gave an update on the census. She said that today (March 12) is the first day residents can fill out the information online and that they should be receiving an invitation in the mail that same day.

"Things have been very busy as the census is really close at hand," Leitheiser told the board. "Apathy is our enemy, and we want to overcome apathy. Let's give it all we've got."

She said the online process is very simple to fill out, offering that her office would be able to assist local residents. The Montgomery County Farm Bureau is also offering assistance for its members.

In a few final updates, Young reminded the board the next mayors' meeting was held on March 11, where they discussed the animal control ordinance, and that the Montgomery County Water Company sold to EJ Water Company in Dieterich.

Road and Bridge

Board members unanimously approved the low bid for MFT oil letting for the county, which was Louis Marsch for \$155,082. They also unanimously approved the low bids for the township MFT oil letting bids.

The board would also unanimously approve pipe culvert letting bids from Metal Culverts in the amount of \$1,653.12 for galvanized culverts, \$1,755.28 for aluminized culverts and \$2,001.06 for poly coated culverts.

With two no votes, the board approved a petition from the city of Hillsboro for a bridge replacement on Seward Street. Engineer Cody Greenwood said this was just the first step in the project, offering that the county would split the project with the city. Voting no were Chuck Graden and Glenn Savage.

In an update to the proposed Walshville Road bypass, Road and Bridge Committee Chairman Gene Miles said the Walshville trustees are not in favor of the county's proposal because they cannot secure right of way from farmers in the area. They want the county to consider two other options, and Miles said they continue to discuss the project.

He added that the committee is also still discussing repayment to the county for the purchase of the Wright Automotive property by the highway department.

Finance

In addition to the discussion of the Foresight Energy contact, board members were presented with the annual audit for the circuit clerk's office. They will review it for 30 days and approve it at the next meeting.

Finance Committee Chairman Megan Beeler said that Supervisor of Assessors Ray Durston was working on setting up a meeting with Vistra on the power plant property. Initially, they were awaiting some legislation, but feel they need to move forward.

Beeler said the capital improvement fund showed a few small deposits, noting that Treasurer Nikki Lohman is doing a good job marking what the deposits are for. She added that they will start seeing additional coal royalty funding soon.

Beeler said there were no

new IMRF updates, but said the county would be keeping a close eye on the pensions.

She said that she and Fogle were working on budget control policies, looking at what other counties have in place.

"A lot of it is in place already, and we are going to build on that," she said.

The committee discussed an engagement letter from KEB, who completes the county's audit, and said they are looking at auditing from previous years.

Beeler said they would also be bidding out professional services, like auditing and insurance this year, per their policy to do so every five years.

The board unanimously approved an intergovernmental agreement between the 911 Board and the Montgomery County Sheriff's Office to keep 911 services in Montgomery County.

They would also unanimously vote to convey a deed in East Fork Township to Patricia A. Ryan Russo.

In a final note, Beeler said they are working with Joe Meyer and Associates on an issue with a deed conveyance in Taylor Springs. She said the county is taking care of its portion and Taylor Springs is taking care of its part.

HWE the

In addition to the discussion about the sale or lease of recycling equipment, HWE Chairman Chuck Graden thanked board member Mark Hughes for bringing it to the committee's attention to reimburse County Coordinator Chris Daniels for her time filling in for the recycling program when Mike Hand resigned.

In elections news, Leitheiser reported that the county has received 213 votes by mail and 473 early voters.

She said the primary election will be held on Tuesday, March 17, and encouraged everyone to vote.

In EPA news, Graden said they hosted a retirement party for Phil Gonet, who retired at the end of February. Buildings and Grounds

Building and Grounds Chairman Bob Sneed reported they would be fixing the north steps on the Historic Courthouse when the weather warms up, closing that entrance for about a week.

He also reported the boiler had been inspected and passed, and that they were planting some trees in front of the new courthouse and replacing some dead ones.

Sneed said they filed two insurance claims on the roof of the Annex building, but felt they were not going to get enough to pay for the repair work.

He said they are still working with the city of Hillsboro on getting an estimate to fix the sidewalks around the Historic Courthouse. They are also seeking more information about a proposal from Imagine Hillsboro for a mural on the north wall of the Annex building.

In a few final notes, Sneed said they signed a contract with Hillsboro Electric to replace lighting on the outside of the new courthouse building. They are also seeking bids for maintenance on three of the county's generators.

Economic Development Economic Development

Vice Chairman Ron Deabenderfer reminded the board that tourism requests for funding from the hotel/motel tax are due by March 27. Applications are available on the Montgomery County Economic Development Corporation's website. They will be reviewed on April 6.

Deabenderfer said the county is still working with the University of Illinois Extension on a CEDS document, which will help the county apply for infrastructure grants.

He said the Planning Commission met Wednesday, March 11. They were discussing revising the wind ordinance to comply with state regulations. When finished, it would be presented to the full board. He also encouraged residents to be vigilant when signing a lease with a wind farm developer and make sure to seek proper legal advice.

Deabenderfer also reported that the Bicentennial committee held its first meeting on March 5, and is planning events for the coming year to kick off on Feb. 12, 2021.

EMA Shairma

EMA Chairman Bill Bergen reported they boxed up reports for the Litchfield Ambulance, and he expects they will be picked up soon.

Bergen added that they have received all the ambulance contracts, except Raymond, and they hope to have it in house soon.

In a 911 update, Bergen said the board is looking over the sheriff's office to update the equipment. They have been in contact with Motorola, and they are on the list to be upgraded when available.

Personnel

Personnel Committee Vice Chairman Sandy Johnson said they had a visit from Tony Johnston and Amanda Mast about employee health insurance. They reported that MetLife does not issue identification cards for vision and dental insurance.

To date, the county has used \$11,406 of its HRA this year, which is comparable to last year.

Johnson said they also continue to work on the revised drug policy, addressing cannabis use. The committee is awaiting possible changes from the state in the veto session.

Board members unanimously approved updated sexual harassment policy and training recommended by IT Manager Curt Watkins. Leitheiser said that all employees and elected officials are required to go through the training every year.

After paying the bills, board members voted to adjourn at 8:35 p.m. They will meet again on Tuesday, April 14, beginning at 5:30 p.m. at the Historic Courthouse in downtown Hillsboro.

The board also approved transportation director Adam Gregg's recommendation to purchase two new gasoline Bluebird 77-passenger busses for \$97,206 each, and two new gasoline Bluebird 83-passenger busses for \$99,505 each from Central State Bus Sales of Fenton, MO. The cost includes six trade-ins, reducing the Hillsboro School District fleet from 34 to 32 busses.

The purchase cost will come from the Transportation Fund.

"We've had really good luck with our gasoline Bluebird busses," Gregg said of his recommendation of gasoline units in favor of diesels. He estimates saving \$18,000 over the life of a gasoline bus compared to a diesel considering the cost of fuel, electricity and maintenance.

During the meeting, the board conducted a public hearing to sell \$2.5 million in working cash bonds. As in recent years, the board has used working cash funds to shore up deficits in other funds, primarily the Education Fund. There were no comments during the brief hearing.

At the recommendation of curriculum director Hope McBrain, the board added a "do-it-yourself 2" dual credit course at Hillsboro High School, following up on the new course offered this year and taught by Tony Marcolini. If Lincoln Land Community College does not approve the course for college credit, it

will still be offered at the high school.

The board also approved McBrain's recommendation of a "music in America" dual credit high school course for students not necessarily in choir or band. Choir teacher Amy Lemons has already been approved to teach the class for Lincoln Land college credit, and the only cost would be an LLCC-required text book.

McBrain, Coffeen Principal Marci Gutierrez, school psychologist Amanda Cunningham and her intern Lucas Altenberger spent several minutes pitching the idea of "social emotional learning" in the school district to impact academic success, social behavior, and emotional distress.

"We'll be asking for your approval next month," Powell told board members.

Cunningham said data for the need for the program comes from an SIU School of Medicine research project in partnership with Hillsboro Area Hospital, and a screening survey for students grades three though 12. Those surveys showed that more than a fourth of the students in each school need social emotional support.

Some programs have already been begun in each school, including two speakers this school year.

Their solution? A new "choose love" curriculum developed in response to the Sandy Hook Elementary School shooting in Connecticut in 2012. McBrain said it's

used in all 50 states, "and the best part is that it's free."

Gutierrez said the curriculum is for students of all levels-pre-K through grade 12.

The curriculum focuses on courage, gratitude, forgiveness and compassion, and includes lessons on character education, positive psychology, mindfulness, neuroscience and emotional intelligence. To learn more, parents may visit jesselewischooselove.org.

To help accommodate the new consortium with Litchfield, Nokomis, and Panhandle, the board agreed to a common school calendar with those districts that starts school on Aug. 17 for students next fall. For teachers, work begins on Thursday, Aug. 13.

Christmas vacation begins on Dec. 18, and classes resume for students on Jan. 5. If all five pre-planned weather days are used, the last day of school next year will be May 28.

To begin the meeting, two members of the Hillsboro Junior High School Student Council presented board members with note pads and pens "to acknowledge the hard work and dedication of school board members."

Gutierrez told board members that a grant will fund a field trip for pre-K students, and that the process of transitioning Coffeen School to a pre-K center next school year is "off to a good start."

The board renewed its annual membership in the Illinois High School Association for 2020-21; as usual, membership dues are waived.

The bills Finance Commissioner Katie Duncan presented for payment totaled \$317,049.50. She characterized the amount as "...better than prior months, but still too high." That opinion was an echo of earlier comments she'd made about a potential purchase.

The other action item on Tuesday's agenda dealt with a proposal from Hurst-Rosche Engineers who asked for \$12,100 to do the preliminary engineering work needed before planned water main replacement work. Phase I is a property and topographic survey; Phase II is for design; and Phase III is for overseeing the bidding process. The proposal totalled \$12,100; it was accepted by the council.

During the departmental reports, Utility Commissioner Don Downs mentioned rental of a pothole machine (an industrial-size power washer designed to blast dirt from above buried mains so the mains can be repaired without digging, which might damage the mains even more) for recent use. The rental made locating water mains quicker when planning for potential Summer and Rountree intersection work. Downs hinted that it would be nice if the city owned a modern machine like that; Duncan pointedly asked if he hadn't been listening to her comments about holding the line on expenses.

Downs, Mayor Brian Sullivan, and Woodard & Curran representative Tim Ferguson explained the letter sent to Hillsboro water customers didn't mean an emergency exists. Current water tests show that no problem exists at the moment, but the average presence of the offending element was still above the norm. Ferguson said that based on past experiences, he expected the average would be fine after another cycle of testing.

Public Safety Commissioner Michael Murphy reported a shed on Mechanic Street had been taken down after complaints of youth congregating in the shed had been lodged. Two dilapidated sheds on Virginia Street were hauled away as well, and evidence exists of a clean-up of an old garage/shed on East Hillsboro is apparent.

What had been a troublesome property on Chase Street by the junior high has been rehabbed and is now a credit to the community, according to Murphy, but he mentioned other eyesores in town, especially any structure with a tarp roof. He said some residents will receive friendly reminders concerning ordinance violations in the mail

Ignoring the two-hour limit to parking downtown is also an irritant; Murphy says that won't be tolerated, even by apartment dwellers. Mayor Sullivan pointed out that parking lots off Main Street can be used by those who need a spot for more than two hours.

Public Properties Commissioner Daniel Robbins said the dock for non-motorized watercraft (kayaks and canoes) is finished, and the spot for its installation is almost ready. Repairs are in progress at the campgrounds, where water will be turned on this week. Rock has been spread in low spots of the dog park parking area, and the city was represented by Jim May and Kendra Wright at a playgrounds conference.

The Street Department picked up brush and a dead deer near the police's shooting range (the location was a coincidence) and worked in filling potholes around town.

They also repaired water mains on Fairground, Kinkead, and North Welch.

The mayor said legal trouble might be in the future. A citizen complained on Monday that a vicious dog not on a leash attacked the citizen's dog in his/her yard. When the animal control center was called, no one responded. A dispute had arisen recently between the city and the county after a contract for services between the two expired and the city chose not to sign a contract offer with higher costs to the city.

The county's position

seems to be no contract, no service. The city's position is that animal control is the county's responsibility. Both feel the state statute supports its own position, and Mayor Sullivan thinks the matter may go to court for resolution.

Community Planner Jonathan Weyer attended a two-day grant writing seminar. He also said Aly Grady, who works for the state's economic development office, will be here next Wednesday, March 18, to tour and discuss the Eagle Zinc property. Also the Coop will have a major announcement to make on the 18th at the Opera House at 7 p.m.

City office personnel are ready to help residents file their census report online beginning Monday, March 23, between 8 a.m. and 4 p.m. Monday through Friday.

City Engineer Scott Hunt said the Central Park bridges application is ready to be forwarded to the Illinois Department of Natural Resources, and the paperwork for Motor Fuel Tax revenue work is in the hands of the Illinois Department of Transportation (IDOT).

The Illinois Environmental Protection Agency (IEPA) wants an easement to the Coal Tar Oil Site; the city hopes to package that request with others. The state has verbally approved a five year plan for spillway improvement at the old lake, and Hurst-Rosche has begun field work on the Helston Place sewer project.

The Rountree/Summer Street intersection project is out for bids, and exploratory work there by the Street Department found some water lines there are only two feet deep. Hunt said that may create an extra cost for the contractors and the engineers to mitigate.

2019-20 A Rebirth For Lincolnwood Girls Basketball

They say that you have to crawl before you can walk, and learn to walk before you can run. This season, the Lincolnwood girls basketball team learned just how hard crawling can be.

After 34 years without a basketball program to call their own, the Lady Lancers experienced a rebirth with their first varsity team since the 1984-85 season. Like all new beginnings, this one had it's share of growing pains, but ultimately, if Lincolnwood can build on this year's lessons, future Lady Lancers will be the better for it in the end.

Lincolnwood started the season with 13 players and were long on athleticism, with most of the roster fresh off a successful 28-8-1 volleyball campaign, but short on basketball experience. None of the 13 had played basketball at the high school

The absence of experience resulted in some tough times for the Lancers, who were outscored 312 to 1,100 this season in 21 games, all of which ended with Lincolnwood on the short end of the scoreboard. Their closest games were against Bunker Hill on Jan. 30, a 40-25 loss, and a 39-21 affair on Nov. 25, against Brussels in the Lady Lancers' first game in orange and black since March 11, 1985.

Not long after that game, a 54-48 loss to Hillsboro in the first round of the regional tournament in Raymond, the decision was made to cut the program, wnich went 2-13 that season according to a story in the *Montgomery* County News. Research trying to find why the program was cut has proved inconclusive,

level through Lincolnwood's but the decision was disappointing to many.

Cindy (Stewart) Roecker, was a key part of that 1985 team and was one of the ones heartbroken by the decision. "Parents and players went

to the school board meetings to try to save the program, but we weren't able to," remembers Roecker, who was a sophomore during the 1984-85 season. "There were a few people that were trying to encourage me to try out for the boys' team, but even that would have created challenges. There was no co-op or playing with other teams like with what we have seen evolve over the years at Lincolnwood. The options were just very limited, so I didn't play basketball after that, except in intramurals and pick-up games throughout college."

While she wasn't able to play her final two years of high school, the game has continued to be a part of her

life. Roecker, who scored a program record 38 points in Lincolnwood's final loss to Hillsboro, has coached her daughter Finley's basketball team at All Saints Catholic School near Tulsa for the last eight years.

"I started coaching her team back when she was in first grade and I've stuck with them," said Roecker. "The school only goes up to eighth grade so this will be my last year coaching, unless I drop down and coach my third grade daughter's team."

While her daughter's team has had it's fair share of success, including a state title in the Diocesan Middle School Athletic Association last year as seventh graders, Roecker can't help but think about what might have been if she would have been able to play all four years at Lincolnwood.



Lancers Turn Off Court Losses Into Wins

After experiencing a 23 loss season in 2018-19, the Lincolnwood-Morrisonville boys basketball team had to deal with a different type of loss this past season, one that weighed much heavier than just coming up on the short end of the scoreboard.

The Lancer family experienced the loss of a teammate, Austin Krager, a senior on last year's team; a friend and broadcaster, WSMI legend Terry Todt; and a parent, Kim Hopper, the mother of Lincoln-

wood senior Evan Hopper and wife to Superintendent Aaron Hopper. Somehow, through all of that loss, the Lancers were able to become stronger, both on the court and off it as they experienced one of their most successful seasons in several

years. Led by a tight knit group of seniors, Lincolnwood would rally back from a 1-4 start to rack up a 21-win season, their first over 20 wins since 2016. They would also make it to their first regional championship game since 2016, eventually falling to an extremely

talented Calhoun squad on

the Lancers' home floor. The turning point for the team came in the new year, where Lincolnwood rattled off seven straight wins. The Lancers were 6-7 at the time, but never fell below .500 after that and were 15-5 in their final 20 games. The seven win stretch included a victory over Nokomis on the Redskins' home floor, just their third in the Coach Kimbro era. Nokomis would avenge that loss in the championship game of the Morrisonville Mohawk Classic, but by just one point

in one of the Lancers' most exciting games of the season.

While one of their best wins of the season came on the road, the Lancers were at their best at the Woodshed in Raymond. In their 14 games on their home court, Lincolnwood won 13, with their only loss coming to Calhoun in the title game. Away from home, Lincolnwood averaged 44 points per game and gave up 43.6 per contest. At home? They averaged 48.1 points per game and held opponents to a paltry 38.4 points per contest.

of the Lancers' most successful on the defensive end under Coach Matt Millburg. The 41.4 points per game they gave up was the fewest in Millburg's eight years at the helm and the least since The Journal-News began tracking that stat after the 2007-2008 season. While their offensive numbers were down slightly from the 2017-18 and 2016-17 seasons, this year's average of 45.7 points per game was a three point increase over last year's squad.

The improvement overall of the team was a case that the whole was greater than the sum of the parts as Lancers formed a cohesive unit, particularly in the second half of

the season. Shawn Goebel, one of five seniors on this year's roster, started off slow, but came on strong in the end, finishing the season with 394 points, an average of 11.9 points per game. Goebel also led the team in assists (86), steals (56),

rebounds with 4.3 per contest. A unanimous all-conference pick by the coaches of the MSM Conference, Goebel was solid from everywhere on the floor, shooting 48.1 percent inside the arc, 34.2 percent outside of it and 64.7 from the free-

He would be joined on the all-conference squad by fellow senior Sam Herman, who was a second team selection after averaging 10.1 points and a team-best 5.1 rebounds per game. While he didn't play basketball last season, Herman didn't miss a beat, shooting 47 percent from inside the arc and contributing 38 steals and 19 blocks on the defensive end.

Evan Hopper, the third of three senior starters, was saddled with some of the toughest defensive assignments throughout the year, including 6'8" Carter Sabol in the Nokomis game. While the 5'11" Hopper had his hands full against some of these giants, his aggressiveness and hustle made up for any height difference. Offensively, he finand was one of Lincolnwood's top free throw shooters at 68

Dalton Thomas and Tucker Lemon would come off the bench in their senior season, both scoring their final points as Lancers. Thomas was a motivational force for the Lancers through his attitude and energy, while Lemon was also there for his teammates every step of the way, despite an injury that kept him from

Replacing the seniors will be up to the rest of this year's squad, comprised of four juniors, three sophomores and a freshman. Junior Cole Sidwell averaged 4.8 points and 3.0 rebounds per game and was a weapon from outside the arc with 32 threes. Jhadyn Walker added in 3.6 points per game and contributed in the post, despite being undersized for

Devin Brown showed flashes of brilliance in his junior season, averaging 1.5 points per game, but making 20 of the 34 shots he took inside the arc, a 58.8 percent shootBraxton Schmedeke, who averaged 2.4 points and shot 34 percent from behind the

Sophomore Will Jenkins was the team's best threepoint shooter statistically, hitting 50-of-142 threes for a shooting percentage of 35.2. His 6.6 points per game were third best on the team and could increase substantially next season. Fellow sophomore's Levi Weir and Colton Tischkau saw action in seven games each, a number that should increase next year. Braden Whalen saw limited minutes as a freshman but has the ability to turn any possession into points. If he can continue to develop, he could be a difference maker in 2020-21.

Time on the court will be just one factor of the Lancers' growth next year though. The team has seen some of the worst that life can throw at them and has come out stronger on the other side. That trait won't just pay dividends during the season though. It'll be a big asset in the real world

Matoush Wraps Up First Season

will probably look back at the 2019-2020 season as the season they started to turn it around.

While most coaches would take an overall record of 14-11 mark as a successful season. Washington University is not the normal school. Not athletically or academically. In women's basketball, they have posted 20 or more wins in eight of the last 10 seasons. During two of those years, they were fortunate enough to play in the NCAA Division III National Final. They won the national title in 2010.

"I think about it every single day I'm in the gym coaching my girls. I realize, just from a coaching perspective, I could be a better coach to them if I had four full years of basketball. I feel like I missed out," Roecker said. "I was so young and it doesn't really stick with you. Thinking back, all of the things I'm teaching them, I don't recall being taught that. I probably was, but I feel like I could have been a lot better if I would have been able to play four years."

With one school record to her credit and two more years to go, the sky might have been the limit back then for Roecker.

"Early on I was thinking I could maybe play in college. Who knows if that would have worked out. You can't dwell on that part," Roecker said. "I do think it would have been fun to see how things would have worked out if we would have

had basketball my four years

While Roecker wasn't able to play in college, others from Lincolnwood have made that step and are role models for this year's team. Sarah Hitchings, a 1997 grad who was one of the first Lancers to take advantage of Lincolnwood's co-op with Nokomis for girls basketball that began in 1993, went on to play for Bellarmine University after scoring 1,132 points for the Lady Redskins, currently seventh most all-

Va'Nicia Waterman, a 2001 graduate, was a key member of Nokomis' state title teams in 1998 and 1999, still holds the career scoring record for the Lady Redskins with 2,384 points. Waterman, who went on to play for Bradley, had the most points in the history of Montgomery County girls basketball for 18 years, until Hillsboro's Sammi Matoush surpassed her mark last

While Hitchings and Waterman were done with their high school careers before any of this year's team was born, 2017 graduate Abby Brockmeyer provides an easier example on the possibilities that basketball can provide. Many of them can probably remember Brockmeyer dropping in shot after shot as a member of the Litchfield co-op squad, where she would go on to set a program scoring record with 2,362 points before heading to Southern Illinois University in Carbondale.

Several players from the high school team and the junior high program, also in its first year, were in attendance for Brockmeyer's opening game of her junior season in November 2019 in Edwardsville. The 6'1" forward scored 16 points and had seven rebounds in the game, but more importantly, she took time to talk to the next generation of Lady Lancers

after the game.

Conference Record: 0 wins, 5 losses

That type of connection is what Roecker remembers from her time as a Lady Lancer, not the points, not the records and not the wins and losses.

"I think what I really valued in the program, I was only a sophomore at the time, was how supportive the older girls were to me," Roecker remembers. "There were a lot of good girls in the program. A lot of the time they were the same girls that were in volleyball and track with you. That's really what I remember the most."

The current Lady Lancers are on that same path. They've practiced together. They've lost together. And if they can stick it out through the hard times, someday, they'll win together.




