# Panhandle Board Continues Home School Discussion

After the Panhandle School Board determined that its policy on not allowing home schooled students to play school sanctioned sports would not change for the 2022-23 school year, Superintendent Aaron Hopper promised to provide more information on what other school districts are doing. On Monday, Feb. 27, Hopper presented some of that information.

Hopper reached out to 202 different school districts in central

Illinois, 139 of which responded. Of those 139, 28 currently have policies that allow home schooled students to participate in athletics.

Of those who do allow home schooled athletes to participate, requirements ranged from attendance for one hour to two hours to half a day to 300 minutes, with at least 40 percent of those schools requiring a half day of attendance or more. At Lincolnwood High School, half a day would be either from 8 to 11:20 a.m. or 11:24 a.m. to 3 p.m. Only eight of the schools surveyed

have no attendance requirement.

Hopper said that daily attendance was an important aspect

of those who allow home schooled students to participate, with most schools requiring that students take credit bearing classes. One of the requirements for eligibility by the IHSA (the high school sports governing body in Il-

One of the requirements for eligibility by the IHSA (the high school sports governing body in Illinois) was that students must be actively enrolled by the 11th day of the semester. Previously the district had spoke about using May 1 as a deadline for enrollment, which

would satisfy that requirement.

Another IHSA requirement is that grades and curriculum from

that grades and curriculum from the semester prior must be submitted and approved by the school. Hopper said that some of the schools he talked to required third party providers or accredited curriculum programs to be used, adding that Clinton had the most detailed program, with curriculum required to be reviewed by the Regional Office of Education.

Hopper said that the primary goal of the district is the education

of the students and any curriculum provided by home schooled students should meet the standards of the Lincolnwood curriculum in fairness to the current students and their eligibility.

He added that if the board does choose to change the policy (which currently prohibits students not attending school from participating in athletics), they may consider requiring multiple hours of attendance.

The Nokomis City Council raised concerns about the proposed Heartland Greenway carbon dioxide pipeline at its regular Feb. 27 meeting.

Navigator CO2Ventures has filed a new route for its pipeline with the Illinois Commerce Commission after withdrawing its original proposal in January. The new route, according to Nokomis commissioners, has the pipeline coming closer to city properties, wells, and aquifers than previously thought.

## Witt Aldermen Focus On Community's Youth

Acting on behalf of the (former) Presbyterian Church of Witt, Alvin Yeske presented a donation to the City of Witt during their monthly meeting on Tuesday, Feb. 28. The church specified that the donation is to be used for a basketball court; a way to provide more recreational opportunities for local youth. Yeske informed the alderman that the church had made several similar donations to civic organizations within the city, as well as setting aside funds to continue the long-running "Breakaway Program," an outreach mission aimed at engaging the city's children and young families.

Mayor Taylor also addressed the alderman about replacing the lights on the ball field at Witt Lions Park. "If we don't have anything for kids to do in this town, what do you think they are going to turn to," he asked. Taylor in-

formed the council members that new LED lights can be installed for approximately \$275 per pole, and that they need at least 20. All were in agreement that replacing the lights would be beneficial to the community, however the matter was tabled until a decision is made regarding

the city's potential purchase of the park.

Aby Phoenix, a new resident who has long familial ties to the city, introduced herself to the aldermen and asked about volunteer opportunities and ways to get involved. Alderman Cearlock invited her to get involved with Envision Witt, a civic organization that takes on improvement projects and community events within the city. Phoenix mentioned a few issues with speeders in front of her home and asked about blocking off parking spaces in front of a downtown building that is owned by her brother, so that they can begin to renovate the space. The alderman suggested speaking to the downtown employees who use the parking spaces and explaining the need to keep the spots in question open before taking more permanent action in the form of "no parking" signs.

### **Body Of Hillsboro Man Recovered From Lake**

The body of a Hillsboro man was recovered from Old Lake Hillsboro on Wednesday, March 1, according to Montgomery County Coroner's Office.

Robert Miles Harris, 56, of Hillsboro, was pronounced dead at the scene at 10:20 a.m. by Montgomery County Coroner Randy Leetham. A forensic autopsy has been scheduled for Friday, March

According to the coroner, Montgomery County 911 received a call at around 10:15 a.m. Wednesday regarding a suspected body in Old Lake Hillsboro near 781 City Lake Road. The Hillsboro Police Department, Montgomery County Sheriff's Office,

and Illinois Department of Natural Resources Conservation Police responded, and requested the Hillsboro Volunteer Fire Department Dive and Rescue Team and also the coroner's office.

A search warrant for a nearby parked vehicle was obtained through the Montgomery County State's Attorney's office, and a note was recovered from inside the vehicle. According to the coroner, there is no indication of a criminal element involved in the death.





after winning his first in 1996. Brown advanced to the title match by defeating Mark Mathews of Greenville 8-11, 9-11, 11-9, 12-10, 11-6 in the semifinals, while Johnson defeated Caleb Hall of Charleston 11-9, 11-1, 13-11 in the semis.

Phil Abegg of St. Louis, MO, won the Class C title, defeating Nate Schipkowski of Litchfield 11-7, 11-6, 14-12 in the championship match. Abegg defeated Ron McCarty of Mt. Pulaski 6-11, 11-6, 11-7, 11-3 in one semifinal, while Schipkowski defeated Rich Fanelli of Mattoon 11-4, 7-11, 11-8, 11-9 in the other.

In doubles, it was Goertz and Brad Woo of Mahomet winning the title in a 3-1 championship match over Hall and Robert Clark of Taylorville. Though no action was taken at Monday's meeting, commissioners agreed to have legal counsel draft a resolution in opposition to the pipeline proposal to be presented to the Montgomery County board.

The issue will be taken up again at the next council meeting. The proposed pipeline will run for over 1,300 miles through five states, including through the heart of Montgomery County and central Illinois. Opponents to the pipeline have cited environmental concerns in the case of a pipeline leak and contamination of drinking water.

Board member Linda Brown asked if there would be any stipulation on core classes being required. Hopper said that if students were required to attend half a day, then that requirement would probably be met.

Board member Scott Cowdrey asked if there were repercussions for students who dropped out immediately after their season ended. Hopper said the district's application would include enrollment requirements, with students not allowed to play a sport later in the season or the next season if those requirements weren't fulfilled.

Board member Gabe Pope asked who determined if a third party curriculum program would be required for home schooled students. Hopper said that the individual school district made that determination, saying that one school did not approve a student because an accredited program wasn't used, while other districts were less restrictive.

Board member Linda Brown asked if all of the handbooks would have to be revised if the policy changed. Hopper said yes, but the board decision supersedes the handbook if the changes weren't made immediately.

Board member Heather Millburg asked about the discrepancy between Panhandle's policy and Morrisonville's policy, which allows home schooled students to participate. Hopper said that the district continues to have conversations with Morrisonville regarding the memorandum of understanding for the all-sports co-op and how such issues affect both schools.

No action was taken on the matter on Monday night, with Hopper saying that any change to the policy would require a first and second reading before the board.

In other business, Hopper said that Principal Ken Schuster and Athletic Director Josh Stone have been working on a sportsmanship code for not only athletic events, but for behavior expectations for all events held at the school.

Hopper said that the district has had a code of conduct for visitors to school property for a long time (Policy 8:30), but this clarifies the repercussions of failing to abide by that code. He added that if those requirements are not met, then a person could be banned from campus, with an appeal to the school board available if they would like to pursue it.

Scott Cowdrey asked who was in charge of ejecting individuals who don't follow the sportsmanship code. Hopper said that it could be the administrator on site, Stone or a game official, but just because someone is or isn't ejected, that did not mean that there could not still be repercussions for bad behavior.

Hopper also said that sportsmanship classes offered by the National Federation of State High School Associations may also be required in order for an individual to be allowed back on campus.

The board also discussed

pursuing the installation of solar panels, which collectively they determined they'd rather not have on the roof of the school due to its recent replacement.

Hopper said that the time to look at the project is a good one with credits changing at the end of the year and that there are several options for grants and payment.

Terri Payne asked if there was room on the grounds for the project. Hopper said that was one of the things that he would check with providers once he confirmed the project was something the board was interested in. He added that he hopes to have more information to the board in April.

Before going into closed session at 7:40 p.m., the board also reviewed the 2023-24 school calendar before it goes to the teachers for a vote and appointed Dana Pitchford as the board's representative on the handbook and discipline committee. Pitchford wasn't in attendance at the meeting, so the appointment was contingent of her approval.

## Witt City Council

Mayor Tim Taylor gave the water report, explaining that they were still waiting on the booster station, which is anticipated to be up and running in April. Sonia Hodson gave the Treasurer's Report: the municipal utility tax for January 2023 was \$5.534.24.

"I like to think that we are making a change in Witt," said Police Chief Dalton King, while giving an oral report to the council. King spoke about upgrades to the police department's equipment and items he hopes to have in the future, stating that he is working on slowly upgrading the items the city's officers need while being financially conscientious. He stated that there has been an increase in domestic disturbances and asked people to "be safe" and make a report when they are concerned.

Mayor Taylor said that he had spoken to Ameren about getting more lighting at City Park. Chief King stated that it would be appreciated as "there always seems to be something going on in the

Continued from page 1A shadows." Taylor asked King who live outside of the city decided to continue to focus to give him a list of other areas in the city that are in need of more lighting. Mayor Taylor reported that EJ Water Cooperative has offered to help pay for additional lights in the city as a way to give back to the community.

Fire Chief Don Keiser reported that the fire department has responded to nine fire calls and 18 EMS calls since the last meeting. Engine #304 is finally paid off and the title has been given to City Clerk Nancy Hughes for safekeeping. Brush Truck #306 is having steering pump issues. The new gear washer has been installed at the fire house. The (former) Presbyterian Church presented the volunteer fire department with a generous donation.

Keiser said that the department sold 676 rib dinners during their annual fundraiser in February; their biggest so far; however with the increase in costs they came in even with the amount they made from the fundraiser pre-COVID. The department will send out subscriptions to people limits, but within the department's coverage area in March. There is a \$40 fee to subscribe. The fire chief then asked for a copy of the city's burn ordinances to be distributed to residents as there have been a lot of violations over the last few months. Discussion turned to a

request from the Witt Lions Club asking the city to purchase the property currently owned by the club, with the stipulation that the club be allowed a long-term lease of the Lions Club Building and the parcel directly behind it. Currently, the city leases the City Hall building from the Lions Club. The alderman voted in favor of Taylor finding out more information about the potential purchase and reaching out to legal counsel for advice. Aldermen Dave Cearlock and John Livesay abstained from voting as they are active Lions Club members.

Taylor informed the council that work is needed at the city dump. After much discussion the aldermen

on ditch work and installing the newly purchased culverts throughout the city, and to address needs at the city dump when funding allowed.

The aldermen voted in favor of pursuing an Ecwag Grant in the amount of \$150,000 to install new storm sewers (and the subsequent sidewalk/pavement repairs) downtown. The council plans to address the downtown streetscape issues in sections as finances allow.

Clerk Hughes will get notices that the city is actively seeking summer workers and bids for lawn maintenance at the cemetery posted in the area newspapers. Aldermen decided to accept a bid for \$1,400 to remove three trees that are currently located on top of storm sewers on S. Fifth Street, and to open a line of credit at Security National Bank, to be used in an emergency.

The board moved into executive session at 8:41 p.m. The meeting was adjourned following their return.





### 2022-23 A Season To Celebrate For Hillsboro Girls Basketball

With 20 wins, the program's 12th regional title and two landmark accomplishments, the 2022-23 Hillsboro High School girls basketball season was the latest in a long string of successful years for the program.

The Lady Hiltoppers haven't had a losing season since they went 12-16 in the 2010-11 campaign and this year's 20-12 mark gave Coach Bret Tuetken his 10th 20-win season in his 21 years at the helm of the team. In those 21 years, Tuetken has won 412 of Hillsboro's 650 games, with win number 400 coming the day after Christmas in a 59-26 victory over Auburn at the Riverton Holiday Tournament.

A big part of the Toppers success this year was due to their senior class (Layne Rupert, Alex Frailey, Sierra Compton, Kenadie Carlock and Meagan White), who accounted for just over 71 percent of Hillsboro's total

Almost half of that total came from Layne Rupert, who came into the season needing 82 points to reach 1,000 for her career. She'd need just six games to reach that mark and continued to pour on the points over the next 26 contests, finishing with the fourth most in the program's history with 1,476.

A three-time all-conference pick and two-time first teamer, Rupert led the team in points (17.4) and steals (2.4) per game, while coming in second in rebounds (4.8) and steals (2.4). She also led the team with 40 three-pointers, but what truly made the senior guard dangerous was her quickness and ability to get to the basket, despite being the focal point of every defense the Toppers faced.

Alex Frailey was second in scoring with 9.2 points per game, plus 4.7 rebounds, third most on the team. While Frailey was one of Hillsboro's biggest post threats over the last three seasons, oddly enough she found her three-point stroke in the Toppers' final two games, hitting all three of her career

three-pointers in Hillsboro's games against Pittsfield and Quincy Notre Dame.

Sierra Compton and Kenadie Carlock were both a little more comfortable from three throughout their careers as Compton hit 28 and Carlock finished with 36. A third-team all-conference pick, Compton averaged 5.1 points, a team-best 4.7 assists and 2.1 steals per game, second most for the Toppers.

Carlock, who hit six more threes than she did the year before and at a better percentage than in 2021-22, averaged 3.5 points, 2.1 rebounds and 1.5 assists in her senior season.

## Panthers Bid Corso, Seniors Buena Suerte

After 28 games played during the regular season, the Litchfield School girls basketball season came to a close on Feb. 11 at home against Roxana in the IHSA Class 2A regional tourna-

Under the guidance of Litchfield Middle School Spanish teacher and Girls Basketball Head Coach Rob Corso, the Lady Panthers finished 10-19 overall and 2-7 (eighth behind Carlinville) in the South Central Conference. They won seven times at home and had 11 losses. They were 3-8 on the road. They averaged 31.6 points per game and their opponents averaged 42.5 points per game. They rebounded 28.4 caroms per game and averaged 9.9 fouls, 9.8 steals, 2.2 blocks and 11.9 assists but turnovers were a constant within the Lady Panthers with an average of 21.9 per game.

The Panthers competed in two tournaments, their 23rd Annual Thanksgiving Round Robin in November and the 16-team Riverton High School Christmas Holiday Tournament in Dec.. Litchfield finished fourth in their six-team round robin and placed seventh at Riverton.

The 2022-2023 girls' basketball season also marks the end of Rob Corso's teaching and coaching career. His coaching roots were planted in 1985 when he attended Illinois State University and served as a volunteer assistant to the Normal Community High School football program.

After coaching two years at Brown County Mt. Sterling and two years at Staunton, he came to Litchfield High School in 2007-2008 where he has remained at the helm of the girls' basketball program for 11 years, during which time his teams have posted 172 wins against 133 losses. His 15-year overall coaching record contains 226 wins and 187 losses.

Coach Corso's Lady Panthers captured regional tournament titles in 1998, 2013 and 2015. In addition, they earned a sectional title in 2013. In 2017, the Lady Panthers were crowned as South Central Conference Champions.

This year's Lady Panther roster numbered 12 players at the beginning of the season and 11 at the conclusion. Due to the limited numbers, there were no junior varsity games played.

Paramount to the Lady Panther lineup were three seniors, Laura Boston, Hailey Rentz and Emma Walch, all of whom have been playing basketball together since middle school.

Standing 5'11", Laura Boston led the team in scoring with 241 points in 28 games. Playing in the post position, she averaged 8.6 points per game, 5.6 rebounds, 2.1 steals and 1.9 assists.

She posted a doubledouble against North Mac on Jan. 12 (10 rebounds, 13 points) and again on Jan. 19 at East Alton-Wood River (11 rebounds, 18 points).

She scored in double figures against 10 different opponents with her highest point total (21) at home against Piasa Southwestern on Nov. 21. She shot 44% from the floor and 58% from the free-throw line. She stepped out of her comfort zone and canned her only three-point basket against Taylorville on Jan. 24. She was second in rebounding with 157 caroms. She was the team leader with

Hailey Rentz scored 133 points in 29 games for a 4.6 per game average. The 5'5"

forward averaged 28% from the floor, 26% from downtown and 73% from the charity stripe. She averaged 5.6 rebounds per game, 2.8 steals and 2.8 assists.

She too had double-doubles against Springfield Lutheran on Jan. 9 (10 rebounds, 17 points) and North Mac on Dec. 27 (11 rebounds, 13 points). She scored in double figures against North Mac (two times), Mt. Olive, Springfield Lutheran and

Carlinville. She made 11 three-point baskets and sank three triples against North Mac on Jan. 12 and at home against Carlinville on Feb. 9. Rentz and Gina Painter led the team in rebounding with 163 apiece. She was also the team leader in assists with 82 and

led in steals with 81. Emma Walch scored 116 points in 28 games for a 4.1 points per game average. She shot 22% from the floor, 17% from deep and 91% from the free-throw line. The 5'11" forward sank 30-33 free throws and unofficially her 91% accuracy from the charity stripe may have set a single season record in LHS girls' basketball.








Three Litchfield Middle School wrestlers will compete for a shot at an IESA State Wrestling Finals berth on Saturday, March 4, at the Class 1A Auburn Sectional.

Eighth graders Rilynn Younker and Syon Jade, along with sixth grader Kohen Kieffer, all finished in the top three at the Jerseyville Regional on Saturday, Feb. 25, to earn their sectional opportunity.

All 10 underclassmen who made all-conference for the South Central Conference last year were repeat selections in 2023 as this year's honorees were announced

Among the repeat honorees were three players who were acknowledged for the third time in their careers: Hillsboro's Layne Rupert, Pana's Anna Beyers and Vandalia's Anna Forbes.

Regardless of the number of wins Hillsboro gets in 2023-24, it will be hard to replicate this season, both due to its successes and the straight up weirdness of the year.

Six of Hillsboro's 12 losses were by single digits, the biggest of which was a 44-37 loss to Highland, the Toppers' only home loss in 10 games. That includes three one-point losses to Civic Memorial, Mt. Pulaski and Staunton, plus a two-point loss to Nokomis and a fourpoint loss to Greenville. The average number of wins for those six teams? Twentythree, with Civic Memorial the only team not well over

The other six losses were even more strange. Breese Central, Taylorville (twice), Rochester, O'Fallon and Quincy Notre Dame beat the Toppers by 164 points combined, an average margin of victory of 27.3. That has more

to do with how tough those teams are than difficiences amongst the Hiltoppers. O'Fallon and Quincy Notre Dame (Hillsboro's opponent in the sectional semifinal), are in the 4A and 2A state tournaments respectively, while Rochester and Breese Central both made it to the sectional finals before their seasons came to an end.

On the winning side, of their 20 wins, only two were by single digits: a two-point victory over Mt. Zion at Taylorville and a 9-point win over Pana at home. Both the Braves and Panthers won regional championships this season.

All 18 of the other wins were by at least 10 points. In fact, 15 of those wins were by at least 20, with the only exceptions a 11-point win over Marquette in December and the Toppers' wins over South County (by 13) and Pittsfield (by 17) in the regional.

What does all of this mean? No clue, but if I would have to guess, I'd say that the Toppers were in a class of their own. The tough games during the season against Taylorville, O'Fallon and

Rochester put them in better position to advance up the South Central Conference ladder (they'd finish tied for second with a 7-2 record) and score their 12th regional title.

Hillsboro will probably see similar competition next vear as well, and hopefully that too will prepare the Lady Toppers for more success. Hillsboro Girls Basketball

### **Lots Of Opportunities To Donate Blood This Month**

The American Red Cross will host several blood drives within Montgomery County

A community blood drive will be held from 2 to 6 p.m. at Nokomis Junior/High School on Tuesday, March  $\bar{7}$ . A blood drive will also be held at the Witt Lions Club from 1 to 5 p.m. on Tuesday, March 14. The Christian Church of Litchfield will hold a community blood drive from 1 to 5 p.m. on Wednesday, March 29.

Donors will be asked for their Red Cross donor card or a positive photo identification, and must be at least 17 or 16 years old with a signed parental consent form, weigh at least 110 pounds and be in good health.

Donors should be sure to eat at regular mealtimes, and drink plenty of water prior to giving blood. They are also encouraged to eat foods rich in iron, since only blood with good iron levels

will be accepted for donation. Iron is part of hemoglobin. the protein that carries oxygen and gives blood its red color, and combining ironrich foods with foods rich in Vitamin C will enhance the absorption of iron. Tannin in tea decreases the amount of iron the body absorbs by about 50 percent.

Those with medical conditions may still be eligible to give at this drive. In most cases, it is the condition for which a person is taking medication, not the medicine that causes them to be unable to donate.

Usually, if the condition is under control the day of donation, the person is eligible to donate. This includes medicine for high blood pressure and diabetes.

According to FDA regulations, donors may donate whole blood every 56 days, platelets up to 24 times a year and double red cells every 112 days.



A Litchfield man, who was charged with the murder of his ex-girlfriend in June 2022 and was previously found unfit to stand trial, is now presumed to be fit to go before the court.

Deundrea S. Holloway, 22 at the time of the incident, is accused in the June 9 death of his pregnant ex-girlfriend, Liese Dodd, in Alton. He has been charged with two counts of first degree murder, two counts of intentional homicide to an unborn child and dismembering a human body, as well as offenses relating to motor vehicles and concealment of a homicide death.

Holloway appeared in court on June 16, at which time Madison County Judge Neil Schroeder shared his concerns regarding the defendant's fitness to stand trial. In July, an evaluation confirmed him to be unfit and he was directed to the Department of Human Services (DHS) for treatment.

On Thursday, Feb. 2, the defendant's DHS supervisor entered a report indicating Holloway has attained fitness. Over one week later, the court found him presently fit to stand trial. Judge Schroeder ordered Holloway to be released from the jurisdiction of DHS and remanded to Madison County Jail, where he will remain to bail.

A jury trial is set to begin Monday, March 6, at 1 p.m. in Madison County.
