Hillsboro City Council Discusses Lake Restoration Work

One question about watershed restoration for Hillsboro's two lakes may have received a partial answer at the end of the city's council meeting held Tuesday evening, June 6, during a presentation by Parks Superintendent Jim May.

May said that Northwater consultant Jeff Boeckler suggested a possible source for grant money matches that will be needed as work progresses. Boeckler said Carlinville had received a nice chunk of change by selling standing timber from land that city owns as he and May conducted a windshield survey of the watershed.

Hillsboro owns timber growing on land at the north end of Glenn Shoals (on the east side) that contains white oak, hickory, and walnut trees. May says he feels white oak is particularly valuable now, but he also said a disease is slowly spreading in woodlands. The city may face a sell it or lose it situation.

Boeckler, according to May, suggested hiring a forestry consultant to manage the potential sale; the cost to the city would be 10% of the highest bid from professional companies in the business of responsibly harvesting timber.

Parks Commissioner Fred Butler said he hoped all of the revenue could go to the Lake Restoration Fund to help pay for projects needed on the lakes, but that will require a separate vote if the project goes through. Hiring a consultant was on the agenda as a discussion item only, so no vote was made, but the council seemed agreeable to proceeding.

Butler did move to enter a land lease

option on the north end of the Eagle Zinc Superfund reclamation area. U.S. Power asked for the option so they can approach Ameren to see if grid capability is available to collect and disperse any power a solar farm would produce. The ground in question is 17 acres, so it's not the entire site. Mayor Don Downs said he knows some citizens in town had hopes to use the entire area for light industry, but he said those businesses seemed hard to attract (based on experience with the first industrial park which is now the sports complex).

Both Downs and Finance Commissioner Patrick Ward reminded the council that the vote was only about a lease option, not the actual lease that will be required if Ameren and U.S. Power can come to an agreement. In the meantime it will provide some income

option on the north end of the Eagle Zinc for Hillsboro. The motion passed with no Superfund reclamation area. U.S. Power objections.

Butler also moved to list two city-owned lots for sale; one is at 123 South Douglas and the other at 672 Virginia Street. According to Butler, selling those lots would put them back on the taxable property list and reduce the mowing the city is obligated to do. The votes to do so were unanimous.

Not all of the motions were income producing. Butler was upset at the only bid received by the county and the city for sidewalk, curbing, and American Disabilities Act work needed around the courthouse. He and the other council members were reluctant to ask for more bids, however, because other bids could be higher, given the trend in construction costs.

FINAL HOPE

McLaughlin Named Honorary Chair For MCCA

It wasn't exactly the birthday present she was hoping for when Isabel McLaughlin found a bump in her mouth on her eighth birthday. That bump turned out to be a rare form of childhood cancer called Rhabdomyosarcoma.

After a year and a half of treatments, McLaughlin has been declared cancer-free and has been named the honorary chairman for this year's Montgomery County Cancer Association Birthday Party and Celebration of Life.

This year's festivities will be held on Saturday, June 24, at The Event Center of Montgomery County in Taylor Springs. In addition to McLaughlin's remarks as the honorary chairman, the event will include a dinner, both a live and silent auction, balloon animals and magic tricks with Professor Longhair, recognition of this year's fundraising teams and scholarship grant recipients and a special survivorship ceremony. Tickets are still available for this year's event by calling Shelley Halleman at 217-412-8598.

McLaughlin and her family will share her story for those present at the dinner. She is the ten-year-old daughter of Phil and Lindsey McLaughlin of Hillsboro.

After discovering the bump in her mouth, McLaughlin saw local dentist Dr. Rob Hamm, who gave her a ten-day antibiotic, treating it as a cyst.

"At this point, no one thought it was cancer," said Isabel's mom, Lindsey.

While she was taking the antibiotic, they noticed the bump was still growing, and Dr. Hamm sent them to a pediatric dentist in Edwardsville. That dentist took some x-rays and recommended them to a periodontist at St. Louis University in St. Louis, MO.

"He told us not to lose any sleep over it," Lindsey said. "Which was good because my dad had just gotten done with a bone marrow transplant in his battle with cancer."

In May, Isabel was scheduled for surgery with an oral dentist to remove the bump. What they found was a tumor that was not only wrapped around her tooth, but the inside of her mouth as well. It took two weeks for a biopsy to confirm Isabel had cancer on June 7.

"They told me and I cried," Isabel said. "I had to start treatment right away."

The very next day, Phil and Lindsey took her to Cardinal Glennon Children's Hospital in St. Louis, MO, for scans and to meet her doctor, Dr. Lauren Draper. Testing continued as they prepared to begin treatments.

"We daily got bad news, Lindsey said. First the tumor was bigger than they initially thought. Then, genetic testing showed the cancer was the worst of the two options.

Treatment officially began on June 16, and Isabel was given a 50-50 chance of beating the odds. Her first treatment included port access, a spinal tap and her very first dose of chemotherapy.

"My first night stay in the hospital,

I puked a lot," Isabel said.
Initially, she was given a 42-week treatment plan, but that was increased to 52-weeks when they learned the cancer had metastasized to her bone marrow.

After discussion, the vote was 5-0 to accept the bid from Kinney Construction (of Raymond). The county's portion is \$97,220, while Hillsboro's cost will total \$134,950.

Already budgeted but needing approval by council vote because the amount was \$10,000, that amount heads to the soccer pitch lighting fund at the Sports Complex. That motion was approved unanimously. Also approved was the final payment for the Huber Drive water line project.

Other motions were cashneutral for the city. Approved was a resolution to go to the Illinois Department of Transportation (IDOT) to close Rt. 16 and 127 for the Old Settlers Parade on Thursday, August 10, from 6:30 p.m. to 10 p.m.

Zach Wygal asked permission to host a cardboard boat regatta at the old lake on July 15 beginning at 11 a.m. The regatta/race was very popular until COVID caused a halt to the tradition. Crossover Ministries asked that part of the Courthouse Square traffic be halted on July 10 as they mark their third year as a local organization. The closing will be similar to that of street closings for the biweekly Farmers Market.

Tabled was a motion by Public Safety Commissioner Tommy Justison to close select city streets for the Old Settlers' Parade. Mayor Downs began a discussion about the need for moving the temporary stage set up for Wednesday and Thursday proceedings be moved from east of the courthouse and relocated at the intersection of Seward and Broad Street (by the Red Rooster and the gymnastics center).

Tabling the motion until the next meeting on Tuesday evening, June 20, will give council members a chance to research the motion. Perhaps some public opinion will arise.

The commissioner and mayors' initial reports were insightful but routine. Butler began with his dual reporting duties. He thanked Bret Reeves for his service time on the Natural Resources' Committee; Reeves' resignation (so he could take on part-time work with the Parks Department) leaves an opening on that committee, which meets in city hall at 6 p.m. on the

third Wednesday each month. He also had a warning; the Central Park pool is open for the summer – its eightysixth year. Butler said that because of its age, it takes

more work and more money to open it each year. The Kiddie Pool pump quit after the re-opening. A new motor will be installed soon. In Butler's opinion, the council will "...have to make hard decisions..." about the current pool's fate...soon.

Butler also had thanks for the fire department's dive team for attaching the final cables to the South Marina. Boeckler trained Park staff members about sampling, testing, and measuring flow amounts so data gathering can continue. Measurements will be taken twice a month through October. Commissioner Kendra Wright later added that the Illinois EPA was on site Monday (June 5) to begin summer lake monitoring for cyanotoxins, and they test both raw and treated water).

Butler thanked the twelve to fifteen volunteers who carted off debris from around the lake and from abandoned lake lots on a recent Saturday. May and others, including a water resources engineer, inspected the Glenn Shoals dam; the original assessments were made in the 1960s, and rainfall patterns have changed since then.

The Street Department's mortuary division removed two deceased raccoons from Kinkead Road. They are also pouring sidewalk on Smith Road. There was a good turnout for the spring cleanup to the dumpsters by the city shed. A meter pit was installed on Virginia Street and they raised a sewer access point on East Brailley Street.

A newcomer to the council, Justison gave his first public safety report. He plans to meet soon with the fire department and police department leadership teams. He noted that summer time seems to bring more calls to the dispatch center (492 in May) and more traffic stops. Fifty-one of those contacts involved traffic violations. One hundred-seventy-seven of the calls came on Tuesday and Wednesday.

Justison also plans to check in with Code Enforcement Officer Mike Lee soon. He wants the departments that report to him to be transparent but effective.

Downs asked parents with teenage (or young adult) drivers to tell their offspring that city streets are not race tracks nor venues for displaying the sounds of loud mufflers. The mayor said he personally noticed unwarranted behavior downtown on Monday evening "...that will not be

tolerated."

Downs also had a printed and highlighted copy of Ordinance 33-3-1. "It shall be unlawful to plant any bushes, trees, shrubs or other plants on the right-of-way of any public street, including the space on the right-of-way between the sidewalk and the adjacent street pavement."

In addition to reporting about IEPA testing, Wright said Phase I of the Lead Service (line) Replacement Project has been approved by the IEPA at 100% - \$583,000. That will cover the cost of replacing approximately 74 water lines (from the main to the meter) in 2024. It helps receive such awards because Hillsboro is on the Disadvantage Community list. A low interest loan would make up any gap between the award and the actual cost. Another phase will follow.

Wright thanked the Street Department for fixing a leak in the sampling hydrant in front of the water plant.

Sewer Department employees have been cleaning the tanks in the old plant while the weather is dry and flows are down. The first round of samples to be used for Whole Effluvient Toxicity Testing has been submitted. It's a necessary step before a new permit will be issued; the last permit came in 2016.

City Engineer Jeremy Connor reported that only the signing of papers is stopping work on the Mechanic Street project, so that's imminent. OSLAD Grant research is complete, and a meeting with IDOT will occur in the next week or so. Connor also helped explain the difference in costs concerning sidewalk work at the courthouse, citing the curbing and ADA work as that which boosts the city's

Community Planner Sarah McConnell couldn't be at the meeting, but she submitted a written report. The Head to Hillsboro website is about ready to launch. She's working to "...establish a good way to incorporate an efficient calendar." The tourism map goes to the printer soon. She termed the Shop Hillsboro event on June 3 a success. Wright added the crowd that appeared at the Abbey on Broad for the concert that night was impressive.

The council agreed unanimously to cancel the July 4th meeting; fireworks of another kind awaits that evening. They will meet in regular session on Tuesday, June 20, at 7 p.m. in city hall.

"It was really hard," Isabel said, noting the six weeks of radiation were the hardest parts of her overall treatment.

Lindsey said Isabel was the sickest during the first six weeks of treatment as her body got used to the chemotherapy.

At week 20, Isabel started radiation, and she lived in St. Louis, MO with her parents for the duration of the sixweek treatment. Her younger brothers, Henry and James, stayed with their grand-parents, Ralph and Anne McLaughlin of Hillsboro.

"I barely ate anything during radiation," Isabel said. "It hurt to eat, but also because I just wasn't hungry."

During her treatments, she got thrush three times and lost her voice for awhile.

Toward the end of radiation, she ended up with an eight-night stay in the hospital because her body was

"I think the hardest part for her was the radiation," Phil said. "If you look back on the pictures, her smile was so forced and you could hardly recognize her. It was definitely the lowest point."

But once radiation was complete, they went back to the treatment plan of chemotherapy. In addition to the now 54-week plan, Isabel would have six months of maintenance chemo to make sure it was all taken care of.

In February, the McLaughlins finally got some good news. Her latest scans showed no evidence of the cancer at

"It was the first time we really saw a reaction from her," Lindsey said. "You kind of become numb to what's going on around you, but that was the first time they used the words, 'cancer free.'

On June 14, Isabel took her last dose of chemo before the maintenance plan began, and her family planned a special celebration. They invited family, friends and the community to celebrate with them as Isabel rang the bell just outside Beckemeyer Elementary School in Hillshoro

"They really surprised me," said Isabel, who completed nearly all of her third grade year at Beckemeyer remotely.

She said she also missed a lot of holidays with family.

And while it was a tough year for Isabel, there were also some good parts, including Camp Rainbow, a summer camp for kids with cancer, a Make-A-Wish trip to California to bake cakes with Duff throughout our journey."

Goldman and modeling in a fashion show for Friends of Kids with Cancer.

Up next, Isabel will be a fifth grader at Beckemeyer this fall, where she looks forward to time with her friends. And while they don't look at the odds of the cancer returning, her family remains hopeful she will stay cancer-free.

"Because she responded so well to the treatments, doctors are hopeful it won't return," Lindsey said.

Isabel will continue scans for five years for this type of cancer, and then move to additional scans to monitor for other types of cancer from the chemo.

The McLaughlins are very grateful to the local community for their support, as well as the MCCA, which provides financial assistance to local cancer patients and mileage reimbursement for treatments.

Isabel said some of her friends even hosted a lemonade stand to raise money for her.

"The community at-large was just amazing," Lindsey said.

"We're very grateful for the people in our community and the MCCA," Phil added. "Everyone was very generous

Coal History Could Draw Tourism

At the invitation of the Montgomery County Historical Society, Dr. Helaine Silverman, a professor in the Department of Anthropology at the University of Illinois, spoke to community members about her desire to include the City of Hillsboro in the Mythic Mississippi Project during an informal tourism meeting held at the Historic Courthouse on Tuesday, May 30.

Created by the University of Illinois three years ago as a way to invest in the economic and social development of often overlooked municipalities in downstate Illinois, many of which have rich historical legacies, The Mythic Mississippi Project works alongside communities to establish thematic tourism routes centered on the historical events that happened in their areas.

"This would be appealing to a very specific, niche tourist," explained Silverman. "It would primarily attract academics and history enthusiasts, prompting them to spend more time, and subsequently money, downstate."

Silverman went on to explain that the university's idea of "heritage tourism" deploys history as a product for consumption in the present. Hillsboro would be a fit for the project's "Coal Triangle" heritage route, which is based around Illinois' history as a major coal producing state in the early part of the 20th century. During this time period coal towns, many of which were located downstate, were thriving with active main streets and proud communities and the project hopes to help revitalize these areas by engaging residents to build and tell the stories of their own history.

The over arching goal is to link communities with coal histories, in particular Virden, Gillespie, Mt. Olive, Benld, Carlinville and potentially Hillsboro, together into a cohesive coal-labor history route to promote tourism within the region.

"Community engagement is a primary factor for inclusion in the project," Silverman explained.

In order to be part of the Mythic Mississippi Project communities must demonstrate that they are capable of coming together to build attractions that will generate outsider interest, while the university will act more

as a silent partner by providing funding and marketing, as well as coordinating between the areas included in the "Coal Triangle" route. Among Silverman's suggestions for Hillsboro were erecting an "Illinois State Historical Society" marker at the Historic Courthouse, creating a visitor center that includes historic depictions of the city, and developing home and cemetery tours with informational signs at each stop.

She noted that the city already boasts many amenities that will peak tourists interest including the Red Rooster Inn, the Abbey on Broad, restaurants, coffee shops, lodging and recreational venues, making Hillsboro an ideal candidate for the project.

Åfter her presentation, attendees spoke about the potential of being included on the heritage route as well as the many elements that are already in place and how to best coordinate efforts among differing groups and organizations.





Saathoff On A Hot Streak

sive American Flat Track (AFT) Singles class were better than Chase Saathoff in the month of May as the Hillsboro motorcycle racer upped his total to five podium finishes on the year and slid into a tie for second place in the overall standings.

Saathoff, who was second at the Dallas Half-Mile on April 22, made it two straight runner-up finishes on May 6, as he finished second to Kody Kopp by 0.293 seconds at the Ventura Short Track race.

California seemed to suit the Illinois boy just fine as he scored his third straight podium finish at the Sacramento Mile on May 13. Saathoff finished third at the Cal three of the Pro-Am, finished Expo track in Sac-town, just .036 seconds behind winner Tom Drane, with Saathoff's Turner Racing teammate Trent Lowe finishing second by five thousandths of a second.

Saathoff was back in the midwest on May 27, for The Red Mile in Lexington, KY. The Red Mile suited the Team Red Hondas as Lowe and Saathoff finished first and second, with Lowe winning by .089 seconds.

If the AFT wins weren't enough, Saathoff was also part of a Turner Racing sweep at the Dairyland Classic on June 2, in Sheboygan, WI. Saathoff, who won heat third behind teammates Trent Lowe and Morgen Mischler in the super competitive race.

If there was ever a time a time for Saathoff to win his first AFT race, the next one may be it. Not only is the race on June 17 relatively close to home at the DuQuoin State Fair Grounds, but that complex has a special place in the hearts of the Saathoff family. In 2021, Saathoff won the AMA Flat Track Grand Championships at the short course in DuQuoin, bringing home the Nicky Hayden Horizon Award in the process and paving his way to the jump to the pros.

A pair of Carlinville riders won the Open A and Vet 30+ A classes, with Jordan Emmons winning Open A in a time of 1:50:32 to finish fifth overall and Riley Brueggeman winning Open Vet 30+A in a time of 1:56:02 to finish 12th overall. Rockton's Ryan Moss won the Senior 40+ A, running a 1:54:40 to finish 11th, while Chris Graber of Chester took the top spot in the Super Senior 50+ A class and was seventh overall with a time of 1:52:45.

Two local riders took the top spot in Open B, with Carlinville's Nathan Dyer finishing first in a time of 1:53:28 and Litchfield's Ryan Komor finishing second in a time of 1:57:09. 

Free Young Eagles Flights In Litchfield On Saturday

Youth age 8-17 will have the opportunity to take to the sky with a free airplane ride during a Young Eagles Spirit of Aviation event this Saturday at Litchfield Municipal Airport.

The event, sponsored by EAA Chapter 864, will be from 9 a.m. to noon on Saturday, June 10. Each youth must be accompanied by a parent or legal guardian who is willing to sign a consent agreement. In case of rain, the event will be postponed to the same time on Sunday.

Launched in 1992, the Young Eagles program has dedicated 30 years to giving youth ages 8-17 their first free ride in an airplane. Each Young Eagle will experience a safe and enjoyable flight from one of eight local pilots that will give them new per-

Pilots will explain what will happen during the flight, talk about the airplane, review an aeronautical chart, complete a walk-around pre-flight inspection, identify parts that control the airplane including the instrument panel, then buckle up for a ride.

Once in the air, Young Eagles will see the earth and sky in a new and exciting way in a 15-20 minute flight. Back on the ground, there will be additional time for questions.

After the flight, the pilot will issue the child the official Young Eagles logbook and certificate, and registers them in the world's largest logbook. EAA will send out follow-up information about the free online ground school course and details regarding other youth aviation programs and EAA scholarships.

Pilots volunteer their time and aircraft to make first flights possible. Each pilot is certificated by the FAA and all aircraft are likewise licensed by the government. The flights are conducted according to federal regulations, and no aerobatic maneuvers are performed.



A cross-country team of bicyclists is pedaling their way across the country and will pass through Litchfield on Tuesday, June 13.






