Council Hopes 'Wildflower' Encourages Growth In Litchfield

The City of Litchfield took the next steps toward the development of the property along Clark Street into the "Wildflower" residential subdivision during their meeting on Thursday, Feb. 6, approving five motions pertaining to the land owned by the Earl Schmidt Family.

The motions were to approve an ordinance annexing the Schmidt Estates subdivision into corporate limits, to approve an ordinance authorizing an economic development

agreement with Jack Matthews Development and three ordinances pertaining to the tax increment redevelopment plan and project for TIF redevelopment project area number four. While all five motions passed 7-0 (Alderwoman Marilyn Sisson was absent), former alderman David Hollo expressed some concerns over the agreement prior to the discussion.

Hollo said that he believed the project was too aggressive and possibly reckless, and that there were other options available to the city. "The developer wants the city to pay for half of all costs including the purchase of the land and then allowing him to sell properties and keep all profits with no return to the city," Hollo said.

He continued, saying that \$1,785,000 of funding for the project is from the long term economic development fund, and that using those funds and \$750,000 of general sales tax originally allocated for that fund in 2026 and 2027 would leave the fund with a deficit of \$632,056 at the end of the April

2027 budget year if budgeted expenditures remain the same.

Hollo said that there are other options, including purchasing the property from the Schmidts (which they offered), with the property then surplused and put out for proposals from multiple developers, with the city receiving the profits from the sale of the properties.

Hollo said that is similar to what the city did with the Eagle Ridge subdivision, where the city spent \$1.6 million developing 70 acres into 41 lots and 1.7 miles of roads

and city water mains.

"In four years we have recouped \$1.1 million through the sales of six lot leases, Hollo said, adding that three one million dollar homes had been built, with two more slated to begin construction this spring.

Hollo said that he, City Administrator Breann Vazquez and former Economic Development Director Tonya Flannery met with Bob Plummer to encourage him to develop the final eight acres of the Prairie Estates subdivision.

Charlie Company Mobilizes For Deployment

"Make no mistake. We are the Charlie Company and we are ready," said Captain Justin Asbury, company commander of Company C, 2nd Battalion, 130th Infantry.

On Sunday afternoon, Feb. 9, 130 soldiers of "The Blackhawk Battalion" of the Illinois National Guard were

mobilized in support of Operation Spartan Shield. The ceremony was held in the Litchfield High School gym with hundreds of family members and friends present.

It was one of five ceremonies throughout the state of Illinois held over the weekend in support of Operation Spartan Shield. A total of 550 soldiers are deploying from units based in Marion, West Frankfort, Effingham, Litchfield and Mount Vernon.

The battalion will be headquartered in Jordan and will have personnel in 17 locations and seven different countries. Their primary mission will be securing and protecting U.S. and allied forces and will also include training with many allies in the region. The deployment is unrelated to conflicts in the region, but rather a regular rotation of U.S. Army units into the Central Command Area of Responsibility.


Lincoln Performer To Visit In Hillsboro

The goal, if they are delivered in time, is to set a tentative ceremony date for July 4, 2025. More information will be available when the stones arrive.


The Veterans Dance was discussed and always a hit, so the third annual Veterans Dance is scheduled for Nov. 8 at the Witt Lions Building.

IDPH Gives Tips To Avoid Respiratory Viruses

The Illinois Department of Public Health (IDPH) announced that in line with the national trend, the state's overall respiratory illness level has ticked up from moderate to high, driven by an expected early winter jump in hospital admissions.

With respiratory illnesses on the upswing, IDPH issued a health alert to hospitals and healthcare facilities recommending that they take note of local conditions and consider targeted steps to mitigate the circulation of seasonal illnesses. These could include visitor restrictions and source control through measures like masking.


"The New Year has arrived, and Illinois is experiencing the expected winter surge in seasonal respiratory illnesses," said IDPH Director Dr. Sameer Vohra. "It is now more important than ever to use the many tools at our disposal to keep ourselves and our loved ones safe. The most effective tool remains vaccinations for flu, COVID-19 and RSV. It is not too late to get your vaccines, as the seasonal respiratory season can extend late into the spring."

Director Vohra recommended that anyone who is feeling symptoms of respiratory illness, such as fever, runny nose, sore throat or cough, consider getting tested and treated early in the course of their illness, especially if they are at risk for serious illness or spreading it to someone who is at risk of serious illness. Treatments for flu and COVID-19 are most effective when they are given early in the course of the illness. Those who are ill should avoid spreading germs to others by self-

IDPH has posted two help-ful new FAQ documents on its website providing the latest guidance on vaccinations and how to get tested and treated for seasonal illnesses. In addition, the CDC has created a new Respiratory Illness Data Channel that provides nationwide county specific information that would be valuable for anyone planning

Antiviral treatments for flu are most effective when given within 48 hours of starting to feelill and are only availably by prescription. Older adults, young children and those who are pregnant or have certain underlying conditions are at risk for complications and should contact a healthcare provider to be assessed for the need for treatment as soon as possible.





Serving as master of ceremonies for the mobilization program was Jacob Considine. After the soldiers marched into the gym, he welcomed those in attendance to the program and honored both military and local dignitaries, including Litchfield Mayor Steve Dougherty, Litchfield Police Chief Kenny Ryker and Litchfield Fire Chief Adam Pennock. Considine also recognized veterans in attendance, asking them to stand and be recognized.

Students from Litchfield High School, under the direction of Ellis Henley, sang the National Anthem and the official orders of the mobilization were read.

Considine also provided a history of "The Blackhawk Battalion," which was originally organized as a militia company at the villages of Kaskaskia and Cahokia along the Mississippi River.

First to speak during the ceremony was Brig. General Lenny Williams, who thanked the crowd for their support of the soldiers, especially those veterans in attendance.

"You have passed the baton onto this group of soldiers," Williams said. "I promise you they're in good hands. Thanks for all you have done for our country and for passing the baton onto these soldiers."

Williams, who has deployed several times himself, said it can be especially chal-

lenging for the families left behind.

"Our soldiers are ready, but it's only because of the support structure you provide at home," he said. "It doesn't happen without the support of family. The entire weight of our organization, 10,000 soldiers strong, is behind you.'

Williams also thanked the soldiers for their unwavering service to the state and the nation. He added that only 2 percent of all Americans are currently on active duty in the military, with 6 percent

of all Americans as veterans. "You have already done so much, and we are grateful to

you," Williams said. In closing he share things with the soldiers. The first was to always do more than what is asked of them and seize the opportunity to achieve greatness. He also encouraged the officers and NCOs to be good leaders and finally, he asked the troops to take care of each other.

'You're trained, ready and professionals," he said. You're going to crush this mission.'

Next to speak was Captain Justin Asbury, who is the company commander. He thanked the families for their support and talked to the soldiers about the upcoming mission.

You're going to make some friendships that will last you a lifetime," he said.

Asbury added the soldiers would have a chance to learn and grow, as they build relationships with other partner

Plummer proposed developing the property if the city would front \$500,000 in development costs, but the city refused. Plummer also offered to sell the property to the city to allow them to put out the bid for development.

Hollo suggested that the proposal be sent back to the economic development committee so the city could pursue something more economically feasible.

Vazquez addressed some of the concerns Hollo brought up during the discussion on the project, saying that the money from the TIF district does not allow incentives for new construction which might be needed for other projects, which is why that money is being used for infrastructure.

Vazquez also believed that there would not be a cash flow issue with the long term development fund as there won't be as many heavy expenditures as there have been with the establishment of the industrial park and other projects. She also believed that the city will receive more than the \$750,000 budgeted from sales tax for the long term economic development fund.

Vazquez said that the project also differs from Eagle Ridge, where the city already owned the land and were selling lake lot leases. City Attorney Michael McGinley said that purchasing the property from the Schmidt Family in order to develop it would be a different and more complicated process.

Alderman Jake Fleming confirmed with Vazquez that the economic development committee approved the project unanimously. Vazquez said not everyone on the committee was present, but those who were voted for the project.

Alderman Ray Kellenberger asked what developers share of the project was. Matt Pfund from Jack Matthews Development said that they are responsible for 50 percent of the costs to develop the land plus all of the construction costs for

the 12 residential units that are required in the economic development agreement.

Pfund said that they don't expect to build every home on the 20 acres, which will feature 34 single-family lots and 12 triplex lots, and that local builders are welcome.

Earlier in the discussion, Pfund spoke about the project, which will feature three different components: the 36 townhomes/triplexes, the single-family homes that surround them and a section of lots surrounding a cul-de-sac. The slightly larger lots were done after a suggestion made by the planning commission.

He agreed with Hollo that the plan was aggressive, but added that they were excited for the development. Pfund said the big unknown is how quickly the initial 12 residential units are inhabited and how soon the other lots

Pfund said that each of the components, or sections of the components, could have it's own HOA (homeowners association), with different covenants and restrictions. He said what those restrictions are depends on the market.

Alderwoman Kassidy Paine, a real estate agent in Litchfield, said that Litchfield does have some HOA's currently, with the monthly fees covering things such as snow removal, roofing and siding replacement. Mc-Ginley added that the HOA restrictions allow property owners a way to solve issues privately.

In addition to the action pertaining to the new residential development, the council also approved a resolution for a facade grant for Niehaus Cycle sales for lighted awnings and an emergency roof grant for the property at 117 East Edwards Street. Matt Vaughn and Carol Sneed were also approved as appointees to the tourism advisory board.

In lake department business, the council approved the adoption of a colored flag lake level notification system. The system uses two seven-foot by three-foot flags at Marina 1 and 2, with green

meaning no restrictions, yellow restricting watercraft to under 20 miles per hour, red restricting watercraft to idle speeds and black meaning that the lake is closed to watercraft.

Lake Superintendent Heather Bell said that the system will help with situations like this past Memorial Day, when the area experienced record rain fall.

Alderman Fleming said that several citizens asked for a visual reference like the flags, with Bell adding that the status of the lakes would also be posted on social media.

Alderwoman Sara Zumwalt asked what the cost of the flags would be. Bell said the cost for two sets of flags is estimated to be less than

The council also approved the fees for the Lake Lou Yaeger Recreation Area and the lease agreements for the Lake Lou Yaeger Campground and Bicentennial campground. The changes in the fees can be viewed online with this article at www. the journal-news.net.

The city noted that even though there was a slight increase in camping rates, Litchfield is still well under priced compared to other local campgrounds.

They also noted new services/amenities/attractions to the Lake Lou Yaeger Recreation area, including an online camping reservation system with interactive maps, senior and military rates for beach admission, improved admission and concession areas at Milnot Beach, an expanded beach area, a toddler swim area, a handicap/wheelchair entrance to the beach/lake area, a shade structure on the beach, an enclosed sand volleyball area, a kayak rental station, renovated cabins, a fenced in boat storage area, an improved primitive camping area and a new playground and pavilion at the Bicentennial campground.

With no further business, the meeting adjourned at 7:04 p.m. The council will meet again on Thursday, Feb. 20, at 6:30 p.m.








DCFS Scholarship Applications Open

of Children and Family Services (DCFS) is currently accepting applications for the 2025 DCFS Scholarship Program. Through the program, a minimum of 53 academic scholarships will be awarded to current and former youth in care for the upcoming school year, with four awards reserved for the children of veterans and two awards presented to students pursuing degrees in social work in honor of Pamela Knight and Deidre Silas, two DCFS caseworkers who succumbed to injuries sustained in the ine of duty.

Scholarship recipients receive up to five consecutive years of tuition and academic fee waivers if they attend an Illinois public university or community college including a monthly grant of \$1,577 to offset other expenses and a medical card. In 2024, DCFS awarded scholarships to 334 college-bound youth, the most in the agency's history.

"It is my priority as governor to ensure that all Illinois students, including youth in DCFS care, have the resources they need to pursue higher education," said Governor J.B. Pritzker. "After awarding

The Illinois Department a record-breaking 334 DCFS scholarships to young leaders last year, I am thrilled to share that we are once again opening applications for 2025. I highly encourage all current and former youth in care to apply.'

Transitioning from high school to college can be a stressful time for any young person, and even more so for the youth in our care who have already worked so hard to overcome obstacles in their young lives," said Illinois DCFS Director Heidi E. Mueller. "These scholar-ships will give our youth some peace of mind knowing that they won't have to worry about how to pay for schol so they can concentrate on their education and pursuing their dreams."

The DCFS Scholarship Program is available to youth who have an open DCFS case, whose cases were closed through adoption or guardianship or who aged out of care at 18 or older.

"The DCFS Scholarship has been a significant support in my journey toward higher education," said Makaya, a 2024 scholarship recipient. It has alleviated the financial burden, allowing me time

to focus more on my studies and less on how to pay for them. It has also provided me with opportunities to engage in extracurricular activities and further my education without the constant stress of financial constraints."

Scholarship recipients are selected based on their scholastic record and aptitude, community and extracurricular activities, three letters of recommendatoin from non-relatives and a personal essav illustrating their purpose for higher education. Scholarships are awarded to students interested in pursuing education at trade schools, community colleges or traditional colleges or universities.



The boys would get the nightcap, as Litchfield looked to get the sweep of the Wildcats, with the Lady Panthers taking down their counterparts in the opener. The Litchfield boys didn't take it easy on their allies as they opened the contest with a 17-1 lead and cruised to a 68-37 victory.

The Mt. Olive and Litchfield school districts have co-op agreements in several sports at the middle school and high school levels, which has created some lasting friendships between students at the two schools.

With those friendships set to the side, Litchfield put the throttle down as soon as the ball game tipped off. The Panthers piled on 17 points in the opening quarter, as both Harrison Thomas and Brayden Ronco connected on six points apiece.

With a combined record of 202 wins and 64 losses this season, Braxton Kieffer, Vincent Moore, Tristan Staggs, Jayden Ellinger, Devin Hansel and Clayton Hauter have been among the Panthers' most consistent winners all season long and showed that again at the regional on Saturday.

Kieffer picked up his second straight regional, adding a 157-pound medal to his 144-pound one from his sophomore year. After beating Colby Madri of Auburn by fall in 36 seconds, Kieffer knocked off Jovonis Lunford of Sacred Heart-Griffin in the semifinals in a 10-1 major decision victory.

The regional championship match was a rematch of the semifinals of last weekend's Rich Lovellette Invitational, with a similar result. In that match, Kieffer defeated Vandalia's Parker Ray at the 5:37 mark, but the Litchfield junior needed a little less time on Saturday as he scored the pin with 13 seconds left in the second period.

The Litchfield/Vandalia match-up in the finals was a fairly common one as Vincent Moore and Tristan Staggs also drew Vandals in their championship matches.

Moore pinned Auburn's Noah Duncan and Shelbyville's Colin Wells

120 pounds in a total of one minute and 58 seconds, but ran into one of Vandalia's buzzsaws in the finals, defending 113-pound state champion Preston Waughtel, who transferred to Vandalia with his brother, two-time state champ and University of Wisconsin recruit Tyson Waughtel. Moore took Waughtel to the third round, but the Vandalia sophomore won the match by technical fall 19-4 at the 4:29 mark.

Tristan Staggs also finished second to a Vandal as Kaden Tidwell (fourth at state in 2024) secured the pin six seconds before the end of the first round. Staggs made it to the championship by beating Kyle Fay of Auburn by fall in 27 seconds and Mt. Zion's Keller Stocks in a 4-3 decision. Redskins Pick Up Win Over Hiltoppers

Hillsboro's boys junior varsity and varsity basketball teams suffered the same fates in the Nokomis High School gym when the team tangled Saturday night, Feb. 8; the Redskins 1-2-2 zone press defense proved difficult to solve as the junior varsity fell 61-29 and the varsity succumbed 59-49 in one of those "It wasn't as close as that" affairs.

The pattern seems always the same. Nokomis pressures the ball full-court, using the turnovers that creates to score enough points to slowly but inevitably pull away. This year an added element was to keep track of Hillsboro's leading scorer, Nathan Matoush; coaches on the bench were verbally telling the defense what Matoush's next move was likely to be based on his position on the floor; one suspects that's the result of modern technology providing game tapes to view.

That strategy worked well while the outcome of the game was in doubt; Matoush had three points at halftime with no field goals in the book, and The 'Skins were up 28-18 as 6'1" sophomore Connor Reynolds came off the bench to score nine points in the first sixteen minutes. 6'3" senior Drake Taylor added 8 as the host team slowly pulled ahead.

The only Topper field goals in the opening eight minutes came from Jackson Tuetken who canned two threes from his left corner; the Toppers committed only two turnovers in the first eight minutes, but the pressure defense took its toll in quarter two. Then Mark Mattson had the only Hillsboro field goals (3). Taylor, playing well during his team's Senior Night, had the first two field goals of the quarter, so the lead

The Toppers' fate seemed sealed; once Nokomis gains an eight point lead, they seldom lose, especially on their home court.

Matoush found his groove despite all the attention he draws these days, scoring six field goals and twenty points in the second half; fourteen came in the last quarter, when only he, Caleb Greenwood (4, including a trey) and Mattson, who also made a trey, would score. The final quarter was the only one in which Hillsboro outscored Nokomis, but the difference (21-19) had minimal effect in the final outcome.

Besides Taylor and Reynolds, Kannon Jonas was in double figures with 13; Ian Keller was effective defensively, as was Atticus Bertolino, who not only helped defend former teammate Matoush but also was a force on the boards as a rebounder. Jonas was seven of nine from the free throw line.

The effects of the press nee on Tuesday, Feb. 11. were even more evident in the preliminary game when the Brian Pesko coached squad built a 69-29 lead on a 23-2 first quarter edge. Two of Hillsboro's J.V. guards were held out of the game because of possible varsity participation. Big man (at 6'2") Eli Zaidi had Hillsboro's only points in the opening quarter and was high for the Toppers with 10; sophomore guard Elijah Patton made two treys to be second in the game summary with six points.

Nokomis had three (freshman Luke Eisenbarth with 14, junior Blain Goodwin with 13, and junior Glavin Himes with 11) to achieve double figures states.

Hillsboro will welcome the north Mac Panthers here tomorrow, Feb.11, for a triple header; the freshman game is set for a 5 p.m. tip. It's only the fifth home game of the 24-25 season.

Two Toppers Move On To Sectional

One veteran and one rookie earned their sectional spots for the Hillsboro High School wrestling team on Saturday, Feb. 8, while two other Toppers will make the trip to the Carterville Sectional as alternates following the IHSA Class 1A Litchfield Regional.

Senior Gaven Vollintine finished second at 144 pounds, while freshman Kohl Fuller was third at 106 pounds as both wrestlers advanced to next weekend's sectional in the south. The two Toppers will be joined by teammates Kaden Long and Mason Currie, who finished fourth at Litchfield and will be alternates for the next round of the postseason.

Vollintine entered the regional with 26 victories, matching his career best from last year, when he also qualified for sectionals. The Hillsboro senior upped his win total to 28 to get to the championship match as he pinned Cade Venrick of Auburn at the 3:04 mark, then outpointed Drayden Smith of Mt. Zion in a 12-5 decision. Vollintine had lost to both Venrick and Smith earlier this year, but avenged both of those losses at the regional.

In the championship match, Vollintine faced Vandalia's Keagan Turner, who picked up a win by fall with 58 seconds to go in the first period. The Vandals put 13 wrestlers in championship

matches on Saturday, with ten regional champions and three runners-up.

While Vollintine will be making his second trip to sectionals, Fuller will be making his first after taking third at 106 pounds in his freshman postseason debut.

After falling to Eli Hill of Auburn in his first match, Fuller defeated Bosco Hyde of Sacred Heart-Griffin by fall in 34 seconds to advance to the third place match. The Topper freshman needed just 58 seconds to dispatch Mt. Zion's Jackson Bough as he captured third and advanced to the next round of the postseason.

The wins over Hyde and Bough were the second of the season for Fuller against both opponents as he pinned Hyde in 90 seconds on Jan. 8, and did the same to Bough

at the 3:06 mark on Dec. 17. Long and Currie also made it to the third place match at Litchfield before ending their day in fourth. Long's only losses came against wrestlers who won their final matches of the day as he defeated Draven Jones of Litchfield by fall at 1:57, before falling to eventual champion Ryne Peavler of Shelbyville at the 1:45 mark. In the consolation semifinal, the Hillsboro senior picked up his 27th win of the season with a win by fall at the 4:48 mark over Destin Lathon of Sacred Heart-Griffin, but Waylon White of Pittsfield earned the final automatic qualifying spot at 165 pounds with a win by fall with 19 seconds to go in the second period.

Currie drew eventual regional runner-up Andre Townsend of Shelbyville in his opening match and lost by fall at the 1:29 mark, but rebounded with back-to-back wins over Josh Eyer of Sacred Heart-Griffin and Ayden Williams of Auburn to advance to the third place match. Currie had wrestled both Eyer and Williams before and had beaten Eyer by fall, but Saturday's 14-13 decision win over Williams avenged an earlier loss by fall against the Trojan heavyweight back on Jan. 23.

Currie met up with another familiar face in the third place match, Litchfield's Devin Hansel, although the two didn't meet up this season. Hansel's experience won out in the match as he pinned Currie at the 1:12 mark of

the first period. In addition to the sectional qualifiers and alternates, Landon Bandy, Briar Kuhl, Liam Kalar, Abraham Putnam, Westin Fenton, Gavin Shomaker, Seth Hubbart and Olan Lentz also wrestled at regionals.
