Ditch ties, work hard, have fun

Bob Draffin is new Sayville Rotary president

Bayport resident Bob Draffin's dad, Edward Draffin, was the Suffolk County director of probation and from there, he spread his help around. "As a public servant it exposes you to issues in the community," Draffin said of his dad. "He was president of the Suffolk County Police Association and numerous boards and was at a meeting almost every night while my mother, Mary, ran the household."

Seventeen years ago, when the 59.9-acre Bayport Aerodrome off Third Avenue was in danger of being developed, Draffin began following his dad's course. He sat in living rooms with others and formed the Bayport Civic Association, of which he is still president. The aerodrome was preserved.

His activism in that issue and others led to his Rotary involvement. He was installed as Rotary's new president on Monday.

"That was my first big championed cause and we succeeded," Draffin said of the aerodrome fight. It is owned by the Town of Islip and is the only remaining grass runway on Long Island, one of the few in the country. It is also home to the Bayport Aerodrome

Society, a living museum that includes 20 hangars with vintage planes, as well as pilots and aviation professionals who are happy to talk about them.

"We also had it placed on the National Register of Historic Places in 2008 and received FAA funding," Draffin said.

Bayport Civic Association vice president Joe Libertelli moved into Bayport 21 years ago. "He made me feel very welcome," Libertelli remembered of his initial meeting with Draffin. "He was brought up in Bayport and has a genuine love for not only our area, but he wants to do what's right for the communities surrounding it like Sayville, and he's the cheerleader for our local businesses and the residents.

"He's made it clear the civic isn't about him but what's right for the community, not a special interest."

But on to Rotary. "I was first asked to be a guest speaker when they were honoring community service people in 2016," Draffin said. "I dedicated my talk to its importance." Draffin noted he was sworn in as a member on St. Patrick's Day. (Nothing but enthusiastic, he wore a tux and carried a shillelagh when he marched in Bayport-Blue Point Chamber's St. Patrick's Day Parade as grand marshal.)

"I also know Rotarians as friends," he said.

Brendan McCurdy, a classmate who was two years ahead of Draffin at Hamilton College and Rotary president-elect, is one of them.

"I've known Bob since 1977," McCurdy said. "We were in the same dormitory and I noticed this guy was getting the *Suffolk County News* every week," he said. "I'm from Oakdale, I went over to him, and the rest is history."

Any funny anecdotes? Mum's the word, but McCurdy did add this: "He was always up for adventure."

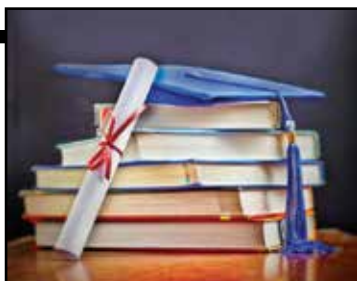
Draffin pointed to Rotary's impact locally; last month members pitched in to clean the memorial stones of war veterans at St. Ann's Cemetery and donned waders and plastic gloves as Creek Defenders as an example. "We did it at the Mill Pond recently, getting in the muck and pulling up garbage," he said. "We'll be officially adopting Bayport Beach as stewards."

On a macro level, "As an organization globally of 1.2 million members, we championed eradicating polio," he said.

Draffin is retiring as employee relations director in Suffolk County's Sheriff's Office after a 37-year

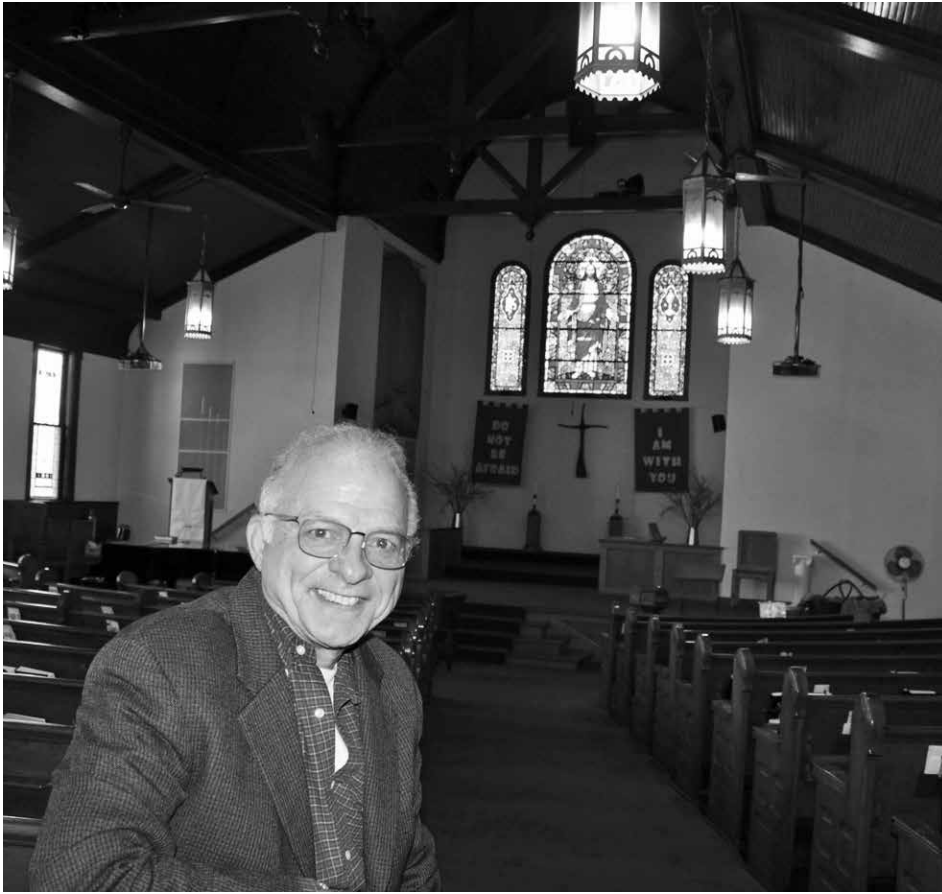

Open and affirming

Pastors discuss inclusive message

United Congregational Church of Sayville

SAYVILLE—Three flags fly in front of the United Congregational Church of Sayville: a POW, rainbow and American flag.

“One day, we’ll only need one flag,” said Sayville UCC pastor Ray Bagnuolo.

Bagnuolo discussed the UCC’s premise since 1957. “No matter where you are on your spiritual journey, you are welcome here.”

The church has openly embraced social issues, including securing 693 crosses and seven Star of David markers on its front lawn, a sober honoring of those who have died from random shootings.

In light of the upcoming 50th anniversary of the Stonewall Riots prompted by an aggressive police raid on a gay club for which New York City police commissioner James O’Neill issued a public apology last Thursday, and Patchogue’s Alive After Five Pride theme on June 27, Bagnuolo said their church isn’t offering a special program for the LGBTQ community because it has been a welcoming sanctuary already.

“The gay community is integrated in all our society,” he explained. “They occupy friends, family members and we are marginalized. The idea is not to separate ourselves but to be inclusive in our faith community. We want to make sure our congregation is open and affirming.”

Flying the Prisoner of War flag is “another example of those who served and sacrificed who we don’t want to forget,” Bagnuolo said.

Bagnuolo, a gay pastor, has headed Sayville UCC since January 2017.

“It’s a church where people really love each other and are often stunned at wrong-minded incidents of any kind and particularly against LGBTQ people. We’re a faith-based community who believe God is love and love is God.”

There are approximately 100 congregants. Besides Sunday services with a coffee gathering afterwards and a Talk Back for those who

want to discuss the sermon or any issue (“we have 20 people regularly for that,” he said), there are two classes of Bible Jam, where attendees discuss the origins of Christianity. Knitted prayer shawls, made by congregants in different hues who pray over them during their creation, are given out to those injured, or just going through a tough time.

“We make a food collection every week for the Sayville Food Pantry, we host fundraisers for Sharing A Meal and provide our hall for meals from Monday to Thursday,” Bagnuolo said.

“We have a connection with Cherry Grove and participate in Bless the Animals and share services there with the Episcopal and Catholic Church. I offer my services at weddings and we have a Congregational Day there. We invite members of the community to head over there for lunch and Sayville Ferry provides us with a ferry on Easter Sunday for a sunrise service and we host a Victorian tea. We also created 18Vote.org, a nonpartisan website, to get 18-year-olds registered.” Bagnuolo added that high school students who helped with the website received community service credit. “A faith community is not just one event,” he said.

Bagnuolo explained that the congregation’s inclusion began in the 1990s with pastor John A. Jeter, who was identified as a gay man. “It caused a grand discussion,” he said. “When you do this kind of activism you frequently are the curriculum. You receive the people who are supportive and those who are not so. There were third party folks who would do proof texting, taking a line out of Scripture to fit their own purpose.” But his church weathered the storm, including working with Suffolk police who caught the perp who stole the rainbow flag seven times.

“We are committed to community building and activism. You don’t have to change everybody’s hearts and minds to be successful,” he said. ■

Congregational Church of Patchogue

PATCHOGUE—Pastor Dwight Wolter noted that besides ordaining its first openly gay pastor in 1972, the United Congregational Church of Christ has been ordaining women since the late 1800s. He said many UCC pastors are LGBTQ.

“We have performed many same-gender marriages and baptisms,” he said. “Our communion table leadership is open to people regardless.”

No formal program is planned at the church for the 50th anniversary of the Stonewall uprising that activated gays to demand rights (New York City police commissioner James O’Neill issued a public apology last Thursday, saying “the actions taken by the N.Y.P.D. were wrong”), Wolter said, but the Congregational Church is considering opening up the sanctuary on the night of Patchogue’s Alive After Five Pride night.

Jacqueline Routh, New York State Sen. Monica Martinez’s chief of staff, is chairing Patchogue’s Alive After Five event. “Coming into this role, I always wanted to be a part of this,” Routh said. “I struggled with my own sexuality in high school and I thought it was time to get involved. I want to help transform this event. Let’s have it come back to the community and social recognition.”

Wolter pointed out that even 47 years after ordaining an openly gay minister, there are people who have issues and questions. “There are churches that are splintered on this issue,” he said. “President Donald Trump has denied military status to transgenders, so we see it in our culture. Isn’t it amazing, but not surprising, that in 2019 we are still talking about whether an LGBTQ is a full human being entitled to equal rights and dignity in the U.S. and the Christian Church?”

Wolter has headed his church for 13 years, hosting many social programs as well as spirituality concerts, which raises funds for their food pantry and soup kitchen, and also too as a way to get people into membership and/or attend a reflective place. The church is also known for Workers Without Wheels program, which has given away over 100 new or used bikes for those who need them as main sources of transportation.

“We’ve had a lesbian couple with twin daughters who went through confirmation class here,” he said. “They weren’t getting discrimination from their school but from other churches. When they came here, people didn’t ask. There was no issue.”

Wolter is a member of the Alive After Five Committee.

There can be personal consequences to taking stands, he emphasized.

“Pastors lose groups or wealthy members,” he said candidly. “You can be unemployed the next day with a vote. But it’s especially important for citizens and church leaders to pick up the cross for people not like you, because it’s the right thing to do. When you take up each others’ issues, that’s when you get change.” ■

Suffolk prepares for early voting

New York was previously one of 12 states that didn't allow early voting

SUFFOLK COUNTY—A list of locations within the county have been designated for early voting in the upcoming general election. One of them is the Islip Town Hall Annex, located at 401 Main Street in Islip.

Polls will be open on Oct. 26 and 27 from 10 a.m. to 3 p.m.; Oct. 28 from 7 a.m. to 3 p.m.; Oct. 29 and Nov. 1 from 12 to 8 p.m.; Oct. 30 and 31 from 8 a.m. to 4 p.m.; and Nov. 2 and 3 from 10 a.m. to 3 p.m.

Early voting will not be available for the June 25 primary this year.

Earlier this year, state lawmakers approved a series of reforms intended to make it easier for residents to vote. One of the measures requires that officials establish 10 days of early voting that con-

cludes two days prior to the election and includes two weekends. Another closed the LLC loophole, a move that looks to limit corporations' ability to open limited liability companies and make nearly unlimited political campaign contributions.

"At a time when the federal government is doing everything it can to disenfranchise voters, we are taking action to make it easier for New Yorkers to participate in the democratic process and crack down on corporate influences in our election," Gov. Andrew Cuomo wrote in a statement earlier this year.

The bills easily passed both chambers with bipartisan support. But the move still drew some criticism, mostly from Republicans, who had concerns about the cost of manning polling stations for

the 10 additional days and the potential for voter fraud.

Supporters, on the other hand, say early voting will increase voter turnout. New York ranked among the worst 10 states, in regards to turnout, during both the 2016 and 2018 elections. These numbers, according to reports, continued a longstanding trend of lower-than-average voter participation within the state.

The reforms also require that officials automatically update voter registrations for anyone who moves, and beginning in 2020, allows young adults to preregister to vote when they are 16 or 17 years old. Younger voters' registration will be marked as pending until their 18th birthday when they will be able to vote.

Suffolk County Legislature presiding officer DuWayne Gregory (D-Wyandanch)

said reforms like these are "vital" in helping more individuals become involved in the election process.

"For far too long, people have been disenfranchised by limiting voting to one day per year," Gregory wrote in a statement. "The more opportunity people have to participate, the more they will. Allowing early voting and extending the number of days and times to vote will address low voter turnout and bring more people into the process."

Gregory's office points out that as part of the package of reforms, state and federal primaries must be scheduled on the same day. Up until last year, New York was the only state in the country to hold federal and state primaries on different days and one of the only 12 states without early voting. ■

York State Senate last month.

If signed by Gov. Andrew Cuomo, the bill would amend state Civil Practice Law and Rules to help to ensure that polluters, not ratepayers, pay for the costs of treating groundwater contaminants. In the past, lawsuits brought by water suppliers against polluters have been dismissed due to nebulous language concerning the timing of contamination.

The Thiele/Gaughran bill clarifies that the statute of limitations begins three years from the latest of detection of a contaminant (1) in excess of any notification level, action level, maximum contaminant level, or maximum contaminant level goal, (2) the last wrongful act by anyone whose conduct contributed to the presence of the contaminant, (3) the date the contaminants is last detected in excess of any notification level, action level, maximum contaminant level, or maximum contaminant level for the contaminant.

"If a company pollutes Long Island's greatest natural resource, its drinking water supply, it should be responsible for the cost of cleanup, not the ratepayers," said SCWA chairman Patrick Haplin. "This bill will go a long way to ensure that happens, and so we strongly encourage Gov. Cuomo to sign it into law."

"The state must be equipped with every tool and resource necessary to address New York's current water quality crisis," said Thiele, the sponsor of the bill in the Assembly. "The bill approved by the Assembly unanimously [last week], if signed into law, will hold polluters financially accountable for endangering our public drinking water supply with emerging contaminants."

"Long Island's drinking water supply is our greatest natural resource," Gaughran said. "When deep-pocketed companies pollute our water and contaminate our drinking water, they should be responsible for the cost of cleaning it up, not ratepayers. Safe, clean drinking water is a human right and we must treat it as such."

When deer news breaks

As a year-round resident of Fire Island for over 22 years now, I've experienced much as a result.

I stood in the marshy grass of Saltaire at 6 a.m. in the morning back in 1996, photographing a man from the U.S. Humane Society delivering birth control blow darts to deer as I was preparing an exhibit for the Ocean Beach Historical Society about the immunocontraception. Longtime Saltaire resident Marija Baqaj agreed to let me observe. She served me and that fellow with the blowgun rugelach as we sat under the gazebo on coffee break watching the sunrise.

Eleven years later, in 2007, I got to ride shotgun through Seaview in a truck with a Fire Island National Seashore biologist and a U.S. Department of Interior sharpshooter, on a news assignment while freelancing for this publication. FINS had taken over operation of the immunocontraception by then, and I watched them load pink vials of PZP contraceptive into air pistols. They gave me a snappy National Park Service day-glow vest to wear on this little adventure, but sadly I was asked to return it at the end of our ride. I won my first journalism award as a result of that article.

In the summer of 2015, FINS invited me to lecture at the Patchogue ferry terminal about the two books I authored about Fire Island, as part of their 50th anniversary celebrations. I had researched both titles at their library, and was a regular fixture there for a while. But things had taken a 180-degree turn since my Seaview truck ride eight years earlier. A draft document called "White-Tailed Deer Management Plan" was being considered by the Federal Register that advocated slaughter over birth control. I did not want to politicize the lecture and embarrass my hosts, but felt it would be dishonest not to bring the subject up as a talking point in my presentation. As former superintendent Chris Soller sat in the audience with pursed lips, I warned this plan could become a public relations disaster if it stayed on this path. I added that this was not a "them and us" situation, and with respectful discourse and cooperation we could find better solutions together. I was never invited back to speak there again.

The deer are not my pets, but I see them every day and know many on my street by sight, as some have known me. I also do not socialize much with FINS staff outside of the scope of my work, but we, too, know each other often by first name, and greet each other warmly. Not unlike the deer, they, too, are my neighbors. And herein lies my disappointment with how things have been handled.

I am the editor of another publication now, and on a snowy day last January I received a call that was not entirely unexpected, but made my heart sink. The dreaded deer management plan had been the law of the land since 2016, but it had only existed as an unfunded mandate. Now, a new superintendent barely three months into the job was saying funding had been located, and with the litigation now over, things were going to happen fast. But the litigation was not over... so I started making calls to find out what was going on.

As a result, an article was penned and published shortly after the federal government shutdown had ended. I was proud we not only scooped other publications with our off-season skeleton crew, but we did not parrot the euphemisms or rhetoric of the press release FINS distributed 12 days later announcing "deer removal operations" at William Floyd Estate, with assistance of the U.S. Department of Agriculture; and more importantly, the alarm had been

sounded — covert operations now were unveiled.

Through other publications, I observed as the Animal Welfare Institute of Washington, D.C. and wildlife preserves petitioned for a temporary restraining order to halt the Feb. 20 deer kill, arguing this action would breach open and pending litigation that the two nonprofit organizations filed against FINS in 2017. U.S. District Court Judge Sandra Feuerstein does not have the most sympathetic track record on this subject, having dismissed a similar lawsuit filed by Friends of Animals in Darien, Conn., in August of 2018. However, surprisingly she agreed to postpone the William Floyd Estate cull pending a hearing on the matter. On Feb. 22, Feuerstein ruled that the stay would remain in place until she had time to weigh the merits of motions submitted by prosecution and defense.

Two days later, news broke that the U.S. Department of Agriculture killed almost four dozen deer in five Long Island state parks; 21 of them at the Robert Moses State Park/ Fire Island National Seashore boundary. An email I received by NYS Parks, Recreation and Historic Preservation earlier that month confirmed they, too, had contracted with the U.S. Department of Agriculture for a deer culling, but stated they did not know when sharpshooting would take place due to delays by the government shutdown. A representative at the Animal Welfare Institute explained to me that such culls on public land require a published public notice, as well as posted notices conspicuously posted in the parks themselves. Did this happen? I've seen no evidence of that. Personally, I think we were blindsided by a well-orchestrated bait-and-switch between the two agencies.

Feuerstein ruled to dissolve the temporary restraining order, allowing the William Floyd deer culling to proceed as of Feb. 26, 2019. Over the next month, two of the more prominent and likable faces at FINS quietly left their jobs. Former assistant superintendent Kelly Fellner transferred to another NPS facility in Springfield, Mass. Longtime public relations Officer Elizabeth Rogers left NPS altogether to join the private sector. Changes in personnel often happen when there is a new boss at the helm; still, the timing is curious.

In April, FINS circulated another press release announcing 500 pounds of deer meat from the William Floyd deer cull had been donated to food banks, and announced further plans to continue using sharpshooters in locations like the Wilderness area, and possibly FINS tracts between Fire Island communities in the year 2020. What their statement did not mention was that the 25 deer they killed at William Floyd Estate in March was far below their target estimate of 80 animals. Many opponents of the deer culling long argued that the population data used to justify this action in FINS was either out of date or exaggerated. The low kill numbers at William Floyd would seem to support this premise.

Now summer is here, and FINS and would like to tout their nature tours, post Facebook pictures of sand and seashells on the beach, and presume an air of normalcy that does not exist right now because a public trust has been violated. Scientific findings have been cherry-picked to match agendas. Propaganda has been rebranded as public education. Doublespeak and subterfuge has appropriated leadership — a sorry reflection of what we see on a larger scale in Washington, D.C. these days.

Wildlife management is not about conquering of the wildlife or its local inhabitants, but of coexistence with them. Fire Island National Seashore has failed across the board on their most primary of tenets. ■

Play Review

A show of laughs for Broadway lovers

'Forbidden Broadway' brings out the absurd and ironic themes in classics

The stage at the Gateway Playhouse was opened up to parody and satire of classic shows and new hits in "Forbidden Broadway," a long-running Off-Broadway musical. In the song-heavy show with a small cast, the audience is taken through the many hits and stars of Broadway with a new twist.

"Forbidden Broadway" is directed by original writer and creator Gerard Allesandrini. He is the recipient of an Obie Award, an Outer Critics Circle Award, two Lucille Lortel Awards, a Drama League Lifetime Achievement Award, three Drama Desk Awards and a Tony Honor for Excellence in Theatre. In 1982, he created "Forbidden Broadway," which has spawned 15 editions, eight cast albums and a 27-year run in New York.

GENERAL THOUGHTS

The talent present in the cast of "Forbidden Broadway" is obvious from the first song. Stars Bill Coyne and Mia Gentile were the standout performers, with a comedic sense that was essential for this show. Coyne can switch demeanor on a dime and has the ability to transform into each role as the show progresses. His parody of Hugh Jackman was a highlight of the show. Gentile is a master of the voice, with a powerful belt and strength in different accents. She was even able to transform into Frankie Valli for a rendition "honoring" the Jersey Boys.

It's a personal experience. Some may find "Hamilton" jokes funnier than "Mary Poppins" jokes. Some may not have an idea of who Evan Hansen is. Throughout the show, different areas of the audience connected with different scenes, which makes each show a unique experience.

WHY YOU SHOULD SEE IT

The show is filled with funny moments. The cast is each very talented with impressions, turning into iconic characters like Elsa from "Frozen" and cast members from "Les Misérables." The

cast was really able to change the mood with each new song, often very different than the one before. For me, the biggest star of the night was musical director and pianist Robert Felstein, who played nearly nonstop for the entire show. For some simply great music, Felstein's performance is a must-see.

There were moments of commentary that were funny and appropriate for the show, like how puppets are sure to please the crowd or how every movie is becoming a musical. The cast also did a great job using little props to bring across the feeling of each new show. Part of the win for this parody is a cast member dressing up in gray towels with an accordion tubenose to portray an elephant for "The Lion King."

WHY YOU SHOULDN'T

The caveat that comes with enjoying this show's full potential is the breadth of Broadway or show-biz knowledge the viewer has. For example, I was awkwardly looking around during the "Cameron Mackintosh" to see what I was missing, since I had never heard of the producer without the help of Google (my apologies to Sir Mackintosh). Or if you haven't seen "Dear Evan Hansen," you may not be in on the running jokes of the show. Younger audiences probably don't know who Ethel Merman or Bernadette Peters are.

The show could have capitalized more on parody opportunities. Often times the best comedy isn't the joke that is flat-out said, but the one that leads you to the punch line on your own. There could have been more satire based in social commentary, as the times it was used seemed to be the biggest hits with the audience.

"Forbidden Broadway" is playing at the Gateway from now through June 22. Ticket prices range from \$49-\$89 per show. 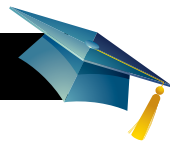
