



# Rental and Utility Assistance for Eligible Applicants residing in the Town of Islip impacted by the COVID-19 Pandemic

This program is for tenants/renters who live within the Town of Islip and have been financially impacted by the pandemic. Grant funds are available for rent and utility arrears. If eligible, funds will be paid directly to the landlord or utility company.

Both the tenant and landlord must apply.

#### **Eligibility Requirements:**

- · Town of Islip Resident
- One or more adults in the household must have qualified for unemployment benefits, has experienced a reduction in income, incurred significant costs, or experienced other financial hardship directly due to the COVID-19 which can be documented
- One or more adults in the household must be able to demonstrate a risk of experiencing homelessness or housing instability such as past due rent or utility notice, eviction notice or threat of eviction.
- · Must be able to provide a fully executed rental lease or agreement where the lease is in the Applicant's name and the Applicant is responsible for monthly rent payments
- · Household income must fall at or below these brackets:



Last week's roundup of some of the local historical books I have read had a great response, so I wanted to highlight a few more that have caught my attention. Long Island and the New York region has such great local history that is fascinating to learn more about and explore.

#### "A World Unto Itself: The **Remarkable History of** Plum Island, New York"

By Ruth Ann Bramson, Geoffrey K. Fleming and Amy Kasuga Folk

I attended a lecture about this book that details the history of one of the most speculated and talked about areas on Long Island. This book goes into the facts of Plum Island and its fascinating




history. I really enjoyed learning about the island during wartime and how it once had a future as a resort destination that did not pan out.

#### "The Rain Drinkers"

By G. Finan

"The Rain Drinkers" is a novel that takes place in Bay Shore at the beginning of the 20th century. It is a coming-of-age story written by an



author from Bay Shore who expertly weaves in historical elements of the town. It's a great read for those who love local historical fiction.

#### "Lost Mohawk Valley"

By Bob Cudmore

This book does not detail local history on Long Island, but rather the history of the Mohawk Valley in upstate New York. I enjoy learning more about the history of a place I do not know much about. I am also fascinated to learn more about communities that revolve around one singular industry, as the Mohawk Valley revolved around old mill towns and carpet making. I thoroughly enjoyed reading about life as a worker in these factories, from the grind and dangers of the factories to the activities that happened once workers clocked out. Another great section details famous people and their ties to the Mohawk Valley, such as John Philip Sousa, Ed Sullivan, Teddy Roosevelt and Mike Tyson.

#### "The Massapequas: Two **Thousand Years of History**"

By George Kirchman

An aspect of this book that I really liked was how Kirchman went all the way back to when Native Americans lived in the Massapequas and provided a more full history of the area. Many local history books begin their timelines in the 18th or 19th centuries, so it was nice to read a deeper account of local history. I also really enjoyed reading about the founding families of the Massapequas who had great generational wealth. Rosalie Jones was my favorite. She was a member of the suffragette movement and walked the 170 miles to Albany in December of 1912 as part of a march. ■





#### Preventing the summer brain drain

Summer is here, and while we are all focused on enjoying vacations and time spent at the beach or pool, it's important to also think about ways to encourage students to continue reading.

Research shows that making reading a part of a child's summer routine allows them to better retain knowledge learned during the previous school year and continue to grow their reading skills for the years to come. A University of Tennessee study found that children who do not participate in summer reading lose about two months of reading development compared to those who do.

By encouraging our children to read this summer, parents can help them avoid what is known as the "summer slide," which refers to the loss of knowledge students gain during school while they are out for summer recess and move beyond their current reading lev-

Reading is also fun and opens for our children entirely new worlds of information, expands their knowledge, encourages curiosity, and creates lifelong study, learning, and social habits that will pay benefits for years to come.

How can you encourage your student to read this summer?

Once again, I am pleased to be teaming with schools, the New York State Library and local libraries to sponsor the New York State Senate Summer Reading Program. This year's theme, "Oceans of Possibilities," invites students to dive into books on, under, and about the exciting world of water and nature. What better topic when the days are getting longer and hotter? Oh, the

things they'll learn!

Students who participate will record titles of books they've read on a special website and receive an official certificate when they've completed the pro-

Of course, your local library is an excellent source of books and other materials to keep minds young and older engaged. Consider checking out a book along with your child to hone your own summer reading skills.

# Friends of Connetquot receives \$41,000 matching grant

### Educational interpretive center to be built at the hatchery

The Friends of Connetquot State Park Preserve was awarded a \$41,000 match-

ing grant from the Environmental Protection Fund's Park and Trail Partnership grants program. The

grant will be used to create an educational interpretive center at the preserve's historic hatchery.

According to a press release from Friends of Connetquot, the group will have to raise an additional \$8,250 in matching funds for a total of \$49,250. The grant is one of 27 awards totaling \$900,000 for organizations "dedicated to the stewardship and promotion of New York's state parks and historic sites, trails and public lands.'

The new interpretive center will help to educate school groups and the public about the trout hatchery with hands-on dioramas and visuals depicting the life cycle of trout. The center will also educate guests on native brook trout propagation, fly fishing, fly tying, entomology, freshwater wetlands, hydrology, resiliency, climate change, natural sciences and invasive species. The interpretive center will overlook the hatchery troughs, where visitors can see fingerlings (small, young trout).

The trout hatchery at Connetquot State Park Preserve dates back to when the South Side Sportsmen's Club still owned the property and established hatcheries for the propagation of trout. The first hatchery known as the Mill Preserves was established in 1871 along the west side of the river. In 1875, the East Brook Preserves was constructed, but the site was abandoned in 1899 and operations were consolidated at the location of today's hatchery. Two species of trout can be found at the hatchery. Brook trout is the official fish of New York State and is native to the streams of the Northeast. Rainbow trout come from the West Coast and were first brought over in 1882. In addition to Connetquot State Park Preserve, trout from the hatchery



are also used to stock the Nissequogue River at Caleb Smith State Park Preserve, Belmont State Park for the Belmont Lake Spring Freshwater Fishing Clinic, and the Hempstead Lake State Park Fall Fishing Festival.

The Park and Trail Partnership Grants are administered by Parks & Trails New York, a statewide nonprofit organization, in partnership with the NYS Office of Parks, Recreation, and Historic Preser-

The Friends of Connetquot is a nonprofit organization that works to preserve the history of the Connetquot State Park Preserve. President Janet Soley wrote the grant for the interpretive center and has written other grants that have helped the organization receive funding for a new roof in a historic room. 

Esteemed historian and librarians learn how to teach about new federal holiday

# **BOOK REVIEW**

### 'Fever Spores: The Queer Reclamation of William S. Burroughs'

William S. Burroughs is a complicated icon. A literary trailblazer who killed his wife. A revolutionary of the beat writers who came from a wealthy family. The new book "Fever Spores: The Queer Reclamation of William S. Burroughs," tackles all the facets of Burroughs through a queer lens. Each chapter tells a different story or gives a literary take on the man that many both idolize and revile. Anyone with a love of literature and especially literary criticism will gobble this book up.

I personally really enjoyed the chapters of writers revisiting Burroughs for their submission. In his chapter, "The Wild Boys," Paul Russell details how "Wild Boys" was the first queer text he ever read as a young man. He then read the book at other points in his life and gained different things from the text each time. I loved reading about his latest read of the novel for this anthology. It is not easy to revisit a work that, even in some small way, shaped who you are as a young person and look at it with a critical eye. But at the same time, it can be extremely gratifying. We see why the book originally piqued our interest and also its "faults." (But are they really faults if we learn from them and acknowledge them?) Russell notes that 'the satire still sings," but "the misogyny is persistent and troubling." He skimmed certain parts, yet loved certain "wonderfully haunting phrases." Russell reminds us that to revisit a book is a way to revisit a part of yourself.

The chapter "The Beats: Pictures of a Legend" by Edmund White was one that I found particularly interesting. I really loved White's observation that Burroughs and his friends "were convinced they represented something new and monumental in literary history." The idea of "artistic destiny" may seem pretentious, but it is also fascinating—to be so sure of you and your peers. I feel like I myself could learn something from that level of confidence. I also loved the quote from Allen Ginsberg that White used about how the beat writers mythologized each other's characters and how it worked to their benefit.

You have a small group of friends and you declare them all to be geniuses and you laud all their work and ascribe them sweet and stormy qualities worthy of the Greek gods," Ginsberg said.
"What you're selling is not just your writing, but your personal legends.'

Whether they saw it that way or not, it was a genius stroke of marketing, whether for themselves or their peers.

Like I'm sure so many will, I thoroughly enjoyed the chapter that was an interview with Fran Lebowitz. "He Invented Something: An Interview with Fran Lebowitz" by Brian Alessandro is an entertaining read. She notes that while Burroughs's work was not "her cup of tea," she understood what he did. Lebowitz was the first person in the anthology to acknowledge Burroughs's degree of privilege.

Burroughs was from a rich family, so that makes a completely different kind of person," Lebowitz said. "And even though he was gay, he was a man, and he was white, and he was rich. These things are incredibly important to forming people's characters—more than their character, their personality. He grew up among the ruling class."

Lebowitz was not indicting Bur-

roughs, but merely stating facts. Her conversation with Alessandro is a highlight of the anthology.

Another highlight is the chapter "The Gift of the Tortured Specter" by Sam Desmond. Desmond writes about Joan Vollmer, Burroughs's wife who died in a William Tell trick gone wrong. Desmond describes how as a young woman, she was drawn to the muses, the women attached to great men. Some of Desmond's lines are so simultaneously poignant and beautiful, I feel as though they need to be jotted down in a notebook of quotes that make you feel.

"I vowed I'd marry a great man, but in making my fantasy realistic, I thought that meant I'd have to sacrifice marrying a good man," Desmond writes.

'Muses, especially to men, often

remain on a pedestal because they do not tell their own tales and have to wait for someone else to discover their own innate talents separate from inspiring a grand man.'

In closing her chapter about Vollmer, Desmond gives my favorite quote.

'She still cannot escape the male gaze that pigeonholes women to nurturing origin points for men's accomplishments.

"Fever Spores" was co-edited by Brian Alessandro and Tom Cardamone and published by Rebel Satori Press. ■

there is much more behind the day than that. We wanted to highlight the social and historical importance of the day, so we sought out a speaker who is a pioneer of getting Juneteenth recognized.

Last year's topic was literacy during the pandemic, specifically tutors of different volunteer organizations who lost contact with students after switching to a digital model.

MOSAIC highlighted 10 online resources for tutors to utilize that could combat the digital learning curve that had mired their progress.

With libraries at the forefront of educating communities, MOSAIC felt that it was of paramount importance to address Juneteenth with authentic voices

'We really looked into our circles to find someone instrumental in the process and found that in Dr. Georgette Grier-Key," said Gagliardi of the keynote speaker.

"We as librarians have to address and accommodate different level of readers: children, teens, and adults," said Michelle Athanas, a librarian at Northport/East Northport Library, adding, "we had people come in [to the library] and ask about Juneteenth, so we put up a display for the three levels of readers with books authored [by] authentic voices.

Asked about how to address the diversity level of a particular library's patronage, Sally Stieglitz, an outreach coordinator for the Long Island Library Resources Council, said, "In our profession, we're taught about windows and mirrors—Juneteenth literature can be mirrors our patrons see themselves reflected in, or for new people, they have a window into that world. It's very grass-





roots."

As the keynote speaker, Dr. Grier-Key is the principal investigator and design committee chair of the Pyrrhus Concer Action Committee.

In this current role as design chair, her task consists of coordination of the design team and government liaison between the nonprofit and profit sectors.

Dr. Grier- Key is a museum professional, preservationist, and historian with expertise in construction that brings a unique perspective to this project. As a founding member and lead organizer of the Pyrrhus Concer Action Committee, her continued work is leading to the rebuilding of the formerly enslaved Pyrrhus Concer's homestead in the heart of Southampton's village. She continues to work on preserving historic structures in Sag Harbor, Southampton Township and East Hampton Township. Dr. Gri-

er-Key has been a diversity fellow with the National Trust for Historic Preser-

Dr. Grier-Key regularly contributes commentary to media outlets such as Newsday, Sag Harbor Express, Southampton Press, 27 East, Long Island Advance, East Hampton Star, Long Island Pulse, CBS New York and News 12; delivers lectures at CUNY Graduate Center, LIU Brooklyn, Hofstra University, and Suffolk County Community College; publishes her research in the Long Island History Journal and the Suffolk County Historical Society Register: and serves on the Black History Commission of the Town of Brookhaven, Town of Brookhaven's Reverend Dr. Martin Luther King Jr. Day Committee.

During her presentation, she summarized the history behind Juneteenth, which she called the "period on the Emancipation Proclamation," as it was codified two years after the executive order to free slaves in rebelling states.

The common theme of Dr. Grier-Key's message was that Juneteenth was not meant to be a holiday for solely, or separately, the Black community in the United States, but "part of American history."

Extremely disappointed in the assumption that July 4, or Independence Day, is meant for only a certain segment of the population, Dr. Grier-Key reminded the audience that the first casualty of the Revolutionary War was a mixed-Black man and that both Independence Day and Juneteenth were part of the African American experience.

Dr. Grier-Key recalled the Niagara Movement and the founding principles of the NAACP and said, "We were born here; there's nowhere we need to go. The American flag is a part of our history,

With a long line of veterans in her family, Dr. Grier-Key spoke of her deep patriotism and honor of service with her father and uncles.

Explaining the Juneteenth flag, Dr. Grier-Key informed the audience that the colors of the American flag (i.e. red, white, and blue) were preserved for the Juneteenth iteration to show unity and lineage. The star was to symbolize the Lone Star state, the territory in which the general orders were sent to free the last of the slaves. The curve of the Congress between red and blue was for new horizons.

'Juneteenth is not a Black holiday," said Dr. Grier-Key towards the end of her presentation, "It's an American cel-






