The Fall Fest is this weekend

The Greater Patchogue Chamber of Commerce will be hosting their Fall Fest on Main Street on Saturday, Oct. 15, from 11 a.m. to 5 p.m.

PATCHOGUE VILLAGE will be face and pumpkin painting, a petting zoo and music, as well as a self-led costume parade down Main Street at 1 p.m.

The event will again feature its famous chili and chowder contest. About 20 entries are expected. Tickets will be on sale the day of the event for \$20 per group. Chowder tasting will start at noon to 3 p.m. and chili from 3 to 5 p.m. Winners will be announced at a later date.

New this year, there will be expanded live music, including the country band and now the local blue grass band, Mother Pluckers. The Patchogue Theatre for the Performing Arts will also be selling tickets to dueling piano players outside the theater, and Birdies will be hosting a corn-hole tournament. Fees will apply to teams that sign up at the Patchogue Chamber's website. The train station farmer's market will also be hosting vendors on South Ocean Avenue as part of the day.

"We are really excited to add these new features. The Fall Fest has grown to become one of our most popular annual events," chamber executive director David Kennedy, said also noting there are currently sponsorship opportunities available.

CHILI AND CHOWDER CONTEST

Temple Beth-El welcomes world traveler rabbi

Ilan Pardo named leader as his religious journey comes full circle

Rabbi Ilan Pardo's spiritual life and journey of self-discovery has come full circle, as he returns to Patchogue after

PATCHOGUE VILLAGE serving in a variety of educational and congregational leadership roles in Virginia synagogues throughout the past two decades. Most recently, Rabbi Pardo officiated as the spiritual leader at Congregation Sons of Israel in Chambersburg, Pa. He recently joined Temple Beth-El, located at 45 Oak Street in Patchogue, in September.

This conservative, egalitarian Jewish congregation has been in the community for more than a century. The temple offers religious services, Hebrew school for children, and educational programs for adults, a youth group, a Sisterhood, a Men's Club, one-on-one religious counseling, community activities, diversity outreach, and much more. The temple upholds the traditions of its strong faith, while also staying open to the challenges and changes of today's modern world.

Originally from Israel, Rabbi Pardo has lived in several continents around the world, due to his father's interna-

tional work posts, including residing in Africa, Asia, and Europe. He has traveled extensively and is fluent in several languages. This global life experience has enabled him to connect with virtually anyone regardless of their background and has given him a broad understanding of the world in all its diversity. The well-traveled spiritual mentor has four children, Andrew, Alberto, and Nadia, who are all adults, along with his youngest daughter, Rebecca who recently had her bat mitzvah. The well-rounded Rabbi, who is also a business owner, recently moved to Patchogue Village with his youngest child and his wife, Neia.

"Growing up, my family practiced Judaism in a Sephardic 'traditional' way. We had Shabbat evening dinners, Shabbat lunches, and celebrated the holidays," explained Pardo of his family life in Israel, which was "culturally Jewish" but not overly religious. "I was striving to connect with a Jewish community and found Temple Beth-El of Patchogue. It was my first time in a conservative synagogue, and it is here that I was introduced to the concept of conservative Judaism. I felt that it fit me perfectly well."

When the rabbi position opened at Temple Beth-El, it was a serendipitous occurrence.

"Following all my work experiences in different synagogues, I could not think of a better place to become the rabbi of," he said. "I am honored and humbled to be

chosen as the next rabbi."

Both in the synagogue, and in the community, Rabbi Pardo is a wonderful new addition to the community and is committed to outreach and inclusion. His warm presence and welcoming, down-to-earth demeanor lend itself to religious services that are enthusiastic, engaging, and inviting to both longtime members of the temple, as well as to those who are new to or returning to religious services. His teachings are designed to engage a wide variety of members of the Jewish community who hail from many backgrounds and traditions. In addition, Pardo is passionate about Judaism and Jewish education for children and adults and believes strongly that building a solid Hebrew-language curriculum is a crucial component for comprehensive understanding regarding religion and heritage.

Pardo is an ardent supporter of Israel as the biblically mandated homeland of the Jewish people. His advocacy for Israel and his support for American solidarity with Israel is unwavering. Having served three years in the Israeli Defense Forces as a military police officer, the rabbi has personally experienced the meaning and implications for a Jewish person residing in the modern State of Israel.

Rabbi Pardo is available to meet with congregants and visitors alike for religious guidance and spiritual counseling. His motto is: "Be kind to the world and

its inhabitants."

The rabbi is looking forward to fully immersing himself in the community and has already joined the St. Joseph's University External Diversity and Inclusion committee to connect with people of a variety of denominations and belief systems who all share in the common goal of peaceful coexistence and a thriving community.

"I am looking forward to personally connect with everyone, and together with my lovely family become an integral part of the community," Pardo added.

Highlights from the 40 Thieves' second season

PATCHOGUE VILLAGE With their sophomore season now in the books, the Patchogue Fire Department's Drill Team, the 40 Thieves, can now look back on their 2022 season and confidently say they have made great strides thus far and have a bright future on the horizon in the sport of firematic drill competition.

The 40 Thieves—which are made up of members from each of the Patchogue Fire Department's four companies—are one of the more well-known drill teams amongst fire departments on Long Island, as well as the state of New York. They returned to motorized firematic drill competition in 2021 after not competing for 14 years prior to that. The team, which has a long and rich history that dates back to 1914, has always carried a tradition of being winners and record breakers throughout the years. And now these 40 Thieves are looking to get back to those winning ways.

After going through the trials and tribulations a first-year drill team will go through, Patchogue set out in 2022 to improve upon their performance of year one. Practice for the season began in the cool days of April with a focused determination to once again be ranked amongst the rest of the state's highly successful firematic drill teams, such as the

North Lindenhurst FD Piston Knockers, the West Sayville FD Flying Dutchmen, the Islip FD Wolves, and the neighboring Hagerman FD Gamblers, to name a few. Showing improvement in each event (for drills in 2022, Patchogue competed in only six of the eight different events that a standard Big 8 firematic drill consists of) and scoring points on a consistent basis each week was the team's collective goal. Looking back, that goal was met with

proven results.

This past summer, the Patchogue vamps competed in nine motorized firematic drills from Hempstead to Hagerman, scoring points in seven of them. The first of two high points on the season came at the Hagerman FD training facility on July 16, where Patchogue scored 10 points, resulting in a fifth-place overall tie with the Westbury FD Turtles. Then, the crowning achievement of 2022 came

at Fireman's Park in Ridge on July 23, where the Thieves placed second place overall with 17 points. The second-place finish on that day was the highest Patchogue had placed in a Big 8 drill since 2007, when the 40 Thieves placed first overall at the Patchogue Invitational Drill held on Rider Avenue. In addition to those accomplishments, the 40 Thieves bettered their team best times from 2021 in all of the six contests they compete in. Coach of the 40 Thieves Mike Pinkney was pleased with his team's effort and results in 2022. "We are getting there," Pinkney said. "Next season we need to start working on the little things, and we'll be set up to take that next step. Not too many expected us to be as successful as we have been, so we just need to keep working hard and good things are going to happen."

The team now turns their attention to the 2023 season, which will see the 40 Thieves again compete across Long Island and, in August, travel to just outside Utica to compete in the 2023 NY State Drill Championship. This fall and winter the team will squarely focus on raising funds for next tournament season. Search out the team's Facebook page and stay tuned for information on fundraiser events the team will be hosting in the upcoming months. ■

Local teens Allison Mullaney of Suffolk County and Catherine Cain of Brookhaven recently nabbed a Young Artist Academy Award in Los Angeles last weekend.

Mullaney won Best Teen Actress in a Streaming Film and Cain won Best Supporting Teen Artist in a Feature Film.

Brookhaven budget to raise taxes 1.92 percent

Town officials estimate a total yearly increase of \$10.52 per average homeowner



Brookhaven Town supervisor Ed Romaine recently released the \$328.6 million 2023 tentative budget with a 1.92, or 10.52 per year, percent tax raise, remaining below the tax cap and reducing

BROOKHAVEN TOWN debt by 36 percent. Last year's \$316.8 million budget included a \$3.88 increase for village residents and \$10.93 for outside village residents.

The 2023 budget also, according to the town, fully funds all constituent services, provides for escalating price increases in commodities, is conservative in its revenue projections, and preserves fund balance levels in the major tax districts through structural balance, while complying with New York State and Town of Brookhaven tax levy, tax rate, and debt caps.

The salaries of the elected officials have slightly gone up, with Romaine



receiving a \$2,500 increase from \$129,000 to \$131,580. The six trustees all saw a \$1,500 increase from \$75,200 to \$76,700. The tax receiver saw a slight bump from \$110,600 to \$112,800, and the town clerk and highway superintendent received a raise from \$110,600 to \$112,800 and \$123,900 to \$130,700, respectively.

The budget also increases the snow

removal budget by \$232,182; the garbage costs for single homes slightly increased to \$385 from last year's \$376 and 2021's \$365; and increases the landfill post-closure reserve by \$1.2 million for \$24.6 million in total.

Public Improvement Projects include: \$21.1 million for roads, stormwater and drainage improvements, traffic

safety, street lighting, machinery and equipment; \$8.8 million in landfill capping, infrastructure improvements and machinery/equipment; \$5 million for open space preservation and land acquisition for drainage; \$2.8 million for park and recreation facilities and equipment; \$2 million for planning and environmental; \$1 million for other improvements, including vehicles, facilities, public safety, IT; \$4.2 million to sewer improvements; and \$3.3 million for drinking-water improvements.

The town's landfill remains on track to close its construction and debris operation at the end of fiscal year 2024. The town board approved a \$4 million capping project in 2022 and another \$4 million capping project in 2023, representing an additional 25 acres to the existing 140 acres capped.

Additionally, a town spokesperson said they are confident they will maintain their AAA credit rating with Standard & Poor's Financial Services and Moody's.

Town makes nearly \$2 million in selling recyclables in 2021

Civic association hosts town recycling spokesman

The Blue Point Civic Association held its October meeting on Monday, Oct. 3 at the Bayport-Blue Point Library.

As a special presentation, Zach Sicardi, from the Town of Brookhaven Recycling Association, spoke with the meeting attendees about waste management, specifically where recycled materials are taken to and how they are treated.

Sicardi began with giving a brief history of recycling law in the Town of Brookhaven, which started with an act passed by New York State in 1988 that codified recycling into state law and was the reference point for local recycling programs that started in the early 1990s.

"The best way to address recycling is to reduce at the source and generate as little as possible," said Sicardi. "Reuse as many times as possible things like shopping bags, clothing as rags, water bottles."

All of TOB garbage is incinerated and this produced enough energy to power about 75,000 homes and businesses with the resulting ash goes to Brookhaven landfill.

Sicardi gave a breakdown of what is recyclable and what is not, including numbered plastics.

He made a note that commonly, pizza boxes are sent out with the paper recycling, but only the top of the box, i.e. the non-greasy part can be recycled.

Plastics

Plastics numbers 1,2,5, are recyclable.

Plastic 1 is typically water and soft drink bottles. Sicardi said, "Home meal kits usually have a plastic labeled 1, but because it is a film plastic is not recyclable."

Plastic 2 is high-density polyethylene and typically found in sturdier containers like shampoo and detergent bottles.



Plastic 5, which was just added by the Town of Brookhaven last year, includes food-grade plastic such as yogurt cups, sour cream containers, and orange prescription pill bottles. Sicardi recommends that these containers are given a wash before being put in the recycling.

As a special note, caps on plastic bottles should be put in regular garbage as they are a different plastic and the sorting machines remove anything less than 2 inches in size.

Metal cans

Soup cans, soda cans, clean aluminum foil (not soaked in food product) are all highly recyclable.

No scrap metal, including metal hangers, pots and pans, which can cause a danger for the people that work in the processing facility there.

Town employees can be scheduled to pick up scrap metal, washers, dryers, televisions, refrigerators.

Paper and cardboard

Magazines with glossy pages, envelopes with plastic window envelopes, and flattened cardboard boxes are accept-

able, as well as cereal boxes and paper towel rolls.

Sicardi advises that all Styrofoam products be thrown out.

One attendant remarked that she took her children to the town landfill to illustrate to them how much it is growing and to instill a sense of civic duty to recycle and cut down on usage.

Sicardi said that schools are often invited to the landfill and that while "some people think it all goes to the landfill, and that's not true," he showed a photo of three to four bales of recyclables, each 3,000 to 4,000 pounds, that were ready to be processed to be reused by manufacturers.

"We want to give people faith that recycling efforts are not going to waste and that we sell our recyclables to manufacturers throughout the country and the world."

In 2021, the town had \$1.7 million in sales of recyclables.

Sicardi mentioned that the facility's sorting machines are susceptible to jamming when plastic bags are caught in

them and that every day a worker is sent to cut them out, which is both dangerous to the employee and costly to the taxpayer.

Someone asked why there was not actual human personnel sorting through the recycling to weed out the garbage bags.

At the prompting of civic vice president, Alex Wellem, it was learned that the sheer volume of the sorter, at 12 tons an hour, could not physically nor fiscally support dedicated employees to sort.

Sicardi said that while some recyclables get turned into items like benches, where it is not a closed loop, paper can be recycled into other paper products and metal can even come back into the market in as little as eight weeks.

Calling glass the "elephant in the room," Sicardi lamented that having a separate day for glass pick up would be too costly but offered the 13 drop-off sites in the town for glass, including the Henrietta Acampora center in Blue Point, and said that crushed glass was used in construction for municipal purposes. ■

'1 in 7 Suffolk adults are functionally illiterate'

Nonprofit creates community in-roads to address illiteracy

A fundraiser for the 501(c)(3) nonprofit, Literacy Suffolk, was held at the 89 North Music Venue on **BELLPORT** Sunday, Oct. 2, to collect funds for organizational events.

With East End Trio, billed as "one of Long Island's premier live acoustic groups" on their website, providing the entertainment, guests had food, music, and raffles to enjoy.

Literacy Suffolk presented three awards that evening: Robert Margolin (Steven Moll Memorial Award), Rosemarie Jabour (Outstanding Volunteer Award), and Suffolk Regional OTB (Supporting Partnership Award).

Previously, on Wednesday, Sept. 28, Literacy Suffolk asked New Yorkers to experience what functional illiteracy felt like by hosting a Stop Reading Challenge event at the Suffolk Cooperative Library System, in Bellport, to demonstrate how debilitating it is not to be able to read.

Attendees were asked not to read for five minutes to experience the frustration of illiteracy.

It is currently estimated that 1 in 7 adults in Suffolk County cannot read, according to Literacy Suffolk. Nearly four million New Yorkers lack high school diplomas and/or have limited English language skills, with 25 percent of adults in New York State considered

"low literate," which puts these individuals at a 22 percent higher risk of unemployment, poverty, health issues and incarceration.

Since its founding in 1978, Literacy Suffolk has helped adults from 47 countries besides the United States through two programs: Basic Literacy and English for Speakers of Other Languages (ESOL). The Basic Literacy program helps adults who read and write below a sixth-grade level. ESOL teaches conversational English to people whose native language is not English.

Today, most of organization's students are recent immigrants from Latin America, Turkey, and South Korea. Literacy Suffolk serves the community by:

- Providing free one-to-one and small group literacy tutoring;
- Recruiting and matching adult learners and volunteers;
- Training volunteer tutors and testers and provides support through literacy materials, in-service workshops, and tutor support groups; and
- Increasing public awareness of literacy through outreach, partnerships with libraries and other community organizations, and county literacy initiatives.

Before the pandemic in 2020, more than 200 Literacy Suffolk-trained tutors provided one-on-one literacy instruction. The tutors also led small conversation groups.

During the COVID pandemic, many tutors learned how to use Zoom, Google Meet, WhatsApp, and other video conferencing technologies to continue personalized instruction with their students. These technologies also supported new opportunities for students to practice their English skills in small groups.

With the language skills they obtained through Literacy Suffolk, students have "entered the workforce and advanced in their jobs. For many, literacy was the first step in working towards a high school equivalency diploma or earning U.S. citizenship," according to a representative from the organization.

Other students have gone on to start their own businesses and become community leaders, and two former students have served on Literacy Suffolk's Board of Directors. ■

Iranian artist encourages a closer look at her art

Exhibit on display through the weekend

Nearly all the women depicted in Atusa Jafari's art gaze directly at you.

"Look," they say. "Look hard. What do you see?"

The faces and bodies are meticulously rendered, as if the subject will step out at any moment and engage the viewer in conversation. Hues that start out as a gorgeous bronzes or greys ebb into softer translucent shades surrounding the contemplative subjects, subtly heightening the images. As it is in "Play Date" (2022), for example. In this 39-by-39-inch oil on canvas, Jafari wears a necklace on naked shoulders of small, luminescent teddy bears; her long, dark hair is braided. It's a stunner.

"Everyone has to take care of that inner child," explained Jafari of the teddy bear necklace and title. "But there are dark smudges under her eyes, so that's the growing up part."

Jafari's exhibit, "Im Garten," German for "In the Garden," is her first solo show. The seven paintings, oil on canvas, are worth a visit—or two, or three—at The Something Machine Gallery in Bellport Village. Jafari, 22, born of Iranian parents, has lived in Germany all her life. She resides in Berlin, and while she's participated in group shows, this is her first solo exhibit.

In the 55-by-39-inch "Flower for You" (2022), Jafari is sitting on a garden lawn wearing jeans, offering a delicate flower. A small green plant on the ground

has sprouted up between her legs. The details are beautiful: a shadow gracing a pant leg from a billowing white sleeve; painted white toenails on feet in black leather flipflops; beautiful, outstretched hands with tapering fingers; small, dainty flowers on the grass here and there.

"It's a direct interaction of me offering a flower," she said. "You can see there aren't a lot of plants around, but the plant between my legs is my femininity. So I'm saying, 'It's in my power to give it.' I tried to make it an interaction scene. You can go in, or it seems the subject is coming out."

Jafari explained the garden theme. "Basically, it's looking into myself and getting to know parts of myself," said Jafari. "It's also accepting of both sides, masculine and feminine. Both are shining through at different times, so that's in my paintings."

"You have to look a little bit longer. And you have to take your time. You can get distracted by the bodies and views in different ways."

She was referring to paintings like "My Moon and My Sun," a 59-by-35-inch portrait, where Jafari is standing naked wearing only black socks, holding

Shaka, a ginger cat, up to her face. But there's a glimmer of the moon on the upper left, and then on the right, small slats of sunlight appear on her arm. "It's duality, it's in everyone," she explained. "There's darkness and light in you."

Jafari uses two medium-size brushes made from animal hair for her images ("I'm always replacing them," she said), plus a large one for painting surfaces. Her oils are created in a studio near her home; these paintings took a year to produce. "The process for me is really fast," she said. "If the process isn't fast, it's not ready to come out. I did more, but they're not ready yet."

She was asked about the massive protests in Iran right now over the death of Mahsa Amini, the Iranian woman accused of breaking her country's dress code, with French actresses and other women cutting their hair in solidarity.

"The work is not from a political point of view," she said frankly of her exhibit.

"It's a structural problem we can find everywhere. There's no room for a woman's cycle, so it's not fully where we need to be. And it's so easy to get sexualized with a naked image, but it's not made from that place." ■

Practice your escape routes

The Firefighters Association of the State of New York (FASNY) urges residents to plan their fire escape routes in case of an emergency. If your fire alarm were to go off right now, would you know what to do or where to go? What if you were stuck in the dark?

In the event of a house fire, FASNY says, people have as little as two minutes to safely escape before the smoke hinders vision. Because of this it is critical everyone not only plans but practices their escape routes. Knowing what to do and limiting panic could be the difference between life and death.

In support of Fire Prevention Month and Fire Prevention Week (Oct. 9-15), FASNY suggests residents know their exits. Another key point of the plan is to have a rendezvous point so that all members of the household know where to go.

"It's critical to plan and practice a home fire escape route. Everyone needs to be prepared in advance, so that they know what to do when the smoke alarm sounds. Every home is different, so every home fire escape plan will also be different," said Ed Tase, president of the Firefighters Association of the State of New York. "Have a plan that accommodates everyone in the home. Children, older adults and people with disabilities may need assistance to wake up and get out. Make sure that someone will know how to help them!"

In addition to a good and practiced plan, residents should check their smoke alarms and carbon monoxide detectors, replacing batteries if necessary.

According to the National Fire Prevention Association (NFPA), three out of every five home fire deaths occur in homes without working smoke alarms or in homes lacking smoke detectors. New York has the third most home fatalities in the country and more than 80 percent of fire-related casualties in NY are a result of residential fires, compared to the country-wide average of 76 percent.

Book bans are back

The national debate over book bans has wound its way from cable news stations and Internet forums right into my typically quiet hometown. Recently, a number of books in the Bayport-Blue Point collection have come under fire from people, who for one reason or another, believe they are inappropriate for students. Book bans are nothing new, especially here.

In a small Long Island school district, members of the board of education, after meeting with a group of local conservative parents, accepted a list of a dozen books the group objected to. The board voted to remove the books the group found morally offensive from the local high school library. Sound eerily familiar? It was the fall of 1975, the district was in Levittown, and a group of angry seniors sued to return the books to their shelves.

The case went all the way to the United States Supreme Court. In *Island Trees School District vs. Pico*, the justices ultimately ruled in the students' favor, stating for the first time that the right to read is implied in the First Amendment and that it is against a student's constitutional right to free speech to restrict speech just because


someone doesn't agree with the content of that speech. The ruling uniquely applied to public school libraries, where selection is a matter of free choice, as opposed to curriculum, which is mandatory for all. The decisions labeled libraries places for "voluntary inquiry" and found that the school board's "absolute discretion over the classroom did not extend to the library" for that very reason.

It was Long Island high school students who first established the national right to read, and protecting that right

is more imperative today than ever before.

Despite numerous efforts and billions of dollars aimed at early education intervention programs, studies consistently show that the only measurable method to predict future academic success in children is how early and often you were read to as a child. There's a good reason for that. It's because reading comprehension forms the building blocks on which our brains process and catalog all information. Reading a wide variety of books as we grow cultivates empathy through our connections to characters and places, both familiar and foreign, creating access to experiences outside our own lived reality. It makes us better, kinder, smarter human beings. And that's always a good thing.

As the conversation turns to book bans these days, remember that high school libraries have a way of becoming a safe haven for many students, especially for those that feel out of place otherwise. Our librarians work hard to make that space somewhere that everyone has a place. Just as it's important to read about experiences outside of our own, it's just as crucial to see ourselves depicted in the pages of books in our own schools. Who gets to be represented or not, should never be up for public debate. ■



Stony Brook Cancer Center continues to expand its minimally invasive procedures, such as robotic-assisted surgery, for patients with cancer. Cardiothoracic surgeons, Drs. Henry Tannous and Ankit Dhamija, are using the robotic approach to treat lung cancer. The highly trained surgeons explain how this procedure offers patients a more precise surgery that can lead to better outcomes.

What is robotic-assisted surgery?

The way we perform surgery keeps evolving and improving, especially when new technology is introduced. When we first started using the da Vinci® Xi™ robotic system, we mastered the new technique of using this tool as an extension of our hands and magnification of our vision. When performing robotic-assisted surgery, we dock the robot and are right next to you as we perform the surgery. The incisions are similar in size to thoracoscopic (video-assisted thoracic surgery or VATS) surgery, which uses a handheld camera and instruments through small holes in the body.

How is this used to treat lung cancer?

When an early-stage lung cancer is diagnosed and it's only in one lung, we are using this surgical technique for anatomic lung resection (removal). A lobectomy — considered the gold standard for lung cancer treatment — is the surgical removal of one of the lobes in the lung. The right lung has three lobes, and the left lung has two. Additionally, these lobes are broken down into segments, which allows us to perform smaller anatomic resections. We are also using robotic-assisted surgery for an

esophagectomy, which is the removal of and reconstruction of the esophagus, when cancer is found. In addition, we are using this approach for tracheal disease, mediastinal masses and chest wall disease, such as thoracic outlet syndrome.

What are the advantages?

We've found there are a few advantages with this type of surgery. One is that we don't have to spread the ribs as we do in open or traditional surgery, because we are using smaller incisions to access the tumor. This results in a faster recovery, which allows you to return to work or your normal activities sooner. Another advantage is that we can remove the lymph node packet — the area around the tumor — more precisely. This is partially due to the ten times magnification of the robot in conjunction to the benefit of the wrist articulation.

How do I qualify for this approach?

You're a candidate if you have an early-stage cancer and have had minimal operations in your chest. Ideally, you wouldn't have received preoperative cancer therapy, such as chemotherapy, radiation or immunotherapy. Even in a percent of these cases, there are modifications that can be done during surgery, so we can use the robotic system for part of the procedure. For late-stage cancer, it can be used to evaluate for lymph node invasion and palliation.

What would my recovery be like?

With the robotic technique we have found that there is a shorter hospital stay when comparing it to an open surgery. Bleeding is a risk, but not any higher than it is in any of the other approaches. For the lung resections, you're likely to go home anywhere between day one and five. Pain substantially decreases upon discharge and removal of the chest tube. The time frame to go back to your normal function, work and activities is usually between one to two weeks, except for exercising and lifting heavy objects. Those take a little longer.

What's the Stony Brook difference?

We have immediate access to our colleagues who have expertise in a range of specialties. Collaborating with them in our multidisciplinary tumor board meeting, and when needed, is an asset that is unique to an academic health center where the depth of knowledge is abundant. Also, there is strong administrative support to expand the robotic surgical program, so we can keep adding to our array of techniques that will benefit patients.





How to approach a basement remodel

A fully finished and functional basement is a dream for many homeowners. Such a space, when completed, can serve as an entertainment space, a man cave, an artist's studio, or any number of additional functions.

Despite their usefulness, finished basements are something of a rarity. In an analysis of data from the U.S. Census Bureau's Survey of Construction, the National Association of Home Builders® found that only around 24 percent of single-family homes built in 2018 have basements. Homeowners who do not currently have a finished basement but are considering such a project can approach the remodel with a few key factors in mind. Careful consideration of these factors can ensure the project is budget-friendly and worthy of homeowners' investments.

- Investment value:** Conventional wisdom among home renovation and real estate experts suggests that a basement remodel is best if done to satisfy current inhabitants and not necessarily to appeal to prospective buyers once the home is put up for sale. Remodeling magazine reports that a midrange basement remodel costing around \$70,000 will provide a return of around \$49,000 (or 70 percent) at resale. Though that's not a poor return on investment, homeowners who are remodeling a basement solely for the potential ROI at resale can find other projects that provide a greater return.

- Foundation:** The foundation of the home must garner ample consideration before beginning a basement remodel. Certain foundation issues, such as soft concrete, cracked or curved outside walls and cracks in the flooring, are indicative

of significant issues with the foundation. These issues can be costly to address, and they must be remedied before the basement remodel can begin.

- Existing space:** Some homeowners may have bought their homes with partially finished basements or even finished areas that they simply want to remodel. In such instances, a pre-remodel inspection from a licensed home inspector can save homeowners lots of money and heartache over the long haul. Partially finished or even aging finished basements might not have been renovated in adherence to codes, which could lead to costly violations down the road. An inspection in advance of a remodel can give homeowners an idea of what they will need to do to bring the basement up to code. Local officials also can provide a list of necessary permits and a detailed description of requirements to ensure the remodeled basement adheres to code.

- Soil:** Soil surrounding the home should be tested prior to beginning the project. Radon is an odorless gas found in soil that the U.S. Environmental Protection Agency notes can increase individuals' risk for lung cancer. Radon can seep into basements and increase that risk even further if it is present at elevated levels in the soil surrounding a home. Radon tests are simple and inexpensive, and no basement remodel project should begin without first conducting such a test.

Finished basements are valuable spaces. Homeowners who want to finish or remodel their basements should consider a host of factors before beginning the renovation.

A look at the oldest Halloween traditions

As with many celebrations, Halloween is steeped in traditions — many of which can be traced back quite some time. Since Halloween is believed to have originated from Celtic pagan, ancient Roman and early Christian events, its traditions are varied. The following is a deep look at some old traditions associated with Halloween.

Bonfires

Historians trace many traditions of Halloween to a Celtic holiday known as Samhain (pronounced sow-in). The Celts lived 2,000 years ago in parts of what is now Northern France, Great Britain and Ireland.

During Samhain, people believed that the door between the worlds of the living and the dead was blurred. On Samhain, Celts believed the ghosts of the dead returned. Also, Druids made predictions about the future at this time of year. It was customary to build large, sacred bonfires and burn crops and other sacrifices to the Celtic deities.

While large bonfires are not typically part of Halloween celebrations today, revelers can light fire pits in their yards that are reminiscent of ancient celebrations.

Trick-or-treating

Christianity spread throughout Celtic regions and blended with other rituals. Pope Gregory III expanded on a holiday Pope Boniface IV established to honor Christian martyrs to include all saints and martyrs. All Saints Day on November 1 commemorates the venerable saints, and All Souls Day on November 2 celebrates loved ones who went on to eternal rest. All-Hallows Eve (Halloween) was a time to pay homage to the dead. Poor children would go door to door in more affluent neighborhoods offering to say prayers for residents' deceased loved ones in exchange for

some food or money. This was known as "souling," which became the basis for trick-or-treating. Later the tradition became known as "guising" in areas of Scotland, where children would go around in costumes.

Witches

Images of witches riding broomsticks are everywhere come Halloween, and witch costumes remain a standard. Almanac.com indicates that, during the Middle Ages, women who practiced divination were dubbed "witches," from the Anglo-Saxon word "wicce," or "wise one." It was believed the witches could go into a trancelike state, and would do so in front of their fireplaces. Superstitious people believed the witches could fly out of their chimneys on broomsticks and terrorize others with magical deeds.

Bobbing for apples

Bobbing for apples is not quite as popular as it once was, as more people have become concerned about spreading germs. During the Roman festival for Pomona, which occurred around November 1, Pomona, the goddess of fruit and orchards, was celebrated. Romans believed the first person to catch a bobbing apple with his or her teeth would be the first to marry. It also was believed apple peels contained the secrets to true love.

Carving pumpkins

Removing the insides of pumpkins and carving them into funny or fearsome faces may be messy work, but it's tradition on Halloween. Turnips were the material of choice in ancient Ireland, but were replaced by pumpkins when immigrants came to America. The "lanterns" were made with scary faces and lit to frighten away spirits.

Halloween is full of traditions, many of which have lengthy histories.

Decomposing organic material is the basis for compost and other fertilizers. However, vegetable plants that are left to sit can lead to decay in the garden. Decaying plants can serve as hosts for pest populations and diseases. Rotting vegetables also can drop unwanted seeds into the soil, which eventually can strip nutrients that normally would go to next year's crops.

Ornamental plants and perennials can be cut back in fall. Cut down stalks and remove leaves.

Amend the soil

Fall is a perfect time to add soil amend-

ments, such as manure and compost. These fertilizers will add nutrients and break down gradually, enriching the soil over the winter.

Replenish mulch

Gardeners may have added mulch around shrubs and other areas of the landscape early in the season because it is attractive. But mulch also does much to reduce water loss and protect the soil from erosion. It may inhibit weed growth as well. Replacing mulch when the mercury drops can insulate the soil, which helps to regulate soil temperature. A thick layer of mulch around root vegetables left in the garden can offer protection against hard frosts.

Prune dormant plants

Wait until plants are dormant to prune them and adjust their shape. Most shrubs and trees should be pruned in late winter, right before new growth.

Move potted plants

Bring delicate plants into a sheltered area, such as a greenhouse or indoor garage, so they can continue to thrive during the winter.

Fall and winter still provide opportunities to spend time in the garden. At this point in the year, gardeners can prepare landscapes for the next season.

Pre-winter perennial pruning pointers

Foliage and football might be two things people instantly associate with fall, but there's more to this beloved season than brightly colored leaves and action on the gridiron.

Gardeners know that spring is an ideal time to plan and plant their favorite flowers and most flavorful fruits and vegetables. However, seasoned gardeners know that gardening is a year-round commitment. Pruning is one of the keys to keeping perennials coming back for years to come, and fall is an ideal time to take on this important task.

Pruning perennials in the fall is not a one-size-fits-all endeavor. According to the Old Farmer's Almanac, some perennials can be cut down after the first killing frost, while others can be left to benefit wildlife, including birds and insects. Understanding pruning and when to do it this fall can help gardeners lay a strong foundation for their gardens that will benefit them next spring.

Why should some perennials be pruned?

The College of Agricultural Sciences at Pennsylvania State University notes that perennials that have become diseased or infested with insects are pruned to prevent those problems from resurfacing in the spring. In addition, according to the Old Farmer's Almanac, many herbaceous perennials have old foliage and dying stems after several hard frosts. If dead foliage or dying stems aren't pruned, disease, slugs and other pests can overwinter in the plants. Cutting these plants down to the ground after several hard frosts allows the base of the plant to remain dormant over the winter but makes the plant less

hospitable to disease and insects.

Which perennials should I prune?

The first step to pruning perennials is to recognize which need to be pruned and which can be left intact for the winter. The Old Farmer's Almanac notes that bee balm and phlox are prone to powdery mildew and should be cut back once they're gone. Hostas harbor slug eggs, so they, too, should be pruned after a hard frost. Hosta leaves that have fallen on the ground should be removed as well. There's no need to cut back certain perennials if they're healthy. For example, hardy geraniums do not require pruning in the fall, and Penn State Extension notes that hardy perennials like garden mums are more likely to survive a cold winter if they're left intact. That's because the tops of such plants will collect leaves and snow for insulation and moisture over the course of winter. Gardeners who are unsure about fall pruning can speak with their local gardening center for additional advice regarding which plants to cut back before winter.

When to prune perennials

Gardeners need not rush to prune perennials in the fall. Diseased or infested plants can be pruned at the first sight of disease or infestation, but gardeners can wait until several hard frosts have occurred before they prune healthy perennials. In gardening parlance, a hard frost refers to when temperatures drop below 28 F. Several hard frosts kill the uppermost growth of most perennials, making this an ideal time to prune them.

Pruning perennials in fall can be the first step toward creating an awe-inspiring spring garden.

Daylight savings to end?

On the first Sunday in November, people across North America will adjust their clocks, turning them back one hour and thus returning Daylight Saving Time back to Standard Time. When spring arrives anew, the clocks once again will move forward an hour. This phenomenon has taken place for more than 50 years.

Time zones once were overseen by the railroad industry in an effort to streamline transportation. In 1918, the handling of time zones and other topics of time were turned over to a federal organization known as the Interstate Commerce Commission. The ICC also was put in charge of regulating the newly established Daylight Saving Time, purported to help with the war effort. The concept initially was introduced by Germany during the war to conserve fuel and power by extending daylight hours. The United States soon followed suit.

After World War I, DST was abolished nationally, but continued on a state-by-state basis, according to the Department of Transportation. However, the DOT took over regulation of DST in 1966, and by this time a law made it consistent across the nation.

While switching the clocks has become rote, the effects of this tweak have been notable. Some consider it a mild annoyance that messes with their schedules for a few days. Certain health professionals have gone on record to say it is bad for health. The time change in the spring (DST) has been blamed for everything

from increases in traffic accidents to a greater number of heart attacks as people adjust to a temporary deficit in sleep, according to NBC News. A 2019 poll from the Associated Press-NORC Center for Public Affairs Research found that 71 percent of people want to stop switching the clocks.

Over the previous half-decade, 29 states have introduced legislation for year-round Daylight Saving Time. In March 2022, the United States Senate passed legislation that would make Daylight Saving Time permanent starting in 2023, ending the twice-annual changing of clock times, leading to brighter afternoons all year long. The measure was dubbed the Sunshine Protection Act, and passed unanimously by vote. To date, however, the House of Representatives, which has held a committee meeting on the matter, has not passed the bill before it can go to President Biden to sign. The House is considering whether DST or Standard time is the better option for permanency, based on health implications and circadian rhythms. Other impediments affecting the legislation's chances of passing appear to be fundamental disagreements over the bill's language and a general consensus that other matters before the House may be more urgent.

Will switching the clocks each year come to an end? It still may take time to resolve this issue. In the interim, the public should be prepared to switch their clocks back on Sunday November 6, 2022, at 2:00 a.m.

Practice safe boating at all times

Boating is a recreational activity enjoyed by thousands of people. Spring and summer are prime times of year for boating, though people who live in temperate climates may be able to enjoy boating all year long.

Everyone who takes to the water, novices and experienced boaters included, should be familiar with boating safety guidelines. In fact, it is a good idea to take a boating safety course prior to boating for the first time or as a refresher if it has been a while since reviewing the rules of the water.

Boating safety goes beyond learning basic operation and navigation. Safety guidelines also involve getting a vessel safety check. The U.S. Coast Guard Auxiliary offers complimentary boating examinations. They can verify the presence and condition of safety equipment required by federal and state organizations. Boaters also may be able to conduct virtual vessel exams. This means boat owners can perform a self-inspection of the boats based on digital prompts. People who reside in Canada can contact the Office of Boating Safety to confirm whether vessel checks are required and how to get one. Licensure and registration of boats are part of responsible boat ownership both in the U.S. and Canada.

Along with boating inspections and water rules, some other ways to stay safe involve educating oneself of the larger dangers on the water. These generally involve risky boater behavior, such as failing to wear a life jacket or having an inadequate number of life jackets for passengers. Alcohol use while boating also can be problematic. Being under the influence can adversely affect boaters' reaction times and decision-making abilities. According to the 2018 U.S. Coast Guard Recreational Boating Statistics Report, alcohol continued to be the leading known contributing factor in fatal boating accidents in 2018, accounting for 100 deaths (19 percent) of total fatalities. Curbing alcohol use while boating can help avoid accidents and deaths.

Excessive speeds also can derail nice days on the water. The Texas Parks and Wildlife Department says that, although there are no numerical speed limits on the water, excessive speed can cause accidents in crowded areas. Speeding makes it difficult to react to obstacles — including underwater wildlife — and bring the boat to a stop within a safe distance of others.

Boating season is heating up, and that means making safety a big part of operating and enjoying a vessel.
