## Bay Shore Barbershop celebrates four years



## Islip murder-suicide leaves two dead

The Suffolk Homicide Squad investigated an apparent murder-suicide that took place on Feb. 20 in Islip. William Clifford, 73, and his wife, Eileen Clifford, 68, were found dead on their property.

At around 6:30 a.m., Town of Islip garbage collectors noticed the body of a man lying on the driveway outside

the residence. The driver of the truck called 911 after examining the body and realizing the man was dead.

Third Precinct officers reported to the house and found a woman inside, dead from a gunshot wound. The man had also suffered a gunshot wound and there was a firearm found near him.

Eileen Clifford was a retired flight attendant for American Airlines. She founded the Kiwi Club of Long Island

in 2013. She was known for her philanthropic endeavors.

William Clifford was a tugboat operator who graduated from the Merchant Marine Academy. The firearm used in the incident was registered in his name.

The two had been married for over 20 years and had no history of domestic violence.

Officers did not release a motive. ■

# Who let the cats out?

At the Town of Islip's Feb. 11 meeting, many residents spoke about the ongoing overpopulation crisis of stray and feral cats. Many urged the

**ISLIP TOWN** town board to come up with a solution to help fund and support TNR programs: trap, neuter, release.

Cats can have between three to six kittens per litter. They can also carry another litter as soon as three weeks postpartum. If they aren't found and taken to a veterinarian or shelter, these cats grow up on the streets, which then creates a nuisance in neighborhoods.

Last year in July, a feral cat in Nassau County tested positive for rabies.

Tender Loving Cats was founded in January 2017 by Rebecca Caro as an all-volunteer, not-for-profit organization that aims to help cats, whether they're abandoned by their owners or stray. The organization doesn't aim to just find cats a loving home, but rather help enforce a trap-neuter-release. This ensures that cats who are adopted are neutered, and stray cats living in the streets are neutered and cannot reproduce.

In 2024, TLC spent \$30,000 spaying and neutering feral cats in the Town of Islip. Caro wants the town to help financially or implement a program that assists with the medical costs.

"I expect the town of Islip to come up with their own voucher program,

their own town-funded TNR clinics, or contribute funds to those local rescues who are spending a majority of their funding already in the township," Caro said. "Creating a low-cost program is not hard, but does require training on the part of the shelter staff and volunteers on how to advise and teach the public how to humanely trap, transport, and recover these cats. In this way, I'd be happy to help them train staff and volunteers, as well as help advise on how this program can be run effectively and efficiently."

In 2019, TLC began the Prevent-A-Litter program, PAL, to help the stray cat epidemic on Long Island. On average, the program neuters 400 to 500 cats each year, and in 2023 they hit a record of 682 spay/neuters that were made possible thanks to the help of volunteer trappers.

However, one of the main veterinar-

ans that Tender Loving Cats uses, Island Rescue, is raising the cost of their neutering and spaying services 30 percent, from \$90 to \$120. Despite it being more affordable compared to the average cost of neutering, there is a surplus of cats under the care of TLC that need these services.

Ellen Mackey has worked as a full-time nurse at Good Samaritan Hospital for over 20 years and helps maintain cat colonies. She spoke to the town board.

"Say I make a decent living, I'm spending 20 to 30 percent of my income to fix cats, and I've been doing that for this many years, for over two decades," Mackey said. "...If you look at the math and see how fast a population can grow, we need this program."



# Celebrate the return of spring surrounded by art and music

A concert invitation and a call to artists

The Island Symphony Orchestra will celebrate the return of spring on Sunday, March 23, with the world premiere

**WEST ISLIP** of "Sinfonietta Pastorale," a work composed by music director Eric R. Stewart. Inspired by songs of birds of New York State, the program will also feature "The Beauty of Birds," an art exhibition curated by Seatuck Environmental Association featuring bird art and photography.

A native of Buffalo, N.Y., conductor and composer Stewart reached out to Seatuck Environmental Association naturalist, John Turner, to learn about birds native to New York State. His "Sinfonietta" translates the calls of the mourning dove, whip-poor-whil, black-capped chickadee, dark-eyed junco, and piping plover into written music.

"The process of composing this piece was very special to me. I drew on childhood memories in Buffalo, N.Y., surrounded by snow, hearing nothing but the birds calling one another," said Stewart. "From the very beginning of the piece, I tried to paint this picture with the music: a serene backdrop, sprinkled with the songs of these birds and warm reflection of the sunlight off the fresh snow."

"Sinfonietta Pastorale" will be performed by guest artist, New York Philharmonic piccolo and flutist, Mindy Kaufman. The composition showcases Kaufman's technical mastery of the instrument, as well as her superb lyricism and musicality.

Kaufman joined the New York Philharmonic in 1979 at the age of 22. Kaufman has appeared as a soloist with the New York Philharmonic under the direction of former music directors Zubin Mehta, Kurt Masur and Lorin Maazel, and since September 2014, she has been teaching for the Shanghai Orchestra Academy. A sought-after commercial musician, she has performed on more than 45 film soundtracks.

"The Beauty of Birds" art exhibition, also part of the program, is curated by Seatuck Environmental Center, a non-profit, 501(c)(3) organization dedicated to conserving Long Island wildlife and

the environment. The Islip-based organization advocates for wildlife, advances conservation projects, engages community scientists in wildlife research, and offers a wide range of environmental education opportunities for all ages.

The deadline for entering digital submissions of bird art and photography is March 7. All media is accepted, there is no submission fee, and entries must be original to the applicant. Submissions can be emailed to [staff@seatuck.org](mailto:staff@seatuck.org) including name, address, phone, email, and a brief artist biography. Emailed acceptances will be sent on March 14.

The March 23 program will also feature the "Concertina for Flute" by Cécile Chaminade, and Antonin Dvorak's "Symphony No. 6." The South Shore Audubon Society will provide audience members with a printed guide to the birds featured in Stewart's "Sinfonietta Pastorale." ■

# Bay Shore Barbershop celebrates four years

On Feb. 19, Bay Shore Barbershop, located on Main Street in Bay Shore, celebrated four years since their opening. Established back in 2021, the barbershop has grown in business, thanks to support from the local community. People from all different backgrounds step into 176 W. Main Street to get a fresh cut.

The new owner is Jesse Vargas, who has been cutting hair for over 20 years. He opened the shop after the previous owners had closed during the COVID-19 pandemic. Vargas has been working Monday through Saturday since opening in 2021.

He kept some of the keepsakes that were part of the previous barbershop business. A sign that reads "Barbershop" right outside of the entrance was retouched to preserve its old-school look. Twenty-five cent vintage candy machines, kept from pre-COVID, are filled with M&M's and other sweet treats.

One of the things Vargas enjoys about working one-on-one with someone is being able to help them if customers talk about their problems or worries.

"You can interact with people, you can talk to people," Vargas said. "People talk about problems, sports, stuff like this."

Not only do they cut the hair of people in their local communities, but members of the Suffolk County police as well. Bay Shore Barbershop supports

four different police units who visit them for their hair-cutting services.

The barbers also help out one another with their services. If either of them ever needs a haircut, they take turns on each other, a perk of working at a barbershop. One worker, Jhonatan Gil, has been cutting hair since 2013.

Bay Shore Barbershop is looking to be in business for the long run. Their lease is for 10 years, but they are hoping to be on Main Street for years after.

"Basically, we're here like a family," Vargas said. "When we opened it was at first, like, five guys that we got here—we all put a little part." ■


collecting, purchasing, stuff and was dedicating the next 50 orbits around the sun (or however many she would be around for) to getting rid of that stuff.





# Keep up with fire safety

Tips from Suffolk County fire commissioner Sunderman

News of the fires ravaging Los Angeles has reminded many local residents of the 1995 Sunrise Fire which made national headlines, scorched thousands of acres of the Pine Barrens, and threatened homes and businesses in Westhampton Beach before it was extinguished.

A dry spell, 19 days without rain and wind gusts that exceeded 30 miles per hour, helped create a near disaster as fire tore through 5,500 acres of dry brush and pine forest and nearly reached loaded fuel tanks at Gabreski Airport.

It took several days and hundreds of firefighters, including a team of Hot Shots from California, to put out the inferno.

Asked about that fire, Suffolk County fire commissioner Rudy Sunderman got right to the point. "We had a fire yesterday," he said.

On Monday, Feb. 17, fire broke out between Sunrise Highway exits 62 and 63, a seven-mile stretch of wooded acreage and the same vicinity as the 1995 blaze. That fire started near Suffolk Community College's Riverhead campus, and spread rapidly, then did the unthinkable: jumped across Sunrise Highway and continued to burn near Gabreski Airport and, later, farther south, threatening the village of Westhampton.

Thanks to a quick response by 15 local

fire departments, the 2025 blaze was extinguished in two hours, with damage to 2.7 acres and no loss of life or property—a vast improvement over the earlier, near catastrophic, event.

Commissioner Sunderman was quick

to reflect on some of the changes that made a difference.

"We have cellphones today," he said. "Thirty years ago, you saw smoke, you'd have to run home or try to find a public payphone to report it. Now we have

brush trucks that hold more water. They're more efficient at knocking out fires. And, we have opportunities to provide more training today. There's ongoing activity at both the Suffolk County Fire Academy in Yaphank and in-house at local fire departments. Today's Suffolk County firefighters are trained in wild land firefighting techniques."

FRES—the Fire Rescue and Emergency Services—oversees the county's fire academy and posts regular alerts about current fire risk, as it did last November when concern was high after 40 days without rain.

While the cause of the Feb. 17 fire is still under investigation, Sunderman urges residents to exercise caution and remain aware of potential fire risks, especially as we enter peak fire season.

Make sure that matches, cigarettes, or cigars are completely extinguished. Discard them only in a proper container, never on the ground or out a window, where they could ignite surroundings.

Don't put mulch up to the foundation of your home or other structure. Cut back vegetation, especially tree limbs, which should be 6 to 8 feet away from the house.

Wind, dry weather, and sparks from outdoor grills and fire pits can be a recipe for disaster as well.

"Pay attention to weather alerts and outside conditions and definitely exercise caution with open burns during fire season," he said. "Go on FRES, check our social media page, the Suffolk County homepage, or local village or fire jurisdiction sites for fire risk alerts before burning." ■

Lucas Brelsford bowled solid all day and helped East Islip take the lead for good in Game 5 by shooting a 224, while freshman Lucas Lawlor added a 207 and 204 in Games 1 and 3. Rounding out the squad were Chase La Fata, Anthony Sasso and Matthew Sundberg.

The girls team, coached by Rob Scnone, was just as dominant, finishing the regular season with a perfect 11-0 record as league champs before winning their second consecutive county championship. Despite the introduction of new conference alignments for Suffolk's girls bowlers, East Islip remained dominant, with five bowlers ranked among the

county's top 16.

Additionally, the team claimed the top three spots in the county for average score, led by junior Brooke Andresen, senior Dakota Collins and sophomore Meeya Leaderman. As a team, the girls concluded the season with an impressive average of 998 pins per game, outperforming every other team in the county by 45 pins.

Maintaining their momentum, the team amassed 5,981 pins in six games at the county tournament to defeat second-place Longwood and third-place Smithtown. Collins scored a high series of 675, Andresen shot series of 624 and 680, and Meeya Leaderman notched series of 590 and 595.

Both of East Islip's teams will next play for the New York State title on March 14, with the championships to be held at Strike 'N Spare Lanes in Syracuse. Four East Islip players – Jacobsen for the boys; Andresen, Collins and Leaderman for the girls – will also play on their respective Suffolk All-Star teams competing for state championships on March 15.

John Michael Davis ("JD") was born on January 27, 1963, in La Rochelle, France. The eldest son of Jack and Terry Davis, JD's dad was stationed in France during the 1960's while in the US Army. JD often talks fondly about his parents, and the lessons they taught him were all about working hard, giving 150%, and always being mindful of other's needs. Also, never call your friend's parents by their first names because it's not respectful... and no tattoos. Another big influence on JD was his Grandma Lee. Grandma Lee always said if you do something nice for others and expect credit, it doesn't count.

When JD was almost two years old, he and his family traveled back to Long Island, settling first in Glen Cove then moving out to Brentwood by the time he started school. There, he and his two brothers, Steve and Tim, grew up playing sports with neighborhood friends, joining Little League and CYA Basketball. By the time JD was entering high school, he had already played on multiple championship travel teams. He decided to attend St. John the Baptist Diocesan High School in West Islip and there he continued to play team sports. A highlight of his experience at SJB was catching the winning touchdown in the 1980 Metro Bowl championship game ("I didn't play football for my high school; I played football for my country!" - Al Bundy).

With his good looks, grades and athletic skills, JD went on to attend and play football for the Fordham University Rams in the Bronx. He only mentions highlights of his four years there. The rest is hazy. Lots of White Castle and road trips. As a senior at FU, he went on the mandatory trip to Spring Break in Fort Lauderdale. He returned with blue stitches in his lip and a soft cast on his ankle. Again, details are hazy. But in JD fashion, he lived large and did things 150%. Graduating as a "Political Scientist" and in the top 5,000th in his class, he went to work for Yellow/Roadway Corporation, becoming a trans-

portation and logistics specialist. He stayed with the company for 33 years before retiring in 2018.

After moving to Great River in 1998, he joined the community association right away and then signed his eldest daughter, Kelly, up for U5 soccer with the East Islip Soccer Club. There he met Tom Vollmuth who asked, "do you want to be my assistant coach?" This spark eventually led JD to the position of President of the East Islip Soccer Club, a role he held for 9 years.

Speaking of the East Islip Soccer Club, it was a conversation that happened by chance in the concession stand with Jim Hand and Dave Dinota that introduced JD to the AOH Division 7.
