## Lincoln Elementary hosts over 1,000 student athletes for fitness competition

33 schools from across Suffolk County compete in speed and obstacle events

Lincoln Avenue Elementary School recently welcomed more than 1,000 athletes from 33 schools across Suffolk County for the annual Suffolk Zone Fit Club. Fourth and fifth graders represented their schools in two team events focused on health and fitness.

Fit Club is hosted annually by the Executive Board of the Suffolk Zone Chapter of the New York State Association of Health, Physical Education, Recreation, and Dance (NYSAPERD) as an opportunity for students and teachers to promote fitness and lifelong wellness. The event is unique because it is created by and run by students trained to serve as referees, scorekeepers, greeters, and coaches.



The two events in the competition challenged students across all five health-related fitness components (cardiovascular endurance, muscular strength, muscular endurance, flexibility, and body composition) and all six skill-related components (agility, balance, coordination,

A handy app for volunteers

Looking to volunteer?  
Want to keep track of those hours for school or work?  
Are you a nonprofit looking for volunteers?  
Jennifer Cunningham founded Volun-timekeeper, an app that addresses all of that and more. (See VoluntimeKeeper.com.)  
Cunningham lives in Patchogue. Her son attends Bayport-Blue Point High School.  
“He needed to get papers signed for his volunteer hours when he was in eighth grade for the National Honor Society,” she explained of the impetus. “It was 10 hours each year then. Now, he’s in high school and it’s up to 30 hours.”  
As with most significant ideas, Cunningham kept musing for an easier way to chronicle volunteer hours. The reality is that students and their parents deal with a lot of paperwork, especially with college applications. And not-for-profits always need volunteers.  
How to connect?  
On a plane ride from New York to Jackson Hole, Wyo., in 2022, a lightbulb hit, and she sketched out a plan.  
“We’re creating a solution where adults and students can find a volunteer activity,” she explained. “They can submit the hours if they did, for example, a trash cleanup, food drive or helped out at an animal shelter. The goal is to reach all nonprofits and provide a research tool so they can post their event.”  
Students can view a digital impact report to track where they volunteered. But not only that. “Some companies give employees time off for volunteer activi-

ties, so it can provide service hours, even for municipalities who encourage that.”  
It’s \$15 to sign up.  
The volunteer tech company she founded is Lighthouse Technology Solutions, LLC.  
Cunningham, who works for an ad tech company, said she sees her app creation as a humanitarian asset. She’s spent 20 years working in ad tech sales, marketing, and client support solutions. Growing up in Westchester with a Rotar-

ian father, a retired dentist who now teaches at New York University College of Dentistry (Ralph P. Cunningham, DDS Clinical Associate Professor, General Dentistry & Comprehensive Care) and an educator mother, she has traveled extensively via college and work.  
“It had an impact on how we were raised,” she said, especially of the Rotary connection. Her mom, a retired professor at Mercy College, still subs in Connecticut.

cut high schools.

“They always volunteered at a horse show and hosted exchange students in their home,” she said. “As I got older, I did things on my own. Food drives, food service at the Bowery. Also, I’m a catechist at Our Lady of the Snow in Blue Point.”

Cunningham has already signed up the Patchogue-Medford Library, Patchogue-Medford Youth Services, the Rotary Club of Patchogue and Our Lady of the Snow in Blue Point, she said. The Voluntimekeeper program is planned to roll out this fall.

James Bertsch, administrator for Nassau BOCES, was enthusiastic about Cunningham’s app.

“I’ll give you a sense of how we (Save the Great South Bay, the Bayport-Blue Point Junior Civic, whatever) access volunteers and document their service.

“I will reach out to whatever teachers, etc., who are in touch with possible student volunteers. But I need to know who those people are, how to contact them, what organizations they run, etc. Then, if the advisors support whatever cause I’m seeking volunteers for, the advisor needs to be a dynamic enough advisor to get kids excited enough to show up.

So, if the kids show up, I can document their volunteering in two ways: I can give them a pre-printed community letter we developed but fill in the blank parts specific to them (name; time, date, descrip-

tion and location of activity; number of hours), or I can fill out the volunteer sheet they want me to complete,”

The process is similar for adults, he said.

“So why is this app great?” he asked of Voluntimekeeper. “It gives students (or adult volunteers) direct access to volunteering opportunities and gives volunteer organizations direct access to students. Plus, for adults or even kids who like to volunteer but who aren’t connected to either a school club or a community club, you now know how and where to volunteer.” ■

About jumper cables and thanks

I never got jumper cables for an award. Neither did my husband, Vinny. But we were feted with these handy necessities along with roses and other gifts, as well as the goodwill of an amazing amount of friends, family, and supporters at The Rollstone Foundation's 18th annual Save More Gala last week. Let's not get into the whys of how we got to be the honorees. We're just two people who try our best to elevate the community in our own ways, something many of us do. The Rollstone Foundation funds family adoptions of special-needs orphans, many in third-world nations, via grants. Youngsters may have cerebral palsy, Down syndrome or are HIV positive. (The cost of an international adoption is often \$25,000.) Founded 18 years ago by Mike Dawidziak and Pam Greene, their special speaker this year was single parent Emily Brokaw, who traveled from Pennsylvania with her parents and 3-year-old Micah. Emily spoke of her five-year journey, first trying to adopt a child in China. She was rejected when that country closed off overseas adoptions. Emily kept researching and found Micah from Bulgaria. He was the lucky one. But Emily and her family would say they got lucky. Micah high-fived many of us after Emily's speech and danced joyfully to music later on. The event at The Mansion at Timber Point, in Great River, pulled in 250 people

who committed to this nonprofit. There's no overhead; the board goes through the grant applications and then select a family. Well over 600 children have been adopted since Rollstone's founding. The name is derived from a Biblical story. Beautifully uplifting doesn't go near to describing the gala. Judges, government and school officials, Rotarians, company heads, volunteers, people without titles came out and supported this group. (So

Oakdale's Charlotte Community Garden

A space where people and plants grow together

There's something about gardens—our source of sustenance, the origins of civilization, the Biblical locale for innocence—that resonates on a deep, psychic, and spiritual level. That is why Oakdale residents Rae Paoletta and Stacey DeFelice created a community garden on Montauk Highway in Oakdale (1 Berard Boulevard) at the St. John's Episcopal Historic Landmark Church. Their great hope is that their garden becomes a powerful community builder, feeding both our bodies and our souls. "Our hope and vision," their mission statement reads, "is to create a space where people and plants can grow together." The grand opening is on Saturday, May 31, from 3 to 5 p.m. In a tip of the hat to the church's history—a history hallowed by locals—they chose the name Charlotte Community Garden. Charlotte Church was the church's original name. That was in 1765! Respectfully and prodigiously cared for by the Oakdale Historical Society, its official stewards, St. John's Church is on the National Register of Historic Places. It's also the third oldest church on Long Island. See the church page for its great history: <https://stjohnsoakdale.com>. Maryann Almes, the president of the Oakdale Historical Society, wasn't

just interested when Paoletta and DeFelice approached her about it. She was ecstatic and welcoming. "Nourishing our community is at the core of our mission. One hundred percent of our harvests will go to people and families who need them," Paoletta and DeFelice pointed out. They're working with Uplift Our Towns, ECLI Vibes, Eileen's Free Bodega and other charities that "help domestic violence survivors, women and children, and people experiencing food insecurity." Paoletta and DeFelice want to grow food for people who need it, all while feeding the hearts and minds of the people who grow it. A space where people and plants grow together, indeed! Paoletta and DeFelice have devoted a lot of time to the garden over the past

three months. Thus far, they're growing various kinds of tomatoes, eggplant, an assortment of herbs, peppers, red and green lettuce, kale, cucumbers, snap peas, radishes, spinach and more. The garden already hosts 250 plants (and counting!), a donation bin for non-perishable food items, and a compost bin where anyone in the community can bring food scraps. This summer, the garden will also host free, beginner-friendly classes for people who want to learn how to garden and/or compost at home. It also hosts a native garden that helps support local pollinators, natives they purchased at the Long Island Native Plant Initiative (or LINPI) in Brentwood. Natives support bees and restore the web, making the land and the life it supports

healthier and more functional. How big, varied, and active the garden becomes is up to us, readers and volunteers. Anything we can give—tools, money and especially time—is always welcome. "I think gardeners are people who look at a seed and see only potential—what it could become, with a little time and nurturing," Paoletta explained regarding her hopes and dreams for the site. "And I think that's exactly how Stacey and I feel about this garden. We know that when we plant a seedling, that it will grow and one day feed a person and perhaps their family." Purpose. Community. Sustenance. Fulfillment. Paoletta and DeFelice are just as interested in growing people as

Connetquot hosts eighth annual Beats for Liam cardiac screening event

On May 10, Connetquot High School welcomed a strong community turnout for the eighth annual Beats for Liam teen cardiac screening event, with 96 teens receiving free heart screenings aimed at detecting hidden cardiac anomalies.

The event was held in memory of Liam Regensburg, a Connetquot High School student who tragically died in his sleep on Oct. 29, 2012, due to sudden cardiac death. Liam was a healthy high school junior at the time, and his loss

has fueled a mission to raise awareness and provide preventive screenings.

Sudden cardiac arrest is a silent threat, claiming the lives of thousands of young people each year. Often symptomless, it is caused by electrical irregularities in the heart that can be detected with a simple, non-invasive EKG.

Thanks to the Liam Regensburg Memorial Foundation, families had the opportunity to have their teens screened at no cost, potentially saving lives through early detection.

# School budgets pass by wide margins

Connetquot, Sayville, and Bayport-Blue Point School District's voters passed budgets and elected returning and new school board members Tuesday

## Connetquot School District

In an election for the Connetquot Board of Education, former board president Sara Parisi received 1,525 votes, defeating incumbent trustee Jaclyn Napolitano-Furno, who received 1,056 votes.

A lifelong Connetquot resident, former trustee, and Board of Education president, Parisi said her top priorities in returning to the board are "fiscal responsibility, academic excellence and respectful, effective governance."

Voters in the Connetquot School District also approved a \$229 million budget for the 2025-2026 school year, with 1,898 votes in favor and 725 against. The approved budget is around \$6.5 million, or 2.91 percent higher than the 2024-2025 budget. The budget also increases the tax levy by 1.34 percent, at the district's limit.

The budget for the upcoming year maintains all academic, athletic and extracurricular programs, and the district said it will "sustain lower class sizes and create additional pathways for enrichment through the expansion of the district's Universal Pre-K program by two additional sections."

Compared to the current budget, the district will increase spending on instruction by around 2.89 percent, transportation by around \$800,000, or 6.03 percent, and general support by around 2.9 percent.

## Sayville School District

Voters in the Sayville School District approved a \$105.7 million budget for the 2025-2026 school year, with 1,895 votes in favor and 849 against. The approved budget decreases from the 2024-2025 budget by around \$350,000, or .33 percent,

and the tax levy will increase by 2.2 percent, below the district's cap of 2.32 percent.

The administrative budget has increased by \$398,063, while the capital budget has decreased \$793,348.

The \$398,063 increase in the proposed 2025-2026 schoolyear budget is heavily allocated to increasing insurance and BOCES costs. The remaining increase will go toward contractual increases across the Sayville School District.

The unallocated insurance in the administrative budget had a 26.64 percent

increase from \$632,479 to \$801,000 (a difference of \$168,521).

Budget revenue streams have all decreased this year, with \$351,838 less in revenue, \$597,197 being from state aid.

In an election for two open seats on the district's Board of Education, Christopher Robertson defeated Alyson Ryan and Jason Rowland for a three-year term to succeed outgoing trustee Maureen Dolan.

Incumbent trustee Christine Sarni won reelection to her seat with 1,443 votes, defeating challenger Teal Rizzo, who received 1,271 votes.

"We have wonderful students and teachers here in Sayville!" Robertson said. "I want to give them the full support, tools and equipment they deserve to create an amazing learning environment."

The budgets for Sayville's Public Library and Historic Society also passed with more than 2,100 votes in favor of each.

## Bayport-Blue Point School District

Voters in the Bayport-Blue Point School District approved an \$89.1 million budget for the 2025-2026 school year, with 797 votes in favor and 319 against. The approved budget is around \$3.3 million, a 3.8 percent increase from the 2024-2025 budget. The budget also increases the tax levy by 3.45 percent, at the district's maximum limit.

The increased budget is mainly due to increases in general support by

around \$600,000, instruction by around \$1.4 million, transportation by around \$133,000, and debt services and employee benefits by around \$3.3 million.

Voters also passed a second ballot proposition, establishing a capital reserve, in addition to the school bud-

## Connetquot River State Park Preserve receives \$100K grant for accessible trail

Soon-to-be wheelchair-accessible trail latest initiative to restore the park by Friends of Connetquot

Enjoying nature at the Connetquot River State Park Preserve is about to become even better after the state park received a \$100,000 donation to construct more accessible trails.

The John C. Dunphy Private Foundation Inc. donated \$100,000 to the Friends of Connetquot River State Park Preserve earlier in May to make the park's signature Red Trail more accessible and Americans with Disabilities Act-compliant.

The project, which now enters phase 1, and is expected to begin construction later this year, will create a wheelchair-accessible pathway through the park preserve, and is expected as of now to finish around next summer, according to Friends of Connetquot River State Park Preserve.

"We are honored to support Friends of Connetquot River State Park Preserve in their mission to expand accessibility at one of Long Island's most treasured natural spaces," said Karlyn B. Grasso, secretary and communications officer for the John C. Dunphy Private Foundation Inc. "This initiative reflects our core commitment to projects that foster inclusion, improve lives, and connect people with the environment."

The accessible trail will include boardwalks along more marshy and muddy sections to help visitors of all abilities take advantage of the park's scenery and services. The money will also help rebuild new bridges over the swampier parts of the trail.

Connetquot State Park's 3.4-mile red trail connects the Visitor's Center, which used to house the Southside Sportsmen's Club in the 19th century, to the park's Fish Hatchery, known for its different species of trout.

Tens of thousands of rainbow and

brown trout eggs have hatched at the site every year for over a century. The hatchery is one of the oldest in the country and is where rainbow trout was first introduced on the East Coast, according to Richard Remmer of the Long Island State Parks Commission and Friends of Connetquot River State Park Preserve.

"Several hundred thousand visitors a year come to the Connetquot River State Park Preserve," Remmer said. "And altogether, the preserve is 3,473 acres, and unless you're in a car, much of that is not truly accessible. This will be a great expansion of accessibility at a wonderful site."

Connetquot River State Park Preserve already features handicap-accessible fishing sections on the fishing piers. Still, the new improvements will help those in wheelchairs better access these sections from the park's entrance.

For nearly 30 years, the Friends of Connetquot River State Park Preserve have worked to conserve the preserve and raised hundreds of thousands of dollars to fund restoration projects.

According to Friends of Connetquot River State Park Preserve president Janetmarie Soley, the nonprofit organization had secured other donations for its trail improvement project from the Greenbelt Trail Conference, which will help improve bridges. A test section of the trail was constructed with the support of Goldman Sachs last year.

Other private-public restoration project partnerships the Friends of Connetquot River State Park Preserve have secured over the years include the restoration of a 19th-century stained-glass window and tin ceiling at the former Sportsmen's Club and the full restoration of the Nicoll Grist Mill.

The John C. Dunphy Private Foundation, which donated the \$100,000 to construct the new accessible trail, also helped fund some of the Friends of Connetquot River State Park Preserve's previous initiatives. The foundation is also "dedicated to improving the quality of life for the people and service organizations within our local communities—and wherever the spirit may lead." ■

get, with 797 votes in favor and 298 against. The reserve can be funded up to \$10 million over the next 10 years from fund balance when and if possible. This money will be used to complete projects around the district in the future and will not have an impact on the tax levy or budget.

In an election for the Bayport-Blue Point Board of Education, newcomer Jack Sautter defeated challengers Robert McLaughlin and Adam Schneider with 679 votes to fill a three-year term, replacing outgoing trustee John Kroog. “I will work with and listen to all differing opinions, and through collabo-

ration find solutions to future challenges,” Sautter said. “I will always follow the best ideas, even when they are not my own. Through active listening to all community members, robust participation in district functions, and support to school administrators, I will actively engage important issues that come

before the BBP School Board.” Incumbent trustees Sandi Kanne and Brian Johnson won re-election to their seats for three-year terms without opposition, with each receiving over 800 votes. ■

funny. In the Songbird Bedroom, Clare Seaver (Economos), flipping through a fashion magazine, played a great disdainful socialite (she sniffed with an eyeroll when a group came in looking them over, chastising anyone who went near her perfume bottles.)

Clarence Narrow (Dawidziak), who represented the Seaver family and was glad of Blather's demise, worked at the New York City law firm of Narrow, Shyster, Van Drivel & Belch. (He always works within the law, but the Lord's law, perhaps not.)

The Ninth Earl of Egginham (Giebfried), dressed in nifty tennis whites, who just played a game with Freddie Bourne (of the Bourne Mansion), was dismissive of the Bayard Cuttings (new money). Dusty Flors (Greene), with her Irish brogue, wielded her feather duster for emphasis.

She'd been with the family for 40 years; they helped her, and she would do anything for Clare.

"Did you ever have a child?" she was asked.

"What a bold question," she hurled back.

"These are bold times," replied Bill Bailey.

Governess Nanny Villin (Traver) played the upstairs family employee with the stiff-upper-lip English persona of someone who doesn't mingle with the

ited the production to everyone involved in it, contributing ideas, she was witnessed in rehearsal directing scenes and adding reminders. Several performers pointed to her expertise in pulling the production together.

Did LaMarca ever do theater directing?

"No," she said. "But I grew up in a large family and we were always doing plays and talent shows. We still do. We're doing one for July 4th." ■

No. 55-2025. EXTENDING LOCAL EMERGENCY ORDER Nos. 1, 3, 5, 7, 9, 11, 13, 15, 17, 19, 21, 23, 25, 27, 29, 31, 33, 35, 37, 39, 41, 43, 45, 47, 49, 51 and 53 UNDER § 24 OF ARTICLE 2-B OF THE EXECUTIVE LAW

Local Emergency Order:  
Allowing the County to Quickly Respond to the Potential Arrival of Asylum Seekers

I, Edward P. Romaine, Suffolk County Executive, in accordance with a Proclamation of a Local State of Emergency last issued on January 10, 2025, February 7, 2025, March 7, 2025, April 4, 2025 and May 2, 2025 do hereby find and order as follows: Whereas, on August 2, 2021 the Federal Government issued an Order pursuant to 42 U.S.C. secs. 362 and 365 (the “Title 42 Order”) prohibiting migration into the United States by “covered noncitizens” traveling from Canada or Mexico; and Whereas, the Title 42 Order expired on May 11, 2023 and upon its expiration, an anticipated surge of migration into the United States commenced resulting with the imminent arrival of individuals into New York State at an increased rate; and Whereas, Suffolk County recognizes that the anticipated uncoordinated moving of people into the County of Suffolk will result in a severe housing crisis as a result of the limited number of temporary and permanent housing available in the County.

Now, therefore, I, Edward P. Romaine, Suffolk County Executive by the power vested in me by the Suffolk County Charter and the Laws of the State of New York and pursuant to Section 24 of Article 2-B of the New York State Executive Law, do hereby temporarily suspend or modify any statute, local law, resolution, order, rule or regulation or parts thereof, if compliance with such statute, local law, resolution, order, rule or regulation would prevent, hinder or delay action necessary to assist, aid or cope with the aforementioned State of Emergency, and I hereby order the following:

A. The formation of an intergovernmental team (the “intergovernmental team”) that includes the Chief Deputy County Executive, which shall coordinate to assist in meeting the needs of the County as a result of any potential housing crisis in the County.

B. All County Departments are required to work with the County Executive's office to effectuate any emergency measures that need to be addressed as a result of this Order.

C. No hotel, motel, owner of a multiple dwelling, or shelter in Suffolk County is permitted to contract or otherwise engage in business with any other municipality (an “external municipality”) for the purpose of

providing housing or accommodations for asylum seekers without the permission or coordination of Suffolk County. This prohibition extends to any person or entity participating in an external municipality's government program, or a contract or service funded by an external municipality or acting on behalf of any external municipality or the State of New York.

D. In order to effectuate Suffolk County's role in this emergency, all procurement policies for the purchase of equipment, supplies or contracts, relating to this emergency, are suspended, specifically: Suffolk County Code Chapters 1065 and 189; Article IV sections A 4-13 and 14; Article V section A5-1; Charter section C5-2 (C) and (L); and Section A5-8, Chap. 575, Chap. 803, Chap. 353 and Local Law 41-2013 to the extent that they require execution of documentation of compliance; and all related procurement laws, rules, and regulations required to comply with this Emergency Order.

E. Regardless of any other remedy or relief brought by the County for any violation, the County Executive is authorized to direct the County Attorney to commence actions or proceedings in the name of the County, in a court of competent jurisdiction, to abate any violation of, or to enforce any provision of this Emergency Order.

F. Remedies Not Exclusive.

a. No remedy or penalty specified in this Emergency Order shall be the exclusive remedy or remedy available to address any violation described in this Executive Order.

- all related procurement laws, rules, and regulations required to comply with this Order; and further

Order, that the County Executive or his designees shall continue to have the authority to enter into any contract deemed necessary to address the threat posed by these storms; and further

Order, that all Suffolk County Departments, Agencies, and Divisions or other duly authorized law enforcement agencies take whatever steps are necessary to assist in performing such emergency measures as deemed necessary.
