If that famously fickle love/hate conundrum ever once found a perfect Shangra La for coexistence, it surely must have been during the era of McClain County's once glorious, but long forgotten Broomcorn Dynasty.

Loved, because broomcorn was one of the pure and unalterable cash crops. The livestock wouldn't eat it and it had no value as a material

resource around the farm. All you could do with it was to sell it and pocket the cash, a quality that made it immeasurably popular with owners of sharecropper farms—But, often hated by the sharecropper himself. But, ironically, loved by the harvesters, known as Johnnys, because of the five star

The weather is about as fickle as my computer at work.


You never know what's going to happen with my computer, but most of the issues are probably pilot error.

We were fortunate to receive 6.1" of rain in June with temperatures well below normal. Early in the month the lows were in the low to mid 50s.

Over the years it hasn't been out of the realm of possibility for the lows to be around 90.

Yet with all our wet and unseasonably cool temperatures the National Oceanic and Atmospheric Administration (NOAA) reports June in the

# Prioritizing infrastructure

### **Congressman Tom Cole**

Infrastructure is a topic that has been getting a lot of attention in recent weeks and months, especially after President Joe Biden rolled out a proposal earlier this year and with ongoing negotiations for actual legislation in Congress.

Certainly, all Americans can agree that maintaining, repairing and improving infrastructure benefits everyone.

Unfortunately, Democrats and President Biden have become fixated on "human infrastructure," insisting that many social programs should be included in any future infrastructure package.

Although I hope that Democrats will not ultimately go through with undercutting traditional infrastructure needs related to roads, bridges, waterways, rail and air, it is worth noting that lawmakers in Congress have already been steadily investing in traditional infrastructure programs year after year.

This little-known-fact of Congress' responsible track record is thanks to the work originating in the Appropriations Committees in both chambers.

As a member of the House created. Appropriations Committee, I am proud that our panel and other committees have worked across the aisle and in coordination with the U.S. Department of Transportation (DOT) led by multiple presidents to deliver on significant and increased annual funding for the nation's most critical infrastructure needs.

Indeed, lawmakers have worked together to increase funding for traditional infrastructure projects every year.

Since fiscal year 2016, investments in infrastructure and related safety enhancements for roads, bridges, airports, transit and ports have been increased dramatically.

For example, annual funding for infrastructure projects through the Federal Highways Administration alone have increased by nearly \$6 billion and at the Federal Transit Administration by more than \$1.3 billion. Targeted grants for roads on tribal and other federally significant lands have also seen an increase of \$100 million.

In addition, entirely new programs to invest in our deep water ports and to repair bridges across the country have been

Investments such as these have certainly contributed to getting projects in communities across the country critical funding they need – without having to wait on a comprehensive infrastructure package to get to the president's desk.

In fact, Oklahoma's Fourth Congressional District has been the direct beneficiary in recent weeks of broader investments in funding for DOT infrastructure grants led by the Appropriations Committees.

First, it was announced at the end of June that two large highway projects will receive \$100 million in funding through DOT's incredibly competitive Infrastructure for Rebuilding America (INFRA) grant program.

This funding will go toward the I-40 Douglas Interchange project and the I-35 Red River Bridge project to greatly improve and strengthen the ability to move both people and freight in vital commuter and trade corridors while increasing travel safety statewide.

I was delighted to join Senator Jim Inhofe in personally



The Oklahoma Department of Environmental Quality (DEQ) and the U.S. Environmental Protection Agency (EPA) will begin a Five-Year Review of the Hardage-Criner Superfund Site this month. The purpose of the Five-Year Review is to determine whether the site remedy remains protective of human health and the environment; with the methods, findings, and conclusions of the review documented in a report. The final report will be available to the public March 2022. This will be the fifth Five-Year Review for this site. Five-Year Reviews are required when waste is left in place; in this case, waste was consolidated and capped onsite.

The Hardage-Criner Superfund Site is located ¾ mile west of Criner, in McClain County, Oklahoma on State Highway 122 (aka 180th Street). The site operated as an industrial hazardous waste disposal facility from 1972-1980. In 1979, EPA investigations and inspections indicated poor waste management practices by the owner/operator posed threats to human health and the environment. In 1980, the site was closed. The site was proposed for the National Priorities List (NPL) in October 1981 and placed on the NPL in September 1983. Litigation from 1980-1989, resulted in 35 potentially responsible parties (PRPs) being ordered to implement the remedy to address the contamination. Prior to the remedy imple-

The Hardage-Criner Superfund Site is under the jurisdiction of the United States District Court of Western Oklahoma, and operates under a 1990 Court Order and amendments. The remedial objectives are to control the surface water pathway, preclude site access and direct contact with the waste, control air emissions from the source areas, and preclude the use of affected ground water.

In September 1995, the following actions were completed as part of the remedial process; (1) a RCRA compliant composite cap was placed over source areas to prevent direct contact with wastes and to control surface water flow in source areas, (2) a V-shaped interceptor trench was constructed to provide control of the source areas by capture and removal of affected ground water, (3) Southwest interceptor wells were installed to prevent migration of affected ground water into North Criner Creek, (4) permanent vertical recovery wells were installed in the former waste areas to extract liquids for off-site treatment by incineration and disposal, (5) a water treatment system was installed to treat ground water collected from the V-trench and recovery wells, (6) and ground water and surface water monitoring systems were installed in order to assess the effectiveness of the remedial actions.





# Preventing summer fish kills

The suddenness with which a low oxygen fish kill happens can leave pond owners in shock. Fish that were healthy and active one day are dead the next. A little effort put into preventing fish kills can be very worthwhile.

The first line of defense against summer fish kills is working to reduce factors which lead to low oxygen levels. In summer, the most common cause of low oxygen and die-off of algae.

It is normal and healthy for pond water to have a green color due to the presence of microscopic algae. However, when excess phosphorous and other fertilizers run-off into a pond, the growth of algae skyrockets, leading to die-off

As the dead algae decays, Extend the harvest season it rapidly uses up the pond's scarce supply of oxygen and the fish, especially the bigger fish, have a hard time getting enough oxygen to survive.

> Continuous aeration systems are not recommended as the first line of defense against low oxygen problems. They have their place, but can be costly or of little to no benefit, pond you have.

To be effective, multiple units are usually needed, and must be correctly installed and runoff into the pond, then exmaintained. All such systems plore the pros and cons of an a disastrous fish kill.

require maintenance and eventually replacement.

Calculate the cost of running electricity to the pond and the electricity itself before committing to an aeration system. An experienced aeration equipment provider is needed to insure proper installation and application.

Head off a summer fish kill by following these steps:

On a sunny day, lower a secchi disk or other white object into the pond and measure the depth at which it disappears. involves the excessive growth If it disappears at less than 12 inches, your pond is at a high risk.

If it disappears at between 12 and 18 inches, your pond is at intermediate risk. If it disappears at 18 or more inches or your pond is muddy, then you are at low risk. Repeat this check throughout the growing season.

To reduce the risk of a fish kill, you should always be aware of any nutrients that might eventually wash down into the pond and do everything you can to reduce the amount of nutrients reaching the pond.

Phosphorus is generally the main culprit in causing large algae blooms and we can reduce the risk by trying to reduce phosphorous runoff purchase options or instructions if they are undersized for the from lawns, livestock and other

If you absolutely cannot reduce excess phosphorous

aquatic dye, like Aquashade, to reduce algal abundance by reducing light levels.

If the pond is at high risk, have a means of emergency aeration on hand and ready to go. Keep a pump set, boat motor, brush hog or other means of getting oxygen into the water on short notice.

Anything that can be done to break the water into droplets will allow it to absorb oxygen and create a small refuge in which fish may survive until the algal bloom is reestablished and can once again produce oxygen.

Check your pond at dawn for signs of fish mouthing or "piping" at the surface. This indicates that they are stressed by lack of oxygen. On an average day oxygen in a pond will be lowest at dawn. A change in color of the

pond and perhaps formation of a surface scum or film often indicates an algal die-off. If you experience either sign and observe fish strongly piping at the surface, begin aerating and discuss the situation with a fisheries biologist.

In some cases, up to two weeks of continuous emergency aeration may be needed for algal populations to recover and once again produce oxygen.

Understanding how algal die-off fish kills happen, doing regular pond checks and being an active pond manager will greatly reduce your chance of

# **Broomcorn:**

rapidly the actuality, "Out of sight, out of mind," adage materializes came with my very first call. The call to the local agriculture agency only served the 1930s, 40s, and 50s were to reveal that no one in the of- absolutely the most wretched fice was aware that McClain of all farm labor jobs ever County had ever cultivated any such crop

I learned that the one person who might know about the history of broomcorn in this part of the world was out announcing a horse show. I was left with the assurance of a call upon his return. Something I got the very next day.

This courtesy call to confirm that if ever there was a broomcorn industry in McClain County, it left no footprints around his office. The agent on the phone did take my number in case he came across a person or source that might contribute. I never heard back!

Beginning in the 1950s, the worn-down life of broomcorn farming in McClain County was mercifully pushed aside by the infinitely less callous and far more romantic equestrian

Almost overnight, broomcorn fields, once profitable, although, by that time, downtrodden, were being plowed under and sowed with Bermuda and Bluegrass, providing plush green pastures for world class quarter horses. Thus, changing lifestyles and creating a heritage of the more glamorous equestrian culture.

A culture by today's reckoning, that made it all too easy to forget the unimaginable toil and sweat shouldered by our predecessors, the far less celebrated broom corn farmers.

The year was 1950 in the sweltering 100 degree sauna of McClain County, Oklahoma's perennial August sizzling heat

Recognition of just how coupled with exhaustingly high humidity served to create a seething workplace for Broomcorn, "Johnnys."

The broomcorn harvests in existing before or after. It was a positively hellish work environment. However, one which out of blind intent, created an incomparable food extravaganza arranged in country splendor by farm wives drafted into the mix.

The towering fields of eight foot tall broomcorn were concentrated primarily in Grady, Garvin and McClain Counties located along the central part of Oklahoma's South Canadian River Basin.

Rich and wild, while it lasted, the broomcorn dynasty was an amazing, but, short-lived agricultural anomaly. Flourishing during the war years of the 1940s, the Oklahoma broomcorn agricultural industry had completely vanished by the 1960s, replaced by the emerging quarter horse community.

The sudden demise of the broomcorn culture threatened to take with it fragments of the very heart and soul that defines McClain County's zeitgeist, a superlative heritage, tracing back to before statehood and handed down from generation to generation of neighbor helping neighbor.

In ways not to be forgotten, the broomcorn planters proved to be much like their immortalized predecessors, the Boomer/Sooner land rushers whose stay on the land was also short-lived.

But, as with both Boomers/ Sooners, and the broomcorn planters, each left indelible footprints of everlasting quality and aggrandizement of immeasurable proportions.

**Intense Labor: Unintended** 

Perks commonly enjoyed by many of today's workers, such as rest periods, break lounges and coffee setups were all beyond the imagination of the broomcorn Johnnys —Back in the day!

The broomcorn harvest featured a grueling ten or more hours work day, filled with exceedingly frazzled working conditions, too punishing for any remembrance of them to ever be exaggerated. The broomcorn plumes (or heads) shed an insidious shaft with an itchy micro husk which in spite of all efforts to repel, nevertheless always seemed to make its way into every pore of a person's body.

However, the excruciating work aside, the gourmet food extravaganzas which were laid out at mid-day for Broomcorn Johnnys did a lot to overcome the debilitating morning's work in the field. It is not at all clear just how or why broomcorn's gratuitous food rollouts got started.

There were no such accommodative indulgences offered other segments of the farm labor population. There was no such hospitality extended to cotton pickers, corn huskers, sorghum shockers, haymakers, or peanut diggers. The glorious mid-day broomcorn harvest smorgasbord was simply staged without semblance.

Broomcorn's cachet as strictly a cash crop afforded broomcorn growers something of an elitist standing within the farm community. The elitist factor may have prompted a degree of togetherness that led up to the legendary noonday food fest. As well, the need to provide a little something extra in order to attract the often hard to recruit broomcorn Johnnys could also have been a contributing factor to their recruitment.

In any case, the glorious noonday food fest made up for a lot of the broomcorn Johnny's inglorious forenoon sweat in the sweltering fields. Broomcorn harvest field hands for the most part, were day jobbers in desperate need of greenbacks.

The currency with which they were paid at day's end was often counted out directly from the bib of the blue striped overchange in the industry that a mask
