### Pettis County meth bust gets drugs, guns and cash

Two people have been charged after more than

two pounds of methamphetamine and nearly \$20,000 were found during a search warrant earlier this week.

On Monday, April 26, the Pettis County Sheriff's Office and members of the Mid-Missouri Drug Task Force executed a narcotics search warrant in the 2900 block of Oak Ridge Circle in Pettis

**Bridges** County. During the search, two ounces of methamphetamine, scales and two handguns were found. Nearly \$20,000 in currency was also seized. David Lee Bridges, 47, and Audrey Eloise Bridges, 47, both of the residence, were arrested and placed on a 24-hour hold.

The following day, another search warrant on a storage shed in Sedalia and a residence on Marigold Lane just south of Sedalia yielded an additional two pounds of methamphetamine at the residence and more currency in the storage shed.

With the additional quantity of meth, the offense will be raised to first-degree trafficking and possession of a fire-

arm by persons prohibited.

In March, **Pettis County** Detective Shawn Apel initiated a drug investigation aimed at methamphetamine trafficking within the borders of Pettis County. The intelligence he gathered resulted in the original search warrant.

"Deputy Apel had identified a

potential target and he took numerous investigative steps proactively on his own," said Sheriff Brad Anders. "He got the help of some of our Mid-Missouri Drug Task Force detectives, and they were able to build a very solid case, enough to have a search warrant issued."

David Lee Bridges and Audrey Eloise Bridges were both charged with second-degree drug trafficking, endangering the welfare of a child involving drugs and unlawful possession of a firearm.

## More S-C students taking Seal of Biliteracy

More than a dozen Smith-Cotton High School students are participating in testing to earn the Seal of Biliteracy.

The Seal of Biliteracy is a program that allows juniors and seniors to be certified as bilingual and multilingual.

"Being bilingual in itself is pretty impressive," said ESOL Teacher Melissa Lackey, who oversees the program. "So, it's (the Seal of Biliteracy) to give these kids some recognition."

In the past, Lackey said she believes S-C had six students in at any given time as candidates for the program. This year, the number is 20. According to information from Sedalia School District 200,

the previous high number was seven in 2018.

Lackey said she thinks more students became aware of it after several presentations were given to the student body about the Seal of Biliteracy.

In addition to whichever language they are taking, the students need an English language requirement, Lackey noted. The students take a second test in whatever language they are also fluent in. The testing is available in languages such as Spanish, Russian, German and French.

"If the language is not available through the testing services that we use, we have to do a portfolio," Lackey said. "And that's where we're gonna start needing more and more community involvement because we have many languages that are not tested."

Lackey said tests are not available in Ukrainian and Moldova, which affects two of her students.

"(The portfolio) requires a listening, a speaking, a written, and a reading portion," Lackey said. "(Then) we have to find a native speaker to evaluate."

At the time of graduation, students in the program have to meet graduation requirements, including completing 50 hours of community work using their bilingual skills and writing an essay about the socio-economic importance of being bilingual.

The Democrat spoke with four S-C Seal of Biliteracy students: Carmen Cinta, whose

native language is Spanish; Adelina Kukosh, who is Moldovan; Daryna Matsko, who is Ukrainian; and Makaio Cook. All four are either continuing with testing or are waiting for

testing results. Everyone except Cinta learned a language they had no prior experience with and everyone except Cook had to learn English as a child. They all agreed it is easier for children to learn another language than adults.

Cook decided to learn German, inspired by her great-grandparents, who immigrated from Germany. Cook noted it took her three years to learn German.

Kukosh and Matsko both attended a local Russian Church, the Savic Baptist. As a result,

they both learned English and Russian at the same time. Matsko explained her parents encouraged them to learn Russian to communicate with her Russian-speaking relatives.

Several of the students described the test-taking process as stressful. Kukosh said the first two parts of the test, reading and listening, were easier and the speaking and writing were more difficult.

"The speaking (portion for Russian) kind of tricked me... once in a while 'cause I'm more used to speaking in Ukrainian at home, that's like the main language that we speak," Matsko said.

Kukosh said she thinks the writing portion would be the most difficult for everybody.

### US indicts 3 on hate crime charges in death of Ahmaud Arbery

WASHINGTON (AP) — The Justice Department brought federal hate crimes charges Wednesday in the death of Ahmaud Arbery, charging a father and son who armed themselves, chased and fatally shot the 25-year-old Black man after spotting him running in their Georgia neighborhood.

Travis McMichael and his father, Gregory, were charged along with a third man, William "Roddie" Bryan, with one count of interference with civil rights and attempted kidnapping. The McMichaels are also charged with using, carrying and brandishing a firearm during a crime of violence.

The case is the most significant civil rights prosecution undertaken to date by the Biden administration Justice Department and comes as federal officials have moved quickly to open sweeping investigations into troubled police departments as civil rights takes center stage among the department's priorities.

The indictment charges that the McMichaels "armed themselves with firearms, got into a truck and chased Arbery through the public streets of the neighborhood while yelling at Arbery, using their truck to cut off his route and threatening him with firearms." It also alleges that Bryan got into a truck and then chased Arbery, using the vehicle to block his path.

Arbery, 25, was killed on Feb. 23, 2020, by three close-range shotgun blasts after the McMichaels pursued him in a pickup truck as he was running through their neighborhood. Arbery had been dead for more than two months when a cellphone video of the shooting was leaked online and a national outcry erupted.

The Georgia Bureau of Investigation took over the case the next day and swiftly arrested

Travis McMichael, who fired the shots, his father, and Bryan, a neighbor who joined the pursuit and took the video. The three men remain jailed on state murder charges and are due back in

court in May. S. Lee Merritt, an attorney for Arbery's mother, Wanda Cooper-Jones, applauded the hate crimes charges Wednesday, tweeting that the federal case would "serve as a fail-safe to the state prosecution."

"Hate claimed Ahmaud's life," Merritt tweeted. "Our justice system must combat intolerance."

The McMichaels' lawyers have said they pursued Arbery, suspecting he was a burglar, after security cameras had previously recorded him entering a home under construction. They say Travis McMichael shot Arbery while fearing for his life as they grappled over a shotgun.

Local prosecutors have said Arbery stole nothing and was merely out jogging when the McMichaels and Bryan chased him.

The Justice Department alleges that the men "used force and threats of force to intimidate and interfere with Arbery's right to use a public street because of his race."

In pretrial court hearings in Georgia, prosecutors have presented evidence that racism may have played a role

in the man's death. Last June, an agent with the Georgia Bureau of Investigation testified Bryan told investigators that Travis McMichael uttered a racist slur right after the shooting as he stood over Arbery, who was bleeding on

the ground. "Mr. Bryan said that after the shooting took place before police arrival, while Mr. Arbery was on the ground, that he heard Travis McMichael make the statement, 'f--ing n--er,'" GBI agent Richard Dial testified.

Travis McMichael's attorneys have denied that he made the remark.

During a bond

hearing in November, prosecutors introduced evidence that Travis McMichael had used racist slurs in a text message and on social media.

At the time Arbery was killed, Georgia was one of just four U.S. states without a hate crimes law. Amid the outcry over his death, Georgia lawmakers quickly passed a law allowing for an additional penalty for certain crimes found to be motivated by a victim's race, color, religion, national origin, sex, sexual orientation, gender, or mental or physical disability.

The men charged with murdering Arbery won't face hate crime penalties at the state level because the law was changed after the killing.

Georgia Attorney General Chris Carr said the state case remained a priority, and he commended "this positive development and the continued push to get answers for Ahmaud's family, community and our state."

Attorneys for Travis McMichael said they were disappointed "that the Justice Department bought the false narrative that the media and state prosecutors have promulgated."

"There is absolutely nothing in the indictment that identifies how this is a federal hate crime and it ignores without apology that Georgia law allows a citizen to detain a person who was committing burglaries until police arrive," attorneys Bob Rubin and Jason

Sheffield said. Gregory McMichael's attorneys, Frank and Laura Hogue, did not immediately respond Wednesday to an email seeking comment and Bryan's attorney, Kevin Gough, said he had no immediate comment because he had not read the federal indictment.

### **Satellites show world's glaciers** melting faster than ever

Glaciers are melting faster, losing 31% more snow and ice per year than they did 15 years earlier, according to three-dimensional satellite measurements of all the world's mountain glaciers.

Scientists blame human-caused climate change.

Using 20 years of recently declassified satellite data, scientists calculated that the world's 220,000 mountain glaciers are losing more than 328 billion tons (298 billion metric tons) of ice and snow per year since 2015, according to a study in Wednesday's journal Nature. That's enough melt flowing into the world's rising oceans to put Switzerland under almost 24 feet (7.2 meters) of water each year.

The annual melt rate from 2015 to

2019 is 78 billion more tons (71 billion metric tons) a year than it was from 2000 to 2004. Global thinning rates, different than volume of water lost, doubled in the last 20 years and "that's enormous," said Romain Hugonnet, a glaciologist at ETH Zurich and the University of Toulouse in France who led the study.

Half the world's glacial loss is coming from the United States and Canada.

Alaska's melt rates are "among the highest on the planet," with the Columbia glacier retreating about 115 feet (35 meters) a year, Hugonnet said.

Almost all the world's glaciers are melting, even ones in Tibet that used to be stable, the study found. Except for a few in Iceland and Scandinavia that are fed by increased precipitation, the melt rates are accelerating around the world.

## Biden speech takeaways: Government is good, and so are jobs

WASHINGTON (AP) President Joe Biden is using his first address before a joint session of Congress to make the case that his administration has made progress during the first 100 days he's been in office, confronting the public health and economic maelstrom caused by coronavirus pandemic.

Biden is also using the prime-time address to make his pitch directly to Americans for his expansive — and expensive — vision to rebuild the nation's roads, bridges, water pipes and other infrastructure, bolster public education and extend other benefits for a wide swath of Americans.

Here are some key takeaways from the president's address:

#### **BIDEN'S FOUR-LETTER WORD: JOBS**

Biden uttered the word "jobs" a whopping 43 times, according to his prepared text.

It's perhaps no surprise for an administration that has made beating backing the pandemic and getting Americans back to work the central guideposts in the early going of the administration.

Biden noted that the economy has gained some 1.3 million new jobs in the first few months of his administration — more than any in the first 100 days of any presidency. But he quickly pivoted to the need to pass his American Jobs Plan if the country is going to sustain momentum and get back to the historic low levels of unemployment prior to the pandemic.

He also aimed to frame

his push for the U.S. to meet its international obligations to slow the impact of climate change as, ultimately, a jobs plan.

"For too long, we have failed to use the most important word when it comes to meeting the climate crisis," Biden said. "Jobs. Jobs. For me, when I think about climate change, I think jobs."

#### **WHO TURNED** THE TIDE?

Biden said "America's house was on fire" when he took office, citing the devastating COVID-19 pandemic, its damaging economic impacts and the Jan. 6 insurrection at the Capitol.

"Now — after just 100 days — I can report to the nation: America is on the move again," Biden said, adding the nation is now "turning peril into possibility. Crisis into opportunity. Setback into strength."

It's a tried and true strategy by the president to take credit for the more hopeful moment, as the coronavirus vaccines have provided a path out of the pandemic.

Republicans, meanwhile, made it clear they see things differently, with Sen. Tim Scott, R-S.C., implicitly crediting President Donald Trump for the Biden's good fortune.

"This administration inherited a tide that had already turned," he said in prepared remarks from the official GOP response to Biden's address. "The coronavirus is on the run!"

From polling, it's clear Biden's view is winning the day — at least thus far — with more Americans approving of his job performance than ever did of Trump, with strong marks even from Republicans for handling the pandemic.

#### **MAKING THE CASE FOR BIG** GOVERNMENT

Biden made the full-throated case for an American embrace of big government.

The president ticked off details of some of his plan for \$1.8 trillion in spending to expand preschool, create a national family and medical leave program, distribute childcare subsidies and more.

The plan comes on top of his proposal for \$2.3 trillion in spending to rebuild roads and bridges, expand broadband access and launch other infrastructure projects.

Republicans have shown little interest in Biden's spending plan. Senate Majority Leader Mitch McConnell has argued that Biden's plans are a "Trojan horse" that will lead to middle-class tax hikes.

But Biden and his aides say all of this new spending is wise investment in Americans — and doable in time of low interest rates. Much of it can be paid through raising taxes on the wealthy and would go a long way toward addressing the frailties of life for the middle class and working poor exposed by the pandemic, Biden argues.

"I'm not out to punish anyone," Biden said. "But I will not add to the tax burden of the middle class of this country."

While achieving bipartisan backing in Washington for the proposals is a longshot, Biden seems to be betting he can win support across the electorate.

He even made a thinlyveiled bid to blue-collar and non-college-educated white men who voted for Trump in November, noting that 90% of the infrastructure jobs that will be created by his spending plans don't require a college degree and 75% don't require an associate's degree.

"The Americans Jobs Plan is a blue-collar blueprint to build America," Biden said. "And it recognizes something I've always said: Wall Street didn't build this country. The middle class built this country. And unions built the middle class."

#### 'REAL' RACIAL **JUSTICE**

A week after former Minneapolis police officer Derek Chauvin was convicted in the killing of George Floyd, and as the nation continues to grapple with deadly interactions between Black men and police, Biden called on Congress to meet the moment.

"We have all seen the knee of injustice on the neck of Black America," Biden said, referencing Floyd's death at Chauvin's hand. "Now is our opportunity to make real progress."

Biden called on Congress to send him a police reform bill named after Floyd by the one-year anniversary of his death, May 25. But he also went further, saying he aimed to root out systemic racism in housing, education and

public health.

"We have a giant opportunity to bend the arc of the moral universe toward justice," said Biden. "Real justice."

#### **WE HAVE TO PROVE DEMOCRACY** STILL WORKS'

Biden said that while the nation's democracy survived the deadly Jan. 6 insurrection at the Capitol meant to block the certification of his election, leaders in Washington must do more to boost the resilience of the nation's system of government.

Biden said the nation's adversaries "look at the images of the mob that assaulted this Capitol as proof that the sun is setting on American democracy." He said they view the U.S. as too riven by hostility to effectively govern.

"We have to prove them wrong," he said. "We have to prove democracy still works. That our government still works — and can deliver for the people."

It was a familiar refrain for Biden, who has sounded alarm about the nation's divisions for years, but the urgency spiked after Jan 6.

Still, the appeal for unity appeared unlikely to sway many minds in Congress. Republicans have already lined up in opposition to Biden's agenda and the push for a bipartisan commission to probe the insurrection has struggled to gain support.

#### TRUMP WHO?

The president who campaigned on a promise to substantively and stylistically move the country past Trump made no direct mention of the 45th president.

Instead, he spoke only of the "last administration," blaming Trump and his team for abandoning an effort made by his old boss — Barack Obama — to financially assist the Northern Triangle nations in central America. Migrants are now fleeing from those countries — El Salvador, Guatemala and Honduras — and arriving at the U.S. border.

In some ways, the absence of talk about Trump, who still falsely claims the election was stolen from him, isn't surprising. Biden grumbled at a CNN town hall in February that he's "tired of talking about Trump" and he wants to make the next four years about the American people.

His omission made clear he's determined to move on.

#### Missouri Senate tables bill to invalidate federal gun laws

JEFFERSON CITY, Mo. (AP) — The Missouri Senate has tabled a bill to invalidate federal gun laws after pushback from Democrats who said the proposal would threaten partnerships between local and federal authorities.

The bill seeks to invalidate federal laws or other actions deemed to infringe on a person's Second Amendment right to bear arms, the St. Louis Post-Dispatch reports.

Sponsor Sen. Eric Burlison, a Battlefield Republican, said it would allow individuals to sue local police departments and governments if their action "knowingly deprives a citizen of Missouri of the rights or privileges ensured by" the Second Amendment. A \$50,000 civil penalty could be awarded.

"Those politicians in Washington, D.C., can pass, and are attempting to pass, whatever crazy, wild-eyed ideas that they have. But with this law in place, Missouri will have nothing to do with what they pass," Burlison said.

Local law enforcement has voiced concerns, saying an earlier version of the bill could imperil local officials' ability to work with federal authorities.

Critics of similar proposals have said courts have ruled that federal laws cannot be nullified by the states.

#### **Police: Person found dead at suburban Kansas City house**

INDEPENDENCE, Mo. (AP) — Police in suburban Kansas City were investigating after a person was found dead outside a home early Wednesday morning in

Officers were called around 1:50 a.m. to the house along South Crescent Avenue for reports of gunfire, police said. Arriving officers found a person dead outside the home. The victim's name was not immediately released.

Police blocked off the home and part of the street as they investigated. Officer John Syme, a spokesman for the Independence Police Department, said police were awaiting approval of a search warrant to enter the home and see if anyone was inside.

# **Wary Supreme Court weighs** student's Snapchat profanity case

WASHINGTON (AP) — A wary Supreme Court on Wednesday weighed whether public schools can discipline students for things they say off campus, worrying about overly restricting speech on the one hand and leaving educators powerless to deal with bullying on the other.

The justices, hearing arguments in the case of a 14-year-old high school freshman's Snapchat Fbombs, struggled to fit the need to protect students' political and religious expression with the ability of schools to get at disruptive, even potentially dangerous, speech that occurs outside the school setting.

In one of many examples members of the court offered, Justice Elena Kagan described boys who keep a sexually charged online ranking of girls based on their looks. "You can't put people in jail for commenting on people's appearance, but shouldn't a school be able to deal with it?" Kagan asked.

The court tested out possible outcomes in the case of the student's profanity-laced social media rant, which Justice Brett Kavanaugh described as her blowing off steam just like "millions of kids" do.

Kavanaugh is one of several justices who have children in high school, or recently did. The court heard just under two hours of arguments by

telephone because of the coronavirus pandemic, well beyond the allotted 60 minutes.

The current dispute stems from Tinker v. Des Moines, the Vietnam-era case of a high school in Des Moines, Iowa, that suspended students who wore armbands to protest the war. In a landmark ruling, the Supreme Court sided with the students, declaring students don't "shed their constitutional rights to freedom of speech or expression at the schoolhouse gate."

The court also held then that schools retained the authority to restrict speech that would disrupt the school environment.

At the center of this case is Brandi Levy of Mahanoy City, Pennsylvania.

Levy and a friend were at a convenience store when she used Snapchat to express her frustration at being kept on her high school's junior varsity cheerleading squad for another year.

"F——— school f--- softball fcheer f——— everything," Levy wrote, in a post that also contained a photo in which she and a classmate raised their middle fingers. A second post questioned how an incoming freshman could have made the varsity.

The posts were brought to the attention of the team's coaches, who suspended Levy from the cheerleading team for a year. Levy's parents

responded with a federal lawsuit, claiming the suspension violated their daughter's constitutional rights to free speech.

The case's potential importance grew when the 3rd U.S. Circuit Court of Appeals in Philadelphia also sided with Levy and held that schools can't impose discipline for what students say when they're off campus.

American Civil Liberties Union lawyer David Cole, representing Levy, urged the justices to affirm the clean line the appeals court drew, making clear educators have no authority over children when they are not under a school's supervision.

"Expanding Tinker would transform a limited exception into a 24/7 rule," Cole said.

But several justices said the campus border is not so clear in the age of the internet and the remote learning that has come with the pandemic.

"How does that fit with modern technology?" Chief Justice John Roberts asked.

The school district and the Biden administration both argued that the justices should reject the appellate ruling because it draws an artificial line.

Suspending Levy from cheerleading was a reasonable response because she targeted her coaches and a teammate's ability to compete, said Lisa Blatt, representing the district.

Levy is "not somebody

you'd want at the bottom of the pyramid," Blatt said, referring to a cheerleading formation.

But if the court didn't appear ready to embrace Levy's argument, some justices also were concerned that a ruling for the district could give schools too much power to shut down speech they just don't like.

"Kids basically talk to their classmates. Most of their conversation is about school. Most of their exchanges have to do with their perceptions of the authoritarian nature of their teachers and others. And why isn't this any different than just that the coach of this team took personal offense?" Justice Sonia Sotomayor asked, noting that her law clerks told her that among teenagers "how much you curse is a badge of honor."

Kavanaugh also said the coach maybe went too far by suspending Levy.

"But, as a judge and maybe as a coach and a parent, too, it seems like maybe a bit of overreaction by the coach," Kavanaugh said.

By the end of the arguments, there was perhaps a sense among the justices that Levy's case — a teenager venting her unhappiness about an extracurricular program — may not be the best one to use to write a sweeping rule about student speech in the digital age.

A decision is expected by late June.

The near-uniform melting "mirrors the global increase in temperature" and is from the burning of coal, oil and gas, Hugonnet said. Some smaller glaciers are disappearing entirely. Two years ago, scientists, activists and government officials in Iceland held a funeral for a small glacier.

"Ten years ago, we were saying that the glaciers are the indicator of climate change, but now actually they've become a memorial of the climate crisis," said World Glacier Monitoring Service Director Michael Zemp, who wasn't part of the study.

The study is the first to use this 3D satellite imagery to examine all of Earth's glaciers not connected to ice sheets in Greenland and Antarctic. Past studies either only used a fraction of the glaciers or estimated the loss of Earth's glaciers using gravity measurements from orbit.

Those gravity readings have large margins of error and aren't as useful, Zemp said.

Ohio State University's Lonnie Thompson said the new study painted an "alarming picture."

Shrinking glaciers are a problem for millions of people who rely on seasonal glacial melt for daily water and rapid melting can cause deadly outbursts from glacial lakes in places like India, Hugonnet said.

But the largest threat is sea level rise. The world's oceans are already rising because warm water expands and because of melting ice sheets in Greenland and Antarctica, but glaciers are responsible for 21% of sea level rise, more than the ice sheets, the study said. The ice sheets are larger longer term threats for sea level rise.

"It's becoming increasingly clear that sea level rise is going to be a bigger and bigger problem as we move through the 21st century," said National Snow and Ice Data Center Director Mark Serreze.

#### **Complaint: School** violated rules in its response to assault

CLAYTON, Mo. (AP) — The private Fontbonne University in the St. Louis suburb of Clayton is accused in a federal complaint of not doing enough to provide a safe environment in the case of a student who was sexually assaulted just a day after reporting that her dorm room had been burglarized.

The St. Louis Post-Dispatch reports that the woman's lock was changed after she reported that she had awoken two days in a room with her door unlocked. But no report was taken, said her attorney, Laura Dunn.

Then, just days later, on Feb. 25, the woman locked her room and started recording audio as she slept while her suitemate was gone for the night, Dunn said. The recording captured the sounds of two people moving around the room, Dunn said.

"I'm devastated," the student said in the complaint. The Post-Dispatch and The Associated Press normally do not identify victims of sexual assault.

Dunn said the university had violated a federal act that requires campus officials to "evaluate if there is a serious or ongoing threat to the campus community."

Fontbonne said in a statement that it is cooperating with a police investigation but declined to comment on the allegations. Two students are being investigated.

#### **Police: Man fatally** shot on sidewalk near downtown St. Louis

ST. LOUIS (AP) — A man was shot to death on a sidewalk near downtown St. Louis, and detectives are searching for a suspect, police said.

The shooting happened around 9:45 a.m. Tuesday near 14th Street and Chouteau Avenue, according to police. Arriving officers found Eric Rogers, 28, of South City, with several gunshot wounds on the sidewalk near several parked cars. Rogers died at the scene.

The St. Louis Post-Dispatch reported that Rogers' death marked at least 63 homicides in the city so far this year, compared with 47 homicides by the same time last year.

### Feds raid Giuliani's home, office, escalating criminal probe The full scope of the insought a second term.

NEW YORK (AP) — Federal agents raided Rudy Giuliani's Manhattan home and office Wednesday, seizing computers and cellphones in a major escalation of the Justice Department's investigation into the business dealings of former President Donald Trump's personal lawyer.

Giuliani, the 76-yearold former New York City mayor once celebrated for his leadership after 9/11, has been under federal scrutiny for several years over his ties to Ukraine. The dual searches sent the strongest signal yet that he could eventually face federal charges.

Agents searched Giuliani's Madison Avenue apartment and Park Avenue office, people familiar with the investigation told The Associated Press. The warrants, which required approval from the top levels of the Justice Department, signify that prosecutors believe they have probable cause that Giuliani committed a federal crime — though they do not guarantee that charges will materialize.

A third search warrant was served on a phone belonging to Washington lawyer Victoria Toensing, a former federal prosecutor and close ally of Giuliani and Trump. Her law firm issued a statement saying she was informed that she is not a target of the investigation.

vestigation is unclear, but it at least partly involves Giuliani's dealings in Ukraine, law enforcement officials have told the AP.

The people discussing the searches and Wednesday's developments could not do so publicly and spoke to the AP on condition of anonymity. News of the search was first reported by The New York Times.

In a statement issued through his lawyer, Giuliani accused federal authorities of a "corrupt double standard," invoking allegations he's pushed against prominent Democrats, and said that the Justice Department was "running rough shod over the constitutional rights of anyone involved in, or legally defending, former President Donald J. Trump."

"Mr. Giuliani respects the law, and he can demonstrate that his conduct as a lawyer and a citizen was absolutely legal and ethical," the statement said.

Giuliani's son, Andrew Giuliani, told reporters the raids were "disgusting" and "absolutely absurd."

A Justice Department spokesperson did not immediately respond to a request for comment. The U.S. Attorney's office in Manhattan and the FBI's New York office declined to comment.

The federal probe into Giuliani's Ukraine dealings stalled last year because of a dispute over investigative tactics as Trump unsuccessfully

Giuliani subsequently took on a leading role in disputing the election results on the Republican's behalf.

Wednesday's raids came months after Trump left office and lost his ability to pardon allies for federal crimes. The former president himself no longer enjoys the legal protections the Oval Office once provided him — though there is no indication Trump is eyed in this probe.

Trump's spokesman did not immediate respond to questions about Wednesday's events.

Many people in Trump's orbit have been ensnared in previous federal investigations, namely special counsel Robert Mueller's probe of Russian election interference. But most of those criminal cases either fizzled or fell apart. Giuliani's is different.

Giuliani was central to the then-president's efforts to dig up dirt against Democratic rival Joe Biden and to press Ukraine for an investigation into Biden and his son, Hunter — who himself now faces a criminal tax probe by the Justice Department.

Giuliani also sought to undermine former U.S. ambassador to Ukraine Marie Yovanovitch, who was pushed out on Trump's orders, and met several times with a Ukrainian lawmaker who released edited recordings of Biden in an effort to smear him before the election.

Giuliani's lawyer, Robert Costello, said the warrants involved an allegation that Giuliani failed to register as a foreign agent and that investigative documents mentioned John Solomon, a former columnist and frequent Fox News commentator with close ties to Giuliani, who pushed baseless or unsubstantiated allegations involving Ukraine and Biden during the 2020 election.

Phone records published by House Democrats in 2019 in the wake of Trump's first impeachment trial showed frequent contacts involving Giuliani, Solomon and Lev Parnas, a Giuliani associate who is under indictment on charges of using foreign money to make illegal campaign contributions.

Contacted Wednesday, Solomon said it was news to him that the Justice Department was interested in any communications he had with Giuliani, though he said it was not entirely surprising given the issues raised in the impeachment trial.

"He was someone that tried to pass information to me. I didn't use most of it," Solomon said of Giuliani. "If they want to look at that, there's not going to be anything surprising in it."

Everything was sitting "in plain view," Solomon said. He said he believed his reporting had "stood the test of time" and maintained that he was "unaware of a single factual error" in any of his stories.

"The thing is with the writing, you technically have to be a good writer in English too," Kukosh said. "Because like you have to like write paragraphs, and you want them to be advanced, and not like just simple."

Lackey added, "They say listening and reading are the easiest, that's typically how it is even for English learners."

Lackey explained writing and

speaking is where students struggle, even for native speakers.

Cinta said she thinks the Seal of Biliteracy is a "really great opportunity," although she explained she struggled with the English part of the testing. Cinta added she sometimes thinks in Spanish, such as in English class, just because "it makes more sense."

"Even today... sometimes, even with only two languages, it's hard," Cinta said. "Because in the house you're speaking Spanish, like full on, and then you come here and then you have to like change. And so, sometimes, you

mess up the words because... (the words) are similar to English."

Both Kuhosh and Matsko said they also get mixed up with their languages.

Students involved in Seal of Biliteracy get college credit for receiving their Seal, according to Lackey, and it can improve their chances in the workplace.

"What I think is most important about it is that we get the word out that being bilingual and multilingual is a valuable skill and they should be proud of it," Lackey said.

# **AP analysis: The expected COVID** baby boom may be a baby bust

NEW YORK (AP) — When most of the U.S. went into lockdown over a year ago, some speculated that confining couples to their homes — with little to entertain them beyond Netflix — would lead to a lot of baby-making. But the statistics suggest the opposite happened.

Births have fallen dramatically in many states during the coronavirus outbreak, according to an Associated Press analysis of preliminary data from half the country.

The COVID-19 baby boom appears to be a baby bust.

Nationally, even before the epidemic, the number of babies born in the U.S. was falling, dropping by less than 1% a year over the past decade as many women postponed motherhood and had smaller

But data from 25 states suggests a much steeper decline in 2020 and into 2021, as the virus upended society and killed over a half-million Americans.

Births for all of 2020 were down 4.3% from 2019, the data indicates. More tellingly, births in December 2020 and in January and February 2021 — nine months or more after the spring 2020 lockdowns — were down 6.5%, 9.3% and 10% respectively, compared with the same months a year earlier.

December, January and February together had about 41,000 fewer births than the same threemonth span a year earlier. That's an 8% decline.

"When there's a crisis, I don't think people are thinking about reproduction," said Dr. John Santelli, a Columbia University professor of population and family health who reviewed the AP's analysis.

The analysis included 24 states that provided data on births to residents. Joining them in the analysis was California, the most populous state, which provided data on all births that happened in the state, including among

The Centers for Disease Control and Prevention is expected to provide a national picture later this year. But the data for the 25 states is not expected to change substantially; preliminary birth numbers usually end up being pretty close to the final counts, experts say.

The AP's findings echo projections by researchers at the Brookings Institution and elsewhere, who have predicted a sizable drop in births this year.

"The widespread consensus is there is going to be a decline," said Hans-Peter Kohler, a University of Pennsylvania researcher who focuses on fertility and health.

It didn't look that way to some around March 2020, when much of America was cooped up inside. Some figured that couples had more time together and that some men and women might find it harder to run out and get birth control, leading to at least a small uptick in births.

For Bryan and Katie Basamanowicz, it was more complicated than that.

The couple had planned to try to have a baby last summer to provide their son, Simon, with a younger sibling, but then came COVID-19 and the lockdown.

For a time "it was so intense and scary" that the couple thought they would have to put off trying to conceive, said Bryan, 39, a managing editor at a small publishing house who lives in Ventura, California.

But then a lull occurred in the early summer, as the first wave of COVID-19 illnesses waned and lockdowns were eased. The couple decided to try after all. Then cases started

surging again.

"We decided: 'Let's put this on hold," said Katie, a 32-year-old teacher. But it turned out to be too late: A pregnancy test came back positive in early July. "We were already pregnant," she said.

Fritz Basamanowicz was born last month, on March 6. The pregnancy was a worry-filled experience because expectant mothers run a greater risk of severe illness from the virus.

"I'm very thankful that we made it through," Katie said.

New York, the deadly epicenter of the U.S. outbreak in the spring of 2020, was not part of the analysis. Its Health Department said the figures were not available.

A majority of the babies born in 2020 were, of course, conceived in 2019, before the virus took hold in the U.S., so the numbers partly reflect the pre-existing downward trend.


But births in December 2020 declined in 23 of the 25 states from the same month a year earlier, the exceptions being Alaska and Wyoming. They dropped about 11% in Massachusetts and Virginia; 10% in California; and 7% in Florida, Illinois, Indiana and Nevada.

Declines were even more dramatic in January 2021 in many of the 25 states.

### Networks realize draft drama without frills sometimes best

Producer Charlie Yook and NFL Network didn't have their own draft broadcast last year, but he was able to glean a couple of things from last year's joint effort with ESPN.

The biggest is when it comes to the draft, sometimes simple works best and that it is OK to combine resources.

"I think we learned that there's no point in having three cameras in one kid's house. It's also OK to be a little more casual for lack of a better word," he said. "Shots don't have to be with all these jillion dollar cameras. It can be done with iPhones. And I think it's the last year taught if anything, it's more important to be seen and heard with family than anything else."

While 12 prospects will be in Cleveland waiting to be

### Jarvis' ironman streak could be next major NHL record broken

After Patrick Marleau passed Gordie Howe last week for the most games played in NHL history, the ironman streak of Doug Jarvis could be the next milestone to fall.

Jarvis played in a record 964 consecutive games — every game for 12 full seasons from 1975 through 1987 on three different teams while raising the Stanley Cup four times with Montreal.

Florida's Keith Yandle, Marleau and Arizona's Phil Kessel are all less than a full season away from passing Jarvis. Now 66 and an adviser for the Vancouver Canucks, Jarvis is rooting for his record to be broken.

"They all have a pretty good opportunity that they will bypass 964, I would think," Jarvis said. "I'm happy for them. To be able to play in the game of hockey at the NHL level for all those years and those games and to really basically avoid injury, I think that's tremendous."

Yandle is the front-runner, 47 games back of Jarvis at age 34 with two seasons left on his contract. The defenseman has credited his parents for his work ethic.

"I'm lucky every day just to be playing in the NHL and calling this a job," Yandle said in March before playing his 1,000th regular-season game. "Never really thought I'd even make it to the NHL, so it's one of those things where I'm just

kind of enjoying the ride and enjoying every minute of it."

Marleau is 62 games behind, but he turns 42 in September and would need to play another season to have a chance. Before passing Howe's mark of 1,767 games played, Marleau said the same thing keeps him showing up to the rink: "I just love it. There's nothing else like it."

Kessel is 33, won the Stanley Cup twice with Pittsburgh and has a year left on his contract. He is also producing at a high level for the Coyotes, who are in playoff contention.

"I haven't changed anything," Kessel said recently.

"My body's feeling better than it did last year. Whenever your body feels good, it helps a little bit."

Jarvis is feeling good 33 years since his streak ended and he hung up his skates for good.

"I have too many colleagues that have played the game and they're dealing with sore hips and knees and shoulders," Jarvis said. "I'm good — really no issues. I enjoy running. I like to stay active that way. I feel very blessed."

#### **CANADA PLAYOFFS QUESTION**

The NHL won't have to stage its entire postseason in

a quarantined bubble like last year, but Canada's four playoff teams face some questions. If restrictions don't ease north of the border and travel is an issue, the league could consider something like a mini-North Division bubble or move the winner to the U.S. when the playoffs get to the final four.

"It's going to depend on government regulations in terms of where we're going to be able to travel our players and our teams and where we can't," Commissioner Gary Bettman said Tuesday. "If we can't travel in Canada, either as among the provinces or from the U.S. to Canada and back,

we'll make whatever adjustments we have to do to get the playoffs completed. It's wildly unpredictable."

#### TV DOLLARS AND CAP

NHL teams will recoup some pandemic revenue losses with Seattle's \$650 million expansion fee and the money from new U.S. media rights deals with ESPN and Turner Sports. Bettman expects that windfall to help the salary cap increase "sooner than it otherwise would have" but remain at \$81.5 million for probably the next couple of seasons.

"We have a fairly large escrow to be made up, and until we do, the cap is basically flat," Bettman said. "The increase in value obviously is going to shorten the timeframe that perhaps many had projected when we did the return to play for last season and extended the collective bargaining agreement."

# NFL draft could see record run of quarterbacks taken

As soon as the San Francisco 49ers traded three first round picks to move up to No. 3 overall, it became clear that quarterbacks would come off the board at a record pace at the NFL draft.

While QBs are widely expected to go 1-2-3 for just the third time in the common draft era that started in 1967, there are still questions about how many others will follow in the top 10 and first round.

Trevor Lawrence and Zach Wilson are expected to be the top two picks, to Jacksonville and the New York Jets, with the Niners likely choosing among Mac Jones, Trey Lance and Justin Fields at No. 3.

That would match 1971 (Jim Plunkett, Archie Manning, Dan Pastorini) and 1999 (Tim Couch, Donovan McNabb, Akili Smith) as the only drafts with quarterbacks taken with the top three picks.

A record could be set with four QBs going in the top four if Atlanta drafts the successor to Matt Ryan or trades down to a quarterbackneedy team.

If Fields, Jones and Lance all get taken in the top 10, that would also be a first, beating the four top-10 QBs taken in the 2018 draft when Baker Mayfield, Sam Darnold, Josh Allen and Josh Rosen all went off

the board quickly. All five of those QBs are almost assuredly first-round picks, something that also happened in 1999 when the five came off in the top 12, and in 2018 when Lamar Jackson was picked 32nd to join the

four top-10 QBs. If somehow, Kyle Trask, Kellen Mond or Davis Mills go off the board late in the first round, the 2021 draft could match the 1983

class with six first-round QBs.

That class that featured Hall of Famers John Elway, Jim Kelly and Dan Marino, along with Todd Blackledge, Tony Eason and Ken O'Brien, is widely considered the best ever for quarterbacks.

#### **TOP PICKS**

With Lawrence set to be the 26th quarterback to be picked first overall since the merger, quarterbacks will account for exactly half of the top picks since 1970.

This will be the sixth time in the past seven years that a QB went first overall, with Cleveland defensive end Myles Garrett the only other player to break through in 2017.

It wasn't always this way, with a stretch from 1994-97 when the top picks were defensive tackle Dan Wilkinson, running back Ki-Jana Carter, receiver Keyshawn Johnson and tackle Orlando Pace.

There was even an 11-year stretch from 1976-86 when Elway was the only QB to go first overall.

The most popular position besides quarterback to go first overall since the merger is defensive ends with 11, followed by running backs (six), offensive linemen (3), receivers (2), linebackers (2) and defensive tackles (two). There has never been a tight end or defensive back drafted first.

#### **WAITING FOR D**

With most of the teams at the top of the draft appearing to be targeting quarterbacks and other offensive players, this could be the longest wait ever for a defensive player to come off the board.

The latest the first defensive player has gone in the common draft era beginning in 1967 was seventh overall in 1999, when Hall of Famer Champ Bailey was taken by Washington.

As recently as 2019, four of the

first five players drafted came on the defensive side, with Nick Bosa, Quinnen Williams, Clelin Ferrell and Devin White following top pick Kyler Murray that year.

This could also mark the first time since 2012 that a defensive lineman didn't get picked in the top 10. Dontari Poe was the first one off the board that year at No. 11 to Kansas City.

#### RARE TERRITORY

Florida tight end Kyle Pitts could make some draft history this week. If Atlanta picks Pitts at No. 4 overall, he will be highest drafted tight end in the common draft era.

The only time a tight end was picked in the top five came in 1972, when Denver took Riley Odoms fifth overall. Odoms was a two-time All-Pro and four-time Pro Bowler with 396 catches in 12 seasons.

Just 15 tight ends in all have gone in the top 10 in the draft since 1967, with the players doing it in the past 25 drafts being T.J. Hockenson (eighth to Detroit in 2019), Eric Ebron (10th to Detroit in 2014), Vernon Davis (sixth to San Francisco in 2006), Kellen Winslow Jr. (sixth to Cleveland in 2004) and Ricky Dudley (ninth to the Raiders in 1996).

### **DOUBLE TROUBLE**

Alabama is set to have a pair of receivers picked in the first round for the second straight year, with DeVonta Smith and Jaylen Waddle set to follow 2020 first-rounders Henry Ruggs III and Jerry Jeudy.

The only other colleges to have a pair of receivers picked in the first round in the common draft era are 2007 LSU (Dwayne Bowe and Craig Davis), 2007 Ohio State (Ted Ginn Jr. and Anthony Gonzalez), 2001 Miami (Santana Moss and Reggie Wayne) and 1997 Florida (Ike Hilliard and Reidel Anthony).

## AP Source: WR Antonio Brown returning to Bucs on 1-year deal

TAMPA, Fla. (AP) — Receiver Antonio Brown has agreed to return to the Tampa Bay Buccaneers on a one-year contract that could be worth up to \$6.5 million, including incentives, a person familiar with the deal told The Associated Press.

The person spoke on the condition of anonymity Wednesday because the agreement, which includes a \$2 million signing bonus and a little more than \$3 million guaranteed, had not been announced by the reigning Super Bowl champions.

NFL Network was first to report the deal. The Bucs were already

assured of returning all 22 starters from their 31-9 victory over the Kansas City Chiefs in the NFL title game in February. Bringing back Brown ensures Tom Brady will pursue an eighth Super Bowl ring with the entire "band" of offensive playmakers assembled around the 43-year-old quarterback last season.

General manager Jason Licht made good on a promise to keep the team together by placing the franchise tag on receiver Chris Godwin, signing linebackers Shaquil Barrett and Lavonte David to multi-year contracts, and bringing back tight end Rob Gronkowski, running back Leonard Fournette and defensive

tackle Ndamukong Suh

on one-year deals.

Brady and left tackle Donovan Smith contributed to the effort by signing salary-cap- friendly contract extensions that freed money to help Licht

The agreement with Brown comes after the receiver, who joined the Bucs midway through last season after serving an eight-game suspension for violating the NFL's personal conduct policy, settled a civil lawsuit filed against Brown by a former trainer.

Licht was asked last week if Brown resolving the civil dispute would improve the chances of the 32-year-old receiver coming back.

"We've had discussions through the offseason,

and as you can tell we've put an emphasis on bringing back players from last year that contributed to our success, and he would be no different," the GM said. "We'll continue to have talks and see where it goes."

A four-time All-Pro, Brown had 45 receptions for 483 yards and four touchdowns in eight regular-season games in 2020. He caught a TD pass in the Super Bowl, capping a postseason in which he had eight catches for 81 yards and two TDs.

In 139 regular-season games over 11 seasons with Pittsburgh, New England and Tampa Bay, Brown has amassed 886 career receptions for 11,746 yards and 79 TDs.

# **Panthers trading Teddy Bridgewater to Broncos**

ENGLEWOOD, Colo. (AP) — Drew Lock didn't have to wait around for the NFL draft to get the serious competition for his starting job that new general manager George Paton has been promising for months.

Paton traded a sixth-round pick in this weekend's draft to the Carolina Panthers in exchange for veteran QB Teddy Bridgewater on Wednesday.

"Acquiring Teddy Bridgewater adds competition, experience and a strong veteran presence to our quarterback room," Paton said. "He's a talented player and leader who's had success in this league in a number of different situations. Being familiar with Teddy from Minnesota, he's going to compete and do everything he can to help us win."

Paton might not be

done, either. The Broncos own the ninth overall selection Thursday night and have had their eyes on several of the quarterback prospects rated a notch or two below Clemson's Trevor Lawrence and BYU's Zach Wilson, who are expected to go 1-2 to the Jaguars and Jets, respectively.

"We're really high on Drew," Paton said at his pre-draft news conference last week. "I like seeing Drew here every morning when I come in. He's working hard and trending in the right

direction. As you know, he has a lot of talent. I think he's becoming a better pro, but we're still going to look at the quarterback position. I've said since I've gotten here that we want to bring in competition. That's the goal, and we plan on doing that."

Bridgewater became available when the Panthers traded for former Jets QB Sam Darnold three weeks ago.

Bridgewater went 4-11 as the Panthers' starter last year and struggled to win close games down the stretch. He completed 69.1% of his passes, throwing 15 touchdown passes and 11 interceptions.

Those numbers are better than Lock's.

The third-year pro from Missouri tied for the league lead with 15 interceptions in 13 starts and his passer rating ranked 32nd in the NFL last season. He was 4-9 overall with 16 touchdown throws and is 8-10 in two years as Denver's starter.

After missing most of his rookie season with a thumb injury on his throwing hand, Lock missed 2 1-2 games with a rotator cuff injury to his throwing shoulder and another for COVID-19 tracing in 2020.

Bridgewater has a 26-23 career record as a starter over his six seasons in Minnesota, New Orleans and Carolina.

The Broncos have struggled for years to find a suitable replacement for Peyton Manning, who retired a month after Denver's 24-10 win over Carolina in Super Bowl 50 and is headed to the Pro Football Hall of Fame

Manning's induction in Canton, Ohio, further highlights the franchise's serpentine search for a competent successor.

The Broncos are the first team in NFL history to go five years without a playoff appearance following a championship parade, and they've had four consecutive losing seasons for the first time since ending a decade-long stretch of sub-.500 records in 1973.

Among the washouts were first-round bust Paxton Lynch, the worst pick in former GM John Elway's tenure, trade dud Joe Flacco, and free agent flop Case Keenum.

It was widely believed Bridgewater wouldn't become available until after the draft and maybe wouldn't join a new team until June. But, according to the NFL Network, the Panthers agreed to pay a portion of Bridgewater's salary in 2021.

Bridgewater's three-year, \$63 million contract signed last year calls for him to make \$10 million guaranteed and up to \$7 million more in 2021.

The Panthers have the eighth overall pick in the draft and with Darnold in the fold can target other areas of need including offensive tackle, linebacker, tight end or cornerback.

"It is hard to interview someone who just got selected if they're not there because this thing continues to move and the narrative shifts. If they're not readily available to go, you probably won't see a lot of those interviews," Yook said.

NFL Network will have reporters at 11 team complexes, but ESPN will continue to have its reporters operate remotely.

Seth Markman, ESPN's VP of Production, said the decision was mainly for health and safety concerns.

"I think we could have done that, but it's something that we just looked at that wasn't a must do for this year," he said.

"We feel like our reporters are good enough at this point to be able to report on multiple teams from home. I know people like to be face to face, but that's not really going to happen these days. So I think sending a reporter to a team facility would be more about style over substance anyway."

Yook said it was important for NFL Network to have reporters there while observing all health and safety protocols.

NFL Network will debut new graphics along with having a higher level of highlighting players along with one-on-one matchups.

#### **SPOTLIGHT ON CLEVELAND**

The night of the first round for many years was a rare chance Browns fans got to be in the spotlight, but after an 11-5 season and a playoff win for the first time since 1994, NFL Network host Rich Eisen is eager to see

how Cleveland will respond to this year's festivities.

"I don't recall ever being to an NFL draft where the Browns being put on the clock was met with anything but sarcastic derision by anyone in the stands," he said. "I expect there to be a huge moment when they're on the clock and when the Steelers, Ravens and Bengals are on the clock.

"When we go to cities for the draft, it is different vibes because they have different regional interests. I love it. I absolutely love it."

#### **RUN RICH RUN**

Eisen's annual "Run Rich Run" fundraiser to support St. Jude Children's Research Hospital will air on Saturday.

Eisen usually does his 40-yard dash in Indianapolis during the NFL combine, but the event wasn't held this year.

Instead, Eisen did his run at SoFi Stadium in Los Angeles on April 17. It will also feature Jerry Rice, Ray Lewis, Cris Carter, Rod Woodson, Terrell Davis, Michael Vick, Torry Holt and Eric Metcalf.

With the Draft-A-Thon continuing for the second straight year, Eisen would like to see raising funds for charities made a permanent

#### part of the draft. **GREENBERG'S DEBUT**

Mike Greenberg becomes only the fifth host in ESPN's 42 years of doing the draft. He will host the first two days on ESPN with Rece Davis

handling the final day. Greenberg said discussions started in January after he mentioned to ESPN president Jimmy Pitaro a couple of years ago that he would like to be a part of more live sports coverage.

Despite the ebbs and flows of the draft, Greenberg thinks he is ready for the assignment. He also doesn't see it as long days on set after being accustomed to 4 to 5 hours of doing live television and radio a day.

"I know that this is a totally different animal, and a lot of things will be coming at me fast and furious. But at the end of the day, we're there to present these incredibly important events that fans are interested in," he said.
