Emergency hay and water made available for farmers

Due to worsening drought conditions throughout the state, emergency hay and water have been made available for family farms at Missouri state parks and Missouri Department of Conservation areas.

On May 31, Gov. Mike Parson issued Executive Order 23-05, declaring a drought alert for 60 Missouri counties, including Pettis and Johnson counties. With continuing hot, dry weather expected this summer, Parson's office stated that other counties will be added to the alert and be eligible for assistance as they reach established drought thresholds.

"As drought conditions continue to deteriorate across Missouri, we want to do all we can to help our family farms mitigate the devastating effects of severe drought," Parson said in a news release this week. "With the current water deficit, we know it will take a lot of rain for our state and its agricultural community to recover from the drought. While our prayers for rain continue, state government will do its part to assist wherever and whenever it can."

According to the Missouri Department of Natural Resources, more than 90% of Missouri counties are experiencing drought conditions. A drought map on the DNR website shows the majority of Pettis County is experiencing extreme drought, with a

small portion designated as severe drought. Central Missouri is being hit the hardest by drought.

According to information from Parson's office issued this week, boat ramps at 25 Missouri state parks will be open for farmers to collect water. Boat ramps at 36 Missouri Department of Conservation areas are also now open for water collection.

Water may be accessed from state park and MDC boat launches/ water access points during normal operational hours. Contacting MDC area managers prior to collecting water from conservation areas is required. Water is available for livestock needs only and not for resale. Farmers will need to provide their own pumping and hauling equipment.

Area drought pumping locations include Hazel Hill Lake in Johnson County, Haysler A. Poague Conservation Area in Henry County, Malta Bend Community Lake in Saline County, and Manito Lake Conservation Area in Moniteau County. A map displaying locations to pump water from state boat ramps is available at mostateparks. com/drought.

Warsaw musician Cody Dunning has recently released an album, "Wear Your Heart Out," featuring 10 original, smooth, soulful Americana-style songs.

Dunning, a U.S. Army veteran, performed at the Open Mic event at the Benton County Arts Fest in Warsaw in June. He sings from the heart with songs from his experiences of being deployed twice to Iraq and life in general.

Dunning said he became interested in playing in high school but not seriously.

"I think I started to play more when I was deployed when I was in the Army," he noted with a laugh. "I started to attempt to write songs at that point — but they were horrible."

Unionized UPS workers could strike this summer

NEW YORK — Unionized UPS workers voted overwhelmingly on Friday to authorize a strike, setting the stage for a potential work stoppage if the package delivery company and Teamsters can't come to an agreement before their contract expires next month.

The Teamsters said 97% of unionized workers voted for the authorization, which the union urged for in order to have more leverage during negotiations with the company. But a yes vote does not mean a strike is imminent.

"If this multibillion-dollar corporation fails to deliver on the contract that our hardworking members deserve, UPS will be striking itself," Teamsters General President Sean O'Brien said in a prepared statement. "The strongest leverage our members have is their labor and they are prepared to withhold it to ensure UPS acts accordingly."

The Teamsters represent about 340,000 UPS employees, more than half of the company's workforce in the largest private-sector contract in North America. If a strike occurs, it would be the first since a 15day walkout by 185,000 workers crippled the company a quarter century ago.

UPS has grown vastly since then and become even more engrained in the U.S. economy. The company says it delivers the equivalent of about 6% of nation's gross domestic product. That means a strike would carry with it potentially far-reaching implications for the economy.

UPS said in a prepared statement the strike vote does not impact the company's current business operations.

"Authorization votes and approvals are normal steps in labor union negotiations," the company said. "We continue to make progress on key issues and remain confident that we will reach an agreement that provides wins for our employees, the Teamsters, our company and our customers."

UPS workers are still seething about the current contract, which they feel was forced on them by prior union leadership in 2018 based on a technicality. The contract created two hierarchies of workers with different pay scales, hours and benefits. The union wants it eliminated.

In addition to addressing part-time pay and what workers say is



excessive overtime, the union wants improvements to driver safety, particularly the lack of air conditioning in delivery trucks, which has been blamed for the death of a driver and hospitalizations of others.

On Tuesday, the union and the company announced they reached a tentative agreement to equip more trucks with air conditioning equipment. Under the agreement, UPS said it would add air conditioning to U.S. small delivery vehicles purchased after January 1, 2024.

But those changes aren't extending to vehicles already in operation —

at least not yet. Instead, the union savs two fans would be installed in all vehicles when a new contract is ratified. It also said the company agreed to add heat shield to some vehicles, and put air vents in all cars within 18 months of a new contract. Under the agreement, UPS says roughly 95% of its existing U.S. package delivery fleet will be enhanced.

Teamsters spokesperson Kara Deniz said there have been two dozen tentative agreements reached with UPS since the negotiations began in April. The current contract expires on July

UPS delivers around

25 million packages a day, representing about a quarter of all U.S. parcel volume, according to the global shipping and logistics firm Pitney Bowes. That's about 10 million parcels more than it delivered each day in the years leading up to the pandemic.

UPS profits have soared since the pandemic began in 2020 as millions of Americans grew to rely on the delivery to their doorstops.


Annual profits at UPS in the past two years are close to three times what they were pre-pandemic. The Atlanta company returned about \$8.6 billion to shareholders in the form of dividends and

stock buybacks in 2022, and forecasts another \$8.4 billion for shareholders this year.

The Teamsters say that profit growth is largely due to the hard work of UPS drivers and warehouse workers who carry everything from 50-pound bags of dog food and cases of wine to prescriptions.

The acrimony over the current contract was the impetus for workers rejecting a candidate to lead the Teamsters favored by longtime union head James Hoffa. Union members instead chose O'Brien, who has dug in on the Teamsters' contract demands of UPS.



Recognizing all that dads do for their children

"Fatherhood is a vocation in God's service not to be held lightly or frivolously, but with the serious determination of serious men." – Fr. Lawrence Lovasik

There is so much literature on how to be a good mother. Too much. There's no corner of motherhood that hasn't been explored and argued over, from breastfeeding to letting go of your adult children. Everyone has advice for moms.

But what makes a good father?

There are no stacks of slick self-help books, no multimillion-dollar marketing efforts, no internet pileons about the minutia of a dad's parenting decisions. For the most part, a dad is considered "good" as long as he is present for the family at a minimum level and not abusive.

In fact, for the past 30 years, the media has seemed to glorify the stereotype of the dumb, incapable dad: Al Bundy, Peter Griffin, the fathers in the movie "Grown Ups." If you had a good father figure of your own, you could draw inspiration from him, but if you didn't, there's really nothing out there that can point you in the right direction. You guys are flying mostly blind.

This Father's Day weekend, I would like to tell you what I think you don't hear enough: Your fatherhood matters. It matters so much. You are more than a lump on the couch, or a paycheck, or a household drudge who mows the lawn and fixes the sink. You deserve better than the examples, or lack thereof, given in our media. You deserve better than Al Bundy and Peter Griffin. You deserve more than the soft bigotry of low expectations.

Your role should be honored and held to a high standard, just like a mom's, and the fact that it's not says a lot about how much we value manhood and fatherhood in the United States. (We don't.)

You are indispensable to the well-being of your children. Without you, their growth and development would never be the same. It's become controversial to say this, because we fear we will offend mothers who must parent alone, but it is still the truth. Kids need their dads, just as much as they need their moms.

Little girls need their fathers. They need good and upright men to model for them how a man should treat a woman.

They need a safe and loving male to hug them and tell them how beautiful they are, with no strings or expectations attached. Boys crave adult male approval. They need a safe and loving male from whom to receive this approval. They need a father to affirm them in their search for manliness, to love them unconditionally, and to be there for them whether they succeed or fail. They, too, need a good and upright man to model for them how a man should treat a woman. Dads, you are flying mostly blind, unappreciated, under-celebrated, and frequently forgotten. But I am here to tell you that the difference you make in your child's life is crucial. The vocation of fatherhood is more important than your hobbies, your household contributions, even your career. It's the second most important work you'll ever do, outranked only by your marriage. As Fr. Lovasik said, it is serious work for serious men.

Thank you to all good dads who do this hard and important work without much hope of worldly recognition and glory. Whether you see it or not, you are changing the world for the better, one child at a time. Happy Father's Day.

I've written infrequently about my father - our strained relationship, his excellence as a teacher and coach, his tolerance of my mother's love of stray dogs - and I suppose that's because during his lifetime, I couldn't quite reconcile our lack of "closeness" when I was growing up. I've been more successful at that since his death, but I wonder whether my youthful impatience was an impediment to our having more collegial interactions during my

childhood. I'm not sure what I expected. Back then, the mother was responsible for most, if not all, child rearing - and our mother was. Not only did she teach, but she also tutored during summers, cleaned the house, cooked every day, and mowed the lawn, all while taking care of us and making sure we didn't get into trouble. My dad did "dad" things - watched sports on television, hung out at the drugstore drinking coffee with other dads, coached basketball and football, and in summers, filled in as manager at Thayer's dress factory.

What I understand now is that he was an extroverted introvert. He loved

hanging out with people, talking, laughing, drinking coffee with his buds, but after he exerted all that energy, he regrouped by being alone. And I know that Libby and I were anathema to that. We were active – always outside, riding bikes, playing with our neighborhood friends, or playing baseball or kick-the-can in the big empty lot next to the Hoods' house.

I often was at Susan's playing with Barbie dolls, hiking to the Grand Gulf (seven miles away - I'm not sure whose idea that was), or playing circus horseback rider on a pregnant mare that somehow got from Becky Ellison's house to Susan's backyard. It gave birth the next day, unsurprisingly. We also spent almost every day in the summer from 2 until 4 at the Tally-Ho Motel pool,

swimming, jumping off the diving board, and splashing with our friends.

Understandably, those things didn't interest Daddy. But as we grew older, I would have liked for him to have attended the games when we were cheerleaders (by that time, he no longer coached, and said he couldn't take the stress of watching the games) or our band and choir concerts. I think once he got home after school, he didn't want to go back. I understand this pretty well now, because after I've worked all day reading others' words, or writing my own, I have little desire to do something I love - read books.

Even though I can now rationalize all this in my mind, my heart still longs for a different story – where my father takes us to Dairy Queen, goes with us to the pool to pull us around before we learn to swim, plays canasta or gin with us, or tells us after our concerts that we did a great job.

I think I'm really longing for a past where my dad had the relationship with me that Max has with Emily.

She's home for the Gillespie Girls weekend, and her first activity was playing golf with her dad. They talk on the phone every day (she talks to me, too, but she has plenty to say to her father). She introduces him to her friends, who call him "Daddy." He encourages her art, and she's terribly disappointed if he isn't totally wowed by her latest creation.

Of course, this began at her birth: He changed her diapers as often as I did, protested when someone said he was "babysitting" instead of taking care of his child, sat with her when she was ill, and attempted to teach her how to drive a stick shift (that was not good - I ended up doing that job), and generally did all the things a parent does though most people think of those things as being done by a mom.

He acknowledges today that I was the one most responsible for child care, but in an era when men's and women's roles are not as clear cut as they were in an earlier generation, he is a very involved father.

On this Father's Day, I remember my dad with longing, and I am grateful for the one my daughter has.

Hawley, Schmitt playing with fire in reckless comments about indictment

Trained attorneys Josh Hawley and Eric Schmitt either need some law school refresher courses, or they are deliberately misrepresenting the federal indictment of former **President Donald Trump** in ways so irresponsible they might qualify as incitement should violence follow. Missouri's two sitting senators — who both know better — are telling their constituents the indictment is the personal doing of President Biden, instead of the result of a legitimate legal process that is by definition separate from the White House.

No, Biden hasn't "indicted his top political opponent," as Schmitt tweeted. A federal grand jury did that, at the behest of a special counsel who operates independently from the Justice Department, which operates independently from Biden. Ditto regarding Hawley's claim that Biden believes he "can just jail his political opponents."

Hawley and Schmitt aren't alone. Prominent

Republicans around the country are spinning misleading accounts of what's going on. With the echoes of Jan. 6, 2021, not that far in the past, it's plain reckless.

"It is unconscionable for a President to indict the leading candidate opposing him," House Speaker Kevin McCarthy wrote in an especially unconscionable tweet. Again, a president can't "indict" anyone. And is the suggestion here that, by virtue of his candidacy, Trump can't be criminally charged for alleged violation of federal law, as would any other American? It sure sounds like it.

To be clear: These allegations aren't just a matter of mistakenly bringing some sensitive documents home from the office and forgetting about them, as Biden and former Vice President Mike Pence both were found to have done. That's not the best look for national leaders, but in both cases, they immediately cooperated with federal efforts to recoup the documents.

Contrast that with what Trump is accused

of doing. The indictment alleges he didn't merely abscond with the hundreds of documents in question, but that he went to extraordinary lengths to prevent the government from getting them back, including activities that sound like textbook definitions of criminal conspiracy and obstruction of justice.

The indictment alleges Trump took classified documents related to U.S. defense strategies and nuclear programs including documents that could have put U.S. intelligence agents at personal risk — and stored them in unsecured locations like bathrooms and ballrooms at his Mar-a-Lago resort. He's also accused of improperly sharing sensitive information with people with no security clearance, including visitors to his resort properties.

It might be tempting to dismiss even all of that as the blustery self-indulgence of a clinical narcissist trying to impress people. America has long

known who Trump is.
Where it veers into
areas that might reasonably be expected to land

someone in a federal prison cell were his alleged efforts to resist returning the documents, even after they were subpoenaed, and his alleged obstruction of justice as the investigation unfolded. Among other actions, he allegedly pressed his lawyers and others to hide or destroy documents and to lie to investigators about it. If true, that's not just Trumpian braggadocio, it's felonious.

Federally indicting a former president for the first time in history isn't something to be done lightly. If special counsel Jack Smith ultimately presents a case that looks like legalistic nitpicking instead of substantive criminality, the Hawleys and Schmitts of the world may be politically rewarded for their knee-jerk sycophancy to Trump.

But they're making a dangerous bet. As Smith said last Friday: "We have one set of laws in this country, and they apply to everyone." Most Americans understand that, even if Missouri's two sitting senators don't.

He said he was reluctant to write country songs because, at the time, he thought it was possibly "uncool."

"But I've always loved all different kinds of music," Dunning said. "So, this last album, 'Wear Your Heart Out, it's pretty eclectic."

"It's kind of loosely about one of my friends from the Army that I was in Iraq with," he explained. "It's a little bit about life's struggles. We both have PTSD, so it deals with some of that stuff. It's one of the better songs on the album."

Dunning added John Calvin Abney, an American musician, songwriter and multi-instrumentalist from Tulsa, Oklahoma, played on the recording of "Jimmy."

"He plays with a guy, John Moreland," Dunning said. "John Calvin Abney is a sessions musician, but he's Moreland's right-hand man. He does a lot of the guitar parts, piano."

Dunning sent a message on Instagram to Abney and asked if he'd play on his album.

Almost 700 acres are available for having at 17 Missouri state parks. Area haying locations include Arrow Rock State Historic Site in Arrow Rock and Harry S. Truman State Park in Warsaw. Anyone interested in obtaining hay from these locations can contact the park superintendent to view the designated area. The first person who views the area and wants the hay will be issued a license to cut the hay at no cost.

Guidelines and boundaries for cutting the hay on state park property will be provided at that time. Signing a license is required before having can begin. Missouri State Parks will allow having on or after June 25, and hay must be removed before Sept. 25. Visit mostateparks.com/ drought for more information about this opportunity.

In addition to the contracts already in place at many MDC areas across the state, other opportunities to cut hay on conservation areas may be available to assist farmers in need of hay to harvest. Anyone desiring to inquire about cutting hay on conservation areas should contact their local MDC regional office.

The Missouri Department of Transportation is assisting by offering special hay hauling permits, which can be requested through the MoDOT Carrier Express online service at www.modot.org/mce. MoDOT permits cover movement within Missouri only and are required for each truck. Questions may be directed to MoDOT's Motor Carrier Services office at 1-800-877-8499.

The MDC is also warning of the increased risk for wildfires that drought conditions can cause.

After a high chance of precipitation on Saturday, June 17 and Sunday, June 18 in Pettis County, weather conditions are expected to be dry next week with high temperatures reaching the low 90s.

As reports and photographs are essential tools used to assess drought conditions, the DNR encourages the public to submit information and photographs about conditions in their area.



Chiefs get Super Bowl rings, take subtle shot at rival Bengals

KANSAS CITY, Mo. — Chiefs quarterback Patrick Mahomes had a stinging answer for Bengals wide receiver Ja'Marr Chase, who upon learning that his own QB Joe Burrow had picked Mahomes as the league's best replied: "Pat who?"

"That's who," Mahomes posted on social media Thursday night, along with a photo of him flashing his new Super Bowl ring.

Or more accurately, that's two.

Mahomes picked up his first ring in 2020 by leading the Chiefs to a victory over the 49ers, then added a second in February when he led Kansas City to a comefrom-behind win over the Eagles. But unlike the first triumph, which came as the pandemic was beginning, the Chiefs were able to thoroughly enjoy the spoils of the latest with a ring ceremony Thursday night.

The red-carpet affair in Kansas City was closed to reporters, but Mahomes and others were happy to send out photographs. And in the case of the Chiefs' burgeoning rivals,

they were willing to take a couple of shots at Chase and the Bengals.


'That's what you work for, to win the Super Bowl and get those rings," Mahomes said. "They last a lifetime. To be able to see them, I know they've done a great job with them. I got to help out a little bit with the creating process. They did a great job."

The rings were made by Jostens and each contains 613 diamonds along with 35 rubies for a total of 16.1 carats.


And like most Super Bowl rings these days, there were plenty of hidden meanings in the

Front and center are the organization's three Lombardi Trophies, each with a marquise diamond set atop. The trophies are set against a backdrop of 19 rubies and 38 diamonds, which reflects both the 38 points the Chiefs scored in the Super Bowl and the 57th edition of the game. In the middle of it all is the Chiefs' logo, which itself is comprised of 16 rubies — the number of division titles for the franchise and 50 diamonds to reflect the 50th anniversary of

Northwest, Sacred Heart players among All-State baseballers

Lincoln, Northwest and Sacred Heart all had firstteam All-State baseballers recognized as part of the squads that were recently released by the Missouri High School Baseball Coaches Association.

The Gremlins led the way with four players picked to the Class 1 team. Junior Carter Rice was a first-team selection at catcher. He was joined by Conner Rice, a second-team infielder, Tanner Damlo, an Honorable Mention infielder, and Gavin Caldwell, an Honorable Mention at DH/Utility.

Carter Rice, along with a .988 fielding percentage, batted .402 with 35 RBIs and had a 2.95 ERA in 19 innings thrown. Conner, meanwhile, had a 3.50

ERA in 46 IP, and at the plate hit .379 with two home runs, 34 RBIs and 19 steals. Damlo, a senior, batted .391 with three homers, 19 RBIs and 15 SBs to go with a 2.74 ERA in 15 1/3 innings, while Caldwell, a junior, swung at a .337 clip, had two homers and 30 RBIs, and had a 4.15 ERA with 97 Ks

in 62 1/3 IP. Northwest had three players represented at Class 1 in senior Gavin Killion, a second-team pitcher, senior Grant Burson, an Honorable Mention pitcher, and senior Isaac Nieters, a first-team infielder.

Nieters led the Mustangs in average at a blistering .523, hitting four HRs with 43 RBIs, and had a 3.67 ERA in 26 2/3 IP. Killion sported an impressive ERA of 0.91, a

WHIP of 0.89 and struck out 97 hitters in 54 IP, and at the plate batted .370 with three HRs and 23 RBIs. Burson hit .333 with 14 RBIs and on the mound had a similarly low 1.21 ERA and a 0.84 WHIP with 87 Ks in 46 1/3 IP.

In Class 2, Lincoln senior Connor Lynde was a first-team selection at the DH/Utility spot. Lynde batted .385 with three triples and home runs each, striking out just five times while stealing 38 bases. In 61 1/3 IP, he enjoyed an ERA of 1.70 with 112 Ks and a BAA of just .132.

Making the second team in Class 2 from Tipton were juniors Lucas Cashman (pitcher) and Tyler Baer (catcher). Cashman batted .323 with three homers and 16 steals, and on the bump had a 2.07 ERA, a 0.93 WHIP and 67

Ks in 181 innings thrown. Baer, who stole 23 bags, had a .429 average with four home runs and 32 RBIs, leading the Cards in all four categories.

Rounding out Class 2, junior Avyn Burkhart of Windsor was an Honorable Mention at DH/Utility. He batted .352 with 23 RBIs and 27 stolen bases. Additionally, he sported a 2.95 ERA with 47 strikeouts over 42 2/3 IP for the Greyhounds.

In Class 3, Cole Camp junior Reid Harrison and senior Chase Von Holten were both Honorable Mentions as outfielders. Harrison had a .383 average, a .463 on base percentage with 28 stolen bases, as well as three triples and 36 runs scored. Von Holten had a .380 BA with eight doubles and 25

NBA suspends Ja Morant 25 games for second video involving gun

Memphis guard Ja Morant has been suspended 25 games by the NBA — his second ban in four months — and Commissioner Adam Silver made clear Friday the star must stop his "alarming" habit of flashing guns on social media.

The suspension for the upcoming season comes a month after a second video of Morant flashing a handgun was streamed online. The video of Morant showing a gun while sitting in the passenger seat of a car was posted after his eight-game suspension in March for a video in which he flashed a handgun in a Denver-area strip club.

Morant is due to make around \$33.5 million this season. He now stands to lose just over \$300,000 per game — or approximately \$7.5 million. He also will have to adhere to certain conditions before being reinstated, the NBA said.

Silver made clear the two-time All-Star's decision-making is "discon-

certing."

"The potential for other young people to emulate Ja's conduct is particularly concerning," Silver said. "Under these circumstances, we believe a suspension of 25 games is appropriate and makes clear that engaging in reckless and irresponsible behavior with guns will not be tolerated."

The league said Morant "will be ineligible to participate in any public league or team activities, including preseason games" during his suspen-

The Grizzlies suspended Morant indefinitely from team activities after the second video surfaced, and they said Friday they respect the punishment for this "latest episode."

"Our standards as a league and team are clear, and we expect that all team personnel will adhere to them," the Grizzlies said.

Michael Jordan selling majority ownership stake in Hornets

CHARLOTTE, N.C. — Michael Jordan is finalizing a deal to sell the majority share of the Charlotte Hornets, the franchise announced Friday, leaving the 30-team NBA without any

Black majority ownership. Jordan is selling to a group led by Gabe Plotkin and Rick Schnall, the Hornets said. Plotkin has been a minority stakeholder in the Hornets since 2019. Schnall has been a minority owner of the Atlanta Hawks since 2015 and is in the process of selling his investment in that team.

It's not clear how long the process of selling will take to be finalized by the NBA's Board of Governors. Jordan plans to keep a minority stake in the Hornets, the team he bought in 2010 for about \$275 million.

Jordan's decision to sell ends his unsuccessful 13-year run overseeing the organization.

"In the same way that it's wonderful that one of our

greatest, Michael Jordan, could become the principal governor of a team, he has the absolute right to sell at the same time," NBA Commissioner Adam Silver said earlier this month at the NBA Finals. "Values have gone up a lot since he bought that team, so that is his decision."

In that same news conference at the finals, Silver said the Board of Governors are focused on diversity in ownership groups.

"I would love to have better representation in terms of principal governors," Silver said. "It's a marketplace. It's something that if we were expanding that the league would be in a position to focus directly on that, but in individual team transactions, the market takes us where we are."

Elsewhere, the 16 baguette diamonds at the base represent the 16 players that scored a touchdown in the regular season; 54 diamonds across the top represent the total number of points the Chiefs had to overcome in their two most recent title runs; and each player's name is engraved in gold along

with a row of 13 diamonds.
The ring also features a removable top so the thing can turn into a pendant

that looks like Arrowhead Stadium.

"They're pretty cool," Mahomes said. "They did a great job. I hadn't gotten to see the final product, but I got to see kind of the process of it and gave some ideas and stuff like that. They did a great job. Like I said, with whatever they look like, you get to have them forever and they mean the world. It's cool to be able to have two of them now."

That's two more than the Bengals have these days.

Much like their recent trip to the White House, the Chiefs invited anybody



Morant apologized again Friday to the league, the Grizzlies, his teammates and the city of Memphis in a statement issued through his representatives. He specifically told Silver, Grizzlies owner Robert Pera and Memphis general manager Zach Kleiman he is sorry.

The guard with his own signature Nike shoe also apologized to children who look up to him for failing them as a role model. Morant made clear he's had time to reflect and understands the hurt he might have caused.

"I promise I'm going to be better. To all of my sponsors, I'm going to be a better representation of our brands. And to all of my fans, I'm going to make it up to you, I promise," Morant said.

Morant said he'll keep working on both his mental health and decision-making.

On May 24, police

conducted a welfare check on Morant and said he was "fine" after cryptic messages appeared on the guard's Instagram account only to be deleted. A police spokesman said Morant told officers he was "taking a break from social media."

"I hope you'll give me the chance to prove to you over time I'm a better man than what I've been showing you," Morant said Friday.

NBPA executive director Tamika Tremaglio said the players association thinks the NBA went too far punishing Morant, calling it "excessive and inappropriate" and inconsistent with the league's past discipline.

"We will explore with Ja all options and next steps," Tremaglio said in a statement.

Nike also is sticking with Morant, whose Ja 1 shoe line debuted earlier this year.

"We are pleased that Ja is taking accountability and prioritizing his well-being," Nike said.

Silver's stance is clear: Morant's actions, even without being charged with a crime, have severe consequences, particularly with gun violence a massive problem and the guard one of the league's most popular players.

"Waving them around ... is not consistent with gun safety and is not the proper message that an NBA player, particularly one at Ja's level, should be sending to the tens of millions of followers he has — and particularly when it's an incident once again, where it's been streamed live on social media," Silver said earlier this month at the NBA Finals.

The suspension almost certainly means that Morant will not be eligible for any end-of-season awards in 2024, such as MVP and All-NBA. Under the new Collective Bargaining Agreement that goes into effect July 1, a player must appear in 65 games (with limited exceptions) to be eligible.

It's also reasonable to think Morant will miss the league's inaugural in-season tournament expected to start this fall and end sometime in December.
The league has yet to announce if the tournament is definitely happening, nor has it released the schedule.

Silver said basketball needs to take a back seat for Morant before he can return to the NBA. Morant will have to finish a program with the league addressing the issues Silver said "led him to repeat this destructive behavior."

Morant's eight-game suspension cost him about \$669,000 in forfeited salary after the first video surfaced on March 4 on his own Instagram account.

The second video captured May 13 was widely shared online after being streamed by a Morant associate. That was the same friend Morant said in February had been banned from the Grizzlies' home arena for a year over a confrontation with members of the Indiana Pacers organization a week earlier.

The sale price was not immediately announced; ESPN, citing sources, said the franchise was being valued at \$3 billion. The most recent sale of an NBA team came when Mat Ishbia bought the Phoenix Suns, a deal that when struck in December valued that franchise at \$4 billion.

Jordan declined comment on the sale through his spokesperson, Estee Portnoy.

For as great as Jordan was on the court — national champion at North Carolina, two-time Olympic gold medalist, six-time NBA champion and in the never-ending conversation for best player ever — the Hornets never reached a championship level during his time as the owner.

Charlotte went 423-600 in his 13 seasons in charge, the 26th-best record over that span. It never won a playoff series in that time

and hasn't even been to the postseason in the last seven seasons.

Other members of the new potential Hornets ownership group — pending the approval — are recording artist J. Cole, Dan Sundheim, Ian Loring, country music singer-songwriter Eric Church, Chris Shumway and several local Charlotte investors, including Amy Levine Dawson and Damian Mills.

Along with the Hornets, HSE ownership includes the NBA G League's Greensboro Swarm and NBA 2K League's Hornets Venom GT, as well as managing and operating the Spectrum Center, each of which is included as part of the sale.

When Jordan, who grew up in Wilmington, North Carolina, purchased majority ownership in the team, it created a great amount of buzz.

But the Hornets' struggles and inability to turn things around bothered Jordan. The first inclination that he was looking to get out of the NBA ownership business came in 2020, when he sold a minority stake to Plotkin and Sundheim.

The Hornets are coming off an injury-plagued 27-55 season and hold the No. 2 pick in the NBA draft. Victor Wembanyana is expected to go first overall on Thursday night, leaving Charlotte with the choice of either G League star guard Scoot Henderson or Alabama's Brandon Miller.

Charlotte's biggest star is LaMelo Ball, and the team still has some decent foundational parts to build around including Terry Rozier, Gordon Hayward, P.J. Washington and Mark Williams, the team's starting center who played well last year as a rookie.

Jordan was often criticized as an owner for not spending enough in free agency to make the Hornets competitive.

He took over a team in 2010 that had won 44 games the year before but had been swept by the Orlando Magic in the first round.

It went downhill from there.

Charlotte — still the Bobcats at the time — was 34-48 in its first year under Jordan and then an NBA-worst 7-59 the following year. But despite the abysmal record, Charlotte failed to land the No. 1 pick in the NBA draft lottery and Anthony Davis.

Charlotte got back to the playoffs in 2013-14 but was swept by the Miami Heat. Two years later, the Hornets won 48 games but lost again to the Heat in the first round, this time in seven games.

In the seven years since, Jordan's Hornets have had only one winning season and have twice exited early in the play-in tournament as the 10 seed.

Charlotte has not won a playoff series since the 2001-02 season and has never won an NBA championship.

Berhalter back as US coach after feud, investigation

NEW YORK — Gregg Berhalter was rehired as U.S. men's national team coach through the 2026 World Cup, returning to the job after he led the Americans to the second round of last year's tournament and then was dropped amid a feud with a famous soccer family and a domestic-violence

investigation. The U.S. Soccer Federation announced Friday Berhalter had been hired through the 2026 tournament that it will co-host. The USSF planned a news conference for later in the day in Las Vegas, where interim coach B.J, Callaghan led the team to Thursday night's 3-0 win over Mexico in the CON-CACAF Nations League.

"When I started this search, my focus was on finding someone with the right vision to take this program to new heights in 2026," new USSF sporting director Matt Crocker said in a statement. "Gregg has that vision, as well as the experience and growth mindset on and off the field to move this team forward."

Callaghan will remain as interim coach for Sunday's Nations League final against Canada and for the CONCACAF Gold Cup from June 24 to July 16. Berhalter will return after that for a schedule that includes October exhibitions against Germany and Ghana.

Crocker said he planned to "work collectively with Gregg on some of the big-picture items away from the team."

Berhalter, 49, was hired in December 2018 after the failure to qualify for that year's tournament in Russia and coached the Americans at last year's World Cup in Qatar, where they were eliminated with a 3-1 loss to the Netherlands. The U.S. gets an automatic berth in the 2026 World Cup as co-host with Mexico and Canada.

He led the Americans to 37 wins, 11 losses and 12 draws and was discussing a new contract with USSF sporting director Earnie Stewart when the family of Gio Reyna, upset with his lack of playing time in Qatar, contacted the USSF about the allegation involving Berhalter in a 1992 incident with the woman who became his wife.

Gio Reyna's parents former U.S. captain Claudio Reyna and midfielder Danielle Egan — were

angered that Berhalter discussed his issues with Gio at a management conference after the World Cup that, while not identifying Gio, clearly were about the 20-year-old midfielder.

The USSF retained the Alston and Bird legal team to investigate, and the law firm said in a report released March 13 that

while Berhalter's conduct "likely constituted the misdemeanor crime of assault on a female," Berhalter did not improperly withhold information when he was hired.

"There is no basis to conclude that employing Mr. Berhalter would create legal risks for an organization," the report said.

Berhalter said there were "zero excuses for my actions that night" and said the behavior was never repeated.

Stewart announced Jan. 26 that he was quitting and was replaced in late April by Crocker, the Southampton director of football operations, who was tasked with leading the search.

Crocker said planned to make a decision by late summer.

Anthony Hudson, one of Berhalter's assistants, became interim coach on Jan. 4 and coached the Americans to two wins, one loss and two draws, then quit on May 30 to become coach of the Qatari club Al Markhiya.

Column: Morant suspension sends mixed message in country that worships guns

This is not a defense of Ja Morant, whose erratic behavior certainly seems worthy of a lengthy suspension.

Then again, in a country that worships its firearms and shrugs off repeated mass killings as nothing more than the cost of living in America, we shouldn't be the least bit surprised when a brash young athlete chooses to flash a hand gun on social media.

Talk about mixed messages.

Morant will have to sit out at least the first 25 games of the next NBA season for briefly displaying a pistol in a video shared on social media.

Meanwhile, politicians who serve in some of the highest offices in the land have brazenly posed with their assault weapons in front of Christmas trees — while flanked by their weapon-toting children.

It's worth noting that Morant plays for the Memphis Grizzlies, who reside in the state of Tennessee, which allows

its residents to carry firearms openly in public without so much as requiring a permit.

In other words, Morant broke no laws. The police aren't even bothering to investigate his actions.

But the NBA, understandably, is concerned about the optics of one of its brightest young stars dallying with guns in his down time. The league has firm rules against players — even those with a permit — carrying a firearm at arenas or practice facilities or on team planes.

Morant didn't break any of those rules, but he's been roundly condemned for his reckless behavior.

"I hope you'll give me the chance to prove to you over time I'm a better man than what I've been showing you," Morant said in a statement issued through his representatives, which seemed more focused on keeping his sponsors from dumping him than any real repen-

His career is clearly at a crossroads.

Morant already served

an eight-game suspension for a similar incident in March, when a video showed him flashing a gun in a strip club.

Then, showing he had learned nothing from that lack of judgment despite a PR-crafted apology, Morant did it again last month while sitting in the passenger seat of a car.

That prompted NBA Commissioner Adam Silver to bring down the hammer on Morant, issuing a 25-game suspension Friday that includes additional conditions for his reinstatement.

Silver is understandably worried that Morant — one of the league's most popular and exciting players — could influence other young people to go down a similar path, with potentially deadly consequences.

"Ja Morant's decision to once again wield a firearm on social media is alarming and disconcerting given his similar conduct in March," Silver said in a statement. "The potential for other young people to emulate Ja's conduct is particularly

concerning.

"Under these circumstances, we believe a suspension of 25 games is appropriate and makes clear that engaging in reckless and irresponsible behavior with guns will not be tolerated."

The NBA's position, while admirable, is hardly in line with how much of America views weaponry in all shapes, sizes and killing power.

Many states, citing the Second Amendment, have scurried to make it easier to purchase and carry guns than it is to get a fishing license. This country is awash in a staggering array of firearms, including assault rifles that are primarily designed to kill large groups of people quickly and efficiently.

Hardly a day goes by that the U.S. is not rocked by another mass shooting.

Already this year, according to a database maintained by The Associated Press and USA Today in a partnership with Northeastern University, 131 people have been victims of such a killing, which is defined as an incident that claims at least four lives not including the shooter. And that's just a fraction of the people who die in gun-related homicides and suicides.

Despite the carnage, there seems to be little political will for meaningful gun-control measures. In fact, there are plenty of people far more shameless than Morant about showing off their firepower.

When Kid Rock joined the culture-war backlash against Bud Light for teaming up on a sponsorship with transgender influencer and activist Dylan Mulvaney, the rapper videoed himself blasting away at cases of the popular beer with a rapid-fire rifle.

There has been no defense of Morant from

gun-rights advocates. We reached out Friday to the National Rifle Association with both a phone call and an email, but did not receive a reply.

If sticking to their usual position, the NRA and other gun groups should be outraged that someone is being punished so severely by their employer simply for showing off their pistol on social media. Then again, Morant

That other association decided to act firmly and decisively — even if it meant sending convoluted signals.

"For Ja, basketball needs to take a back seat at this time," Silver said. "Prior to his return to play, he will be required to formulate and fulfill a program with the league that directly addresses the circumstances that led him to repeat this destructive behavior."

If only America felt as strongly about this issue as the NBA.

Osage Trails day camp wraps up fun week in Sedalia

ednesday through Saturday evening, members of the Sedalia and Marshall Cub Scouts gathered at Missouri State Fairgrounds for activities and camaraderie.

"Osage Trails Day Camp is designed for those who don't go to Hawn or Lake of the Ozarks (camps)," Osage Trails Day Camp Director Brian Geary said. "It's a cheaper camp, it's four days, they can come here, and they can do pretty much the same activities. Tonight, they're going to be doing name tags, BB guns, model airplanes and they're going to be making race cars out of Twinkies."

Dozens of scouts with bright yellow 2023 Great River Council Day Camp shirts assemble Wednesday through Saturday to get out of the house and into the outdoors.

"It's calm, better than home, even though I get to swim," Carlie Burton said. "It's nice to be with my friends."

Paisley Breshiers agreed that it could sometimes be a bit boring at home and liked coming to Sedalia for the day camp.

"I know a lot of these kids," Paisley said. "We're playing and having fun, archery, playing tag and stuff."

Members of the Sedalia Flyers RC Club had a table with helicopters, gliders, drones, remote-controlled planes, and model planes they used to teach the kids about model planes and aviation in general.

The kids got time to visit with Thomas Yang, who runs the mobile Invention Lab for the Great Rivers Council. He tours mid-Missouri in the trailer, encouraging kids to discover some of the automated machinery used in modern industries.

"This is the Invention Lab from the Great Rivers Council," Thomas Yang said. "This one is based out of Columbia and serves all 33 counties of mid-Missouri. It's part of our Invention Scouts initiative, which is focused on teaching scouts about inventing entrepreneurship. We have a laser-engraver machine right here, 3-D printers, occasionally we'll bring out a CNC router, a variety of science-tech kind of stuff."

Chad Breshiers, of Marshall, was patiently teaching archery to small groups of boys and girls, far away from the others on a designated archery range.

Some arrows fell short, some flew over the target and had to be found later, and some hit their mark with a resounding thud.

the camp in previous years and was looking forward to more practice with the bow and arrow.

Central Park birder turning viral video fame into memoir & TV show

NEW YORK — There's nothing that can keep Christian Cooper from enjoying his "happy place," the bird-friendly Ramble of Central Park — not even his tense, viral video encounter three years ago with a woman walking her dog off leash in his refuge.

Cooper is a lifelong birder, and Black, a relative rarity for the pastime. The dog owner is Amy Cooper, who is white and no relation. His video of her pleading with a 911 operator to "send the cops" because, she falsely claimed, an African American man was threatening her life has been viewed more than 45 million times on social media.

Much has happened to each Cooper since.

She was fired by an investment firm and a judge tossed her lawsuit challenging the dismissal. Later, a misdemeanor charge against her was dropped after she completed a program on racial bias.

He scored a memoir, out this week, and has his own series on Nat Geo Wild, traveling the U.S. doing what he loves most: birding. "Extraordinary Birder with Christian Cooper" premieres Saturday.

Something else happened the day the two Coopers clashed. Just hours later, George Floyd was killed under the knee of a white police officer more than 1,000 miles away in Minneapolis. They had no way of knowing that, of course, but Christian Cooper told The As-

sociated Press in a recent interview he had another Black man, Philando Castile, on his mind when he flipped his phone camera to record.

Castile was fatally shot in the Minneapolis area in 2016 by an officer who wrongly thought the 32-year-old was reaching for a gun during a traffic stop. Castile's girlfriend, Diamond Reynolds, had the presence of mind to hit record on her phone, and her livestream on Facebook touched off protests around the country. (The officer who shot Castile was acquitted by a jury.)

Christian Cooper's decision to record was personal but routine for birders trying to convince park officials to do something

about dogs off leashes where signs clearly prohibited it to protect plantings in The Ramble and leave the birds undisturbed. He was polite but firm as he spoke off-camera while Amy Cooper raged.

"I thought to myself, you know what? They're going to shoot us dead no matter what we do. And if that's the case, I'm going out with my dignity intact," he told the AP.

For a second, he added, "I was like, oh, yeah, when a white woman accuses a Black man, I know what that means. I know what trouble that can mean in my life. Maybe I should just stop recording and maybe this will all go away in a split second. Then I thought, nah, I'm not go-

ing to be complicit in my own dehumanization."

Amy Cooper never apologized directly to him, though she issued a statement of regret. And since then, Christian Cooper has done some soul-searching on what it must be like, at least sometimes, for women to feel unsafe in public outdoor spaces.

outdoor spaces.

"I would hate to think
that I would go through a
situation like that and not
learn something myself.
And so I try to keep in
mind now that, yes, I'm
perfectly comfortable in
The Ramble. It's my happy
place. But that's not necessarily true of everyone,"

he said.

Amy Cooper demanded he stop recording, upset when he offered her cocker

spaniel, Henry, a dog treat. It's a tactic controversial among birders frustrated by unleashed dogs in The Ramble. "It's a very in-your-face move. You know, no bones about that. I haven't done it since," he said.

He declined to cooperate with prosecutors in the criminal case against Amy Cooper. It was an election cycle, he said, so it felt performative. But also, he felt, she had been punished enough through public disgrace.

"I decided I kind of have to err on the side of mercy, particularly weighing with that a sense of proportionality because I had not been harmed. I had not been thrown to the ground by the police or, God forbid, worse. I had never even had to interact with the police. I'm sure my opinion would be different if I had," he said.

Now, Cooper is all about spreading the gospel of birding once again. His book, "Better Living through Birding: Notes from a Black Man in the Natural World," opens with the Central Park encounter, and then launches into his life:


How birding helped him connect to the world as a closeted gay child in his predominantly white Long Island hometown. How all things Star Trek, science fiction and Marvel Comics have sustained him to this day, at age 60.

"The cure to my outsider status was to go outside, outside of myself, outside of my own head, outside into nature. Because you can't go looking for birds without really focusing on what you're doing, and focusing on the natural world around you," he said.

"And when you do that, you can't be preoccupied anymore about, 'Oh my God, I feel so horrible."

As a longtime board member of the New York City Audubon Society, Cooper has seen the ranks of Black birders increase, and he has participated in a movement among National Audubon Society chapters to cast off the name of John James Audubon. The 19th-century artist and naturalist known for his paintings of North American bird species was an anti-abolitionist who owned, purchased and sold enslaved people.

Cooper's chapter of the society is in the process of coming up with a new name, though the parent organization declined to do the same.

If I can communicate some of my passion for birding, for birds, and get them to sort of open their awareness just a little bit more to these

'Avatar 3' pushed to 2025, Disney sets two 'Star Wars' films for 2026 December 2029; "Avatar 5" is set to arrive in December AP Film Writer

NEW YORK — "Avatar: The Way of Water" may have finally arrived in theaters in 2022, but that long parade of "Avatar" delays isn't done, yet.

The Walt Disney Co. on Tuesday pushed the release of "Avatar 3" a year, bumping it from December 2024 to December 2025. The timeline is stretched even further for the next planned installments. "Avatar 4" is now slated to hit theaters in

If those dates hold, the "Avatar" film series will have stretched across the first four decades of the century. Director James Cameron, who launched "Avatar" in 2009, has said he may not direct films 4 and 5. By December 2031, the 68-yearold Cameron would be 77. "Avatar" and "Avatar: The Way of Water" have collectively made more than \$5.2

billion at the box office. "Each 'Avatar' film is an

exciting but epic undertaking that takes time to bring to the quality level we as filmmakers strive for and audiences have come to expect," "Avatar" producer Jon Landau wrote on Twitter.

Disney on Tuesday shuffled plans for some of its biggest franchises. Two "Star Wars" film are planned for 2026. One was pushed from December 2025 to May 2026. Another was added for December 2026. The studio hasn't announced details on either untitled production.






